Congressional Issues

Rich noted that preparations are proceeding for Raj Shah's confirmation. He will start a round of Hill calls next Tuesday, and there will be a couple murder boards before his tentative hearing date on December 1.

• Today is in essence the drop dead date for getting nominations to the Hill in time for possible confirmation this year.

Jack will send another letter to Senator Lugar that should result in his lifting the hold on agricultural assistance to Afghanistan.

• The timing of the Afghanistan/Pakistan rollout and hearings remains in flux.

H is still waiting for the QFRs from Senator LeMieux with respect to Tom Shannon's nomination.

Afghanistan and Pakistan Bombings

I noted that we still do not know the nationality of the 11 KBR contractors wounded along with 6 U.S. military in a suicide attack near Camp Phoenix (near Kabul) today. One foreign national was killed in the attack.

Meanwhile, there were no reported U.S. casualties in the bombing of the ISI building in Peshawar, though the U.S. Consulate did sustain minor damage.
