Legislative Affairs

- Jack said his meeting with Senate and House Appropriations staff yesterday went well, but was fairly non-specific. (In contrast, he noted, to when he used to deal with the Republican majority during the Clinton Administration when the discussion of numbers was very specific.) The staff seemed receptive to the idea of increasing flexibility and reducing earmarks, but noted in turn the need for the Administration to be more flexible in its requests. In their view, everything should be on the table, not just the items Congress wants to earmark.
- Jack also reported that there are problems with the 2010 bill the staff believe it cannot be taken to the Senate floor as a standalone bill because it would be a magnet for amendments (on GTMO, Mexico City language, etc.). They are looking for an omnibus vehicle.
- Rich said H is working with EUR on a memo to S on Armenia spelling out our position on a new Armenian Genocide Resolution, how we should approach the Diaspora, and which prominent Armenian-Americans the Secretary should contact.
- Rich also noted that there would likely be two more food security briefings one each for House and Senate.
- Finally, we have received two additional requests for GTMO briefings from Berman and Hoyer.

- PJ noted that the Sudan rollout had gone well and press has been good. He said that Gration was doing some additional follow-up briefings today.
- Ellen Tauscher will do a briefing at 11:00 today on non-proliferation to set the stage for the Secretary's speech tomorrow.
- PA is moving forward with setting up a briefing on the civilian side of our efforts in Afghanistan.

Roman Polanski

• Harold noted that Polanski's appeal has been denied and he is now in jail in Switzerland. L anticipates an extradition request by Thanksgiving.

Deputies Meeting Highlights

Public Diplomacy and Pakistan

 Judith McHale raised a number of issues in the aftermath of a very successful global PAO conference last week. She noted, in particular, the appointment of Larry Schwartz as "uber PAO" in Pakistan to coordinate all of our public diplomacy efforts and oversee a \$100 million plus overall budget.

Not just in Pakistan, Judith noted, we face a demographic challenge when it comes to young people. Many are
not that familiar with the U.S. and are not necessarily that well disposed to the U.S. as had been the case with
previous generations.

European Affairs

• Phil Gordon expressed concern about the need to consult more closely with NATO allies before a final decision is made on Afghanistan/Pakistan strategy and troop levels. He noted that we don't want a replay of Missile Defense.

S/SRAP

 S/SRAP noted that Karzai has just agreed to accept the IEC results and agreed to a run-off election that would be held November 7. Senator Kerry has been very helpful in this process.

USUN

• Erica said that Ambassador Rice is in Israel today and that there is an unhelpful story in the Israeli press purporting to lay out U.S. strategy on the Goldstone report as told by a foreign mission in New York.

• Iran has asked for a Security Council Resolution condemning the bombing in S.E. Iran over the weekend. This should not be a problem.

Honduras

• Tom Shannon said that the talks made no progress yesterday. We have, however, revoked six more visas from prominent Micheletti supporters and need to see what impact that may have.

South Central Asia

• Bob Blake reported that a court in Kazakhstan had upheld the conviction of a prominent human rights activist on vehicular manslaughter charges despite "many irregularities" in the proceedings.
