Middle East Peace Report

• Cheryl noted that there had been discussion about when the Secretary would give her report on the Middle East peace process, but that this would not happen "mid-October," but rather likely later in the month.

Goldstone Report

 Jim said he has been working on a strategy for the Goldstone report. The problem is that without progress on the overriding set of issues, it is hard to head off a bad resolution.

Civilian Effort in Afghanistan

Jack raised the need to get our story out on the civilian side of our effort in Afghanistan, noting that some in the press have been alleging that we "are not getting out of Kabul." This is not true, but we need to be able to point to tangible progress in order to drive this point home.

Contracts in the FATA in Pakistan

•	Jack noted that the Pakistan grants story still has legs. There was a Dissent Channel message from an AID
	employee criticizing the suspension of the use of U.S. NGO contracts in the FATA which has been leaked to the

- Naji Hamdan has been sentenced to 18 months in prison in UAE. He has already served 14 months, so should be released in four months.
- The Chinese legal counselor called Harold last night to ask for assistance with a default judgment against China, apparently in an expropriation case. He will get more details today.

Honduras

• Tom Shannon said that the two sides are reporting progress in ongoing negotiations, but they have yet to tackle the tough issue of the return of Zelaya to office.

Turkey and Armenia

• EUR reported that the Turks will submit the agreement signed with Armenia over the weekend to Parliament today as promised, making it possible for the Armenian President to visit Turkey for the soccer match.
