### **G-8 POLITICAL DIRECTORS**

• Bill reported on his conversations with the Russians on Iran. I understand those have been shared in other channels.

#### <u>HAITI</u>

- Pat reported that we have recovered the remains of all the Americans believed to have been in the Hotel
  Montana. The issue now is under what authority and who would pay for the recovery effort to continue for the
  other 10-12 other sets of remains still entombed, something the embassy would like to happen. Cheryl asked
  Pat for options.
- There is still uncertainty as to when the Haiti Supplemental will go to the Hill. Perhaps not until the Donors Conference. Cheryl stressed the need to have pre-cleared language on what we can say to the Hill and at the Conference with respect to numbers.

- The issue of whether the U.S. offered to "mediate" in the Falklands issue is still attracting much press in Europe. We have made clear that the Secretary said we were "willing to help," but had not mentioned an offer to mediate.

- We will also give a preview on the Iraqi elections tomorrow.
- New York Times story today on allegations State sought to block serious investigation of 2007 Blackwater shooting event. PJ had pushed back. Pat noted that one Blackwater official who is quoted undercuts the whole allegation, suggesting that in fact State officials did not give Blackwater time to get their story together, but immediately launched an investigation.

### CONGRESSIONAL RELATIONS

- Senators McCain and Lieberman have voiced concerns that Robert Ford may leave Baghdad early to begin preparations for his next assignment as COM in Damascus. They believe he needs to remain in Baghdad at least through the formation of a new government, although that could take months.
- The Pakistan spend plan had a mixed reception on the Hill.
- Senators Dodd and Menendez will be on the CODEL to Haiti this Friday.
- We are working to help Preval set up meetings on the Hill during his visit next week.
- Rose Gottemoeller is in town and will brief Kerry, Lugar and Levin on START.
- The Secretary will testify with Secretary Gates before the Full Senate Appropriations Committee on March 24 on the war supplemental.
- Senator Kyle released his holds on Laura Kennedy and Eileen Donahoe
