BUDGET

- Jack noted that the Secretary's calls to the Hill had been difficult insofar as while they all want to help, the political reality and numbers make it difficult. He added that our message has to be that, notwithstanding what the Hill may think, cuts of the magnitude they propose will impact our ability to do our jobs in Af/Pak and Iraq. In terms of an immediate way forward, Jack suggested we would focus on getting what we can in terms of fee retention in the Supplemental, which would address roughly 20% of our problem.
- Rich said he has draft language for a letter from Secretary Gates he will pass to Cheryl. He also noted that a letter from the Secretary to the budget committees will go up to the Hill this morning.
