**Terrorist Attacks on Internationally Protected Persons** 

The General Assembly,

Recalling the United Nations Global Counter-Terrorism Strategy, contained in General Assembly resolution 60/288 (2006), as well as General Assembly resolutions 62/272 (2008) and 64/297 (2010), which reaffirmed the Strategy,

Renewing its unwavering commitment to strengthening international cooperation to prevent and combat terrorism in all its forms and manifestations, [UNGA 64/297, PP4]

Convinced that respect for the principles and rules of international law governing diplomatic and consular relations is a basic prerequisite for the normal conduct of relations among States and for the fulfillment of the purposes and principles of the Charter of the United Nations, [UNGA 65/30, PP 2],

Concerned at the failure to respect the inviolability of diplomatic and consular missions and representatives, [UNGA Res 65/30, PP 6],

Noting the letter of the Kingdom of Saudi Arabia of 7 April 2011 regarding hostile actions committed against diplomatic missions in Iran, and recalling the obligations on States regarding the protection, security and safety of diplomatic missions, consulates and personnel on their territories,

Emphasizing the duty of States to take all appropriate measures required by international law in a timely manner, including measures of a preventive nature, and to bring offenders to justice, [UNGA Res 65/30,

Noting the letters from the United States on 11 October 2011 and from the Kingdom of Saudi Arabia on 12 October 2011 regarding a disrupted Iranian plot to assassinate the ambassador of the Kingdom of Saudi Arabia to the United States, and noting further the statements of the Gulf Cooperation Council of 12 October 2011 and of the Arab League of 13 October 2011,

Noting also the letter received from Iran on 11 October 2011,

Recalling the Convention on the Prevention and Punishment of Crimes Against Internationally Protected Persons (the Convention),

Alarmed by the new and recurring acts of violence against diplomatic and consular representatives, which endanger or take innocent lives and seriously impede the normal work of such representatives and officials, including those planned or executed acts referenced in the letters of the Kingdom of Saudi Arabia and the United States of America [UNGA Res 65/30, PP 3],
