Otherwise, he will offer to go there himself to protect the denizens of Camp Ashraf. The Governor added that he and Gov. Ridge would share these thoughts at the National Press Club this Thursday (we're checking this with the NPC). I was able only to (a) explain my role and (b) state that preventing a humanitarian catastrophe was the top priority.
