**Background:** In response to a demarche by the Georgian Embassy in Washington in late April, the U.S. Embassy in Santo Domingo raised this issue of Dominican Republic recognition of South Ossetia and Abkhazia with the Acting Foreign Minister (FM was traveling) on April 28, including reiterating U.S. support for Georgia's territorial integrity and sovereignty (see readout cable on the high side). The Georgian Embassy demarched us again in early May. A delegation from the government of the DR, led by the Vice Prime Minister, is currently in Abkhazia on an official visit (May 12-13). Our Ambassador in Santo Domingo is calling the DR Foreign Minister today to reiterate our concern (WILL UPDATE AS POSSIBLE). WHA A/S Valenzuela was in the DR this week, but did not raise the recognitions issue.
