Have been having intensive meetings on this. Spoke to Cathy at length tonight. Upshot is that, as she told you, there will be - at present - a UNGA Resolution. Qataris especially are pushing it hard.

However, there's now acceptance of a Q statement plus some interaction with UNSC as the basis of restarting a negotiation. So the issue is: will any Resolution mean statehood? Cathy says she was adamant that the Resolution couldn't mean statehood but would say something like "looking forward to a Pal state asap". But we need to watch that very carefully.

I'm seeing everyone including her BB and Abbas in next 2 days. We should speak soon.
