Update on efforts to secure meeting with MFA to discuss passport/access issues:

-- MFA has agreed to meet with DCM Bob Wang and me tomorrow at 09:30. MFA rep will be DDG Lu Kang, who served as VFM Cui Tiankai's deputy throughout the Chen negotiations.

-- Lu Kang provided a "preview" of China's official message tomorrow: the more we (and Chen) be quiet, the greater our chances this all works out in a way all sides are pleased with. PRC authorities cannot be seen as moving under US pressure, I was told.

I'll provide a few more details from Lu on the high side, and we'll then do a full write-up tomorrow.

If talking points still needed on your end today, we've been discussing on our end somehow framing today's incremental progress in a way that puts both sides' efforts in a positive light, mentioning:

Chinese officials visited Chen for the fourth time today to document his complaints about mistreatment in his home village in Shandong. He's told us that, in total, they've spoken to him for about three hours.
US officials were in regular, consistent contact with him today. Amb. Locke spoke to him for 30 minutes. DCM spoke to him twice. And other officials have been in touch with his wife.

All:

For our press posture, it seems that we're still in a holding pattern although there are some positive signs from Chen that may be in our interest to share with the media.

In the calls I fielded with Beijing-based U.S. media today, they seemed to be anxious for any progress on the following:

- Chen's travel documents and travel plans to the U.S.

- Any substantive readout of discussions between Bob and Chen/wife

- Chinese reaction/movement to facilitating Chen's passports

- Extraordinary steps the Chinese and U.S. are taking to sidestep regulation to permit Chen to travel expeditiously.

## CURRENT ACTIONS TAKEN:

On background, I'm confirming meetings and phone calls with Chen as it happens. Perhaps we can discuss taking it a step further to characterize some of the discussions Chen is having with the Petition Bureau. With respect to what the Chinese gov't is telling Chen about issuing a passport, we need to be careful how to play that. We obviously don't want to seem overly encouraged.

Off the record, I'm telling trusted journalists that this is not a sprint and that we have to let the process play out, especially as we continue this delicate dance with the Chinese. Any overreaction publicly may have a negative impact on our efforts to get the Chinese to move expeditiously. They seem to understand that but they will want tidbits of anything coming from Chen to reinforce his optimism and good spirits. I'm also telling them that talking on the phone with Chen is just as effective so far as meeting in person with him.

For those unfamiliar with Chinese processes, Bob's reference to the Petition Bureau (aka Letters Bureau) means that the Chinese are taking the initial step in meeting Chen's request for an investigation into his case against local Shandong authorities. VFM Cui mentioned to me the other day that Petition officials had already met with Chen for several hours on Thursday and he appeared to be fully engaged in recounting his story in fine detail. Of course, we'll see how seriously the Central Government follows through, especially if Chen decides to leave China soon. But this is another positive development from our perspective...km

Chen just called me with some good news. He said the Chinese official from the Petition Bureau visited him today, and Chen raised the passport request with him. The official replied that the Chinese are prepared to issue Chen and the family passports but did not give timeline. Given Chen's condition, he indicate they will help him complete the process at the hospital. Chen sounded optimistic although he said he didn't know how quickly this could be done.

Chen also said that the hospital told him embassy officials could meet with the family, although not at the Ambassador's level, because this would be too sensitive. We'll call the hospital directly to see what we can do today.
