Sorry to bother you given all the head aches of the world, but on possible speech topics, some of our big areas of focus are:

- 1. China how we view the relationship over the long term; how it has grown over just the first year of the Obama admin. As you may know, Rudy DeLeon is our SVP for National Security and he is a former Dep Sec of Defense, so he often sees things from the military's perspective (he said that his friends in the military in the Pacific said you were amazing with the Chinese last week; and that the Chinese military was horrible not sure what that means, but I'm hoping it will mean something to you.) However, we have also worked on many aspects of the relationship from trade, to spheres of influence, towards managing China's role on Iran and North Korea.
- 2. An Integrated National Security Budget is an idea that we have championed for some time.
- 3. Climate change and its impact on foreign policy decisions. (Working in any reference to BP and how it affects our international relationships and just making sure it doesn't do so adversely will make news! :)
- 4. The rise of India and the unique possibilities of partnership over the long term. John has asked me to strengthen our India program, which I am starting to work on now. CAP has already done extensive work on energy issues, and we're now moving into economic issues, like a shared innovation agenda and will then build up to more direct foreign policy concerns. The Indian Embassy recently reached out to me to have CAP get involved on issues across a range of subjects. My main theory is that if CAP is more pro-India on economic issues for which we can push against the left (like on outsourcing), we may be better positioned as an organization to put some pressure on India (and as a person who gets a fair amount of Indian press on domestic issues, perhaps I can do some good). I know you are having the Strategic Dialog now, and so the timing of this may be better ahead of foreign travel in the fall. (An interesting side note, we're seeing a huge increase in support for economic nationalism across the country which cascades into Iranian sanctions and punishing corporations that undermine America's interest there, but also is creating stronger opposition to outsourcing, which I think will (unfortunately) be an issue as India comes into focus through a Presidential foreign trip in the fall.)
