is is looking closely at ISCI-Sadrists alternative to SOL as the Shia partner

- Allawi supposedly angry at us as we had 'blocked' his Sadrist deal and now Maliki has 'won' them over

Allawi and the 90 other Irakiya COR members met this AM, Based on this morning's discussions (which are on-going), two of our contacts believe the following will occur (but this is not a final report!!):

1. Iraqiyya will vote unanimously against the return of Maliki as PM

- 2. Iraqiyya will consider ISCI/Fadillah's defections as having eliminated the existence of the INA and NA, thus leaving Iraqiyya as the largest formal bloc
- 3. Iraqiyya will only partner with SoL (and perhaps the Sadrists) if they allow Iraqiyya/Allawi to form the government
- 4. Iraqiyya remains committed to a national unity government that is inclusive of all Kurdish, Shia, and Sunni factions
- Allawi meanwhile has decided on another perhaps week-long trip around the ME to garner support
- Badr's Amiri and one other Badrist have joined the SOL-Sadrist support Maliki. Rest of Badr, and Fadillah, are still loyal to Al Hakim
- Kurds totally split internally. I am off to see Barham but they range from pro-Adel (Barham) to pro-Maliki
 (Talabani) to somewhere-in-the-middle (Mesud, Necivan). We will need more clarity on them to go far on any
 scenario. But they will look to us before making decisions.
