# PAKISTAN SUPREME COURT DISQUALIFIES PM GILANI

(SBU) Embassy Islamabad comments a three-member bench barred PM Gilani from holding office as of April 26, the date of his conviction for contempt of court. The Election Commission of Pakistan has notified Gilani of his disqualification, and leaders of ruling coalition political parties are meeting to decide who will succeed him. Once the pretrial judge makes certain preliminary decisions on timing and logistics, which could take up to five weeks, both sides will file formal notices of intention to appeal the judgment.
