I want to assure you that we have made every attempt to secure you a confirmation hearing this month and have raised your nomination at every opportunity. Unfortunately, we are at the mercy of the Senate, and more specifically, the Senate Foreign Relations Committee. We have advocated for your inclusion in each of the three State hearings this month. Unfortunately, the hearings have been for career ambassadors going to specific geographic regions (Africa, East Asia, and Pakistan). Despite our advocacy, the committee didn't see fit to add your nomination to any of those hearings.</millscd@state.gov></rodriguezme@state.gov>
We had been talking with both Kerry and Lugar's staff about a hearing for you this week, specifically this Thursday. However, it now looks like the Senate will recess Wednesday evening, making a Thursday hearing impossible.
I did speak again this afternoon to Senator Lugar's staff, and they inform me that they have no objection to pressing forward with a confirmation hearing for you during the Senate's lame duck session in October. Although the length of that work period will be determined in large measure by the results of the elections in November, I think we're all hopeful that there will be an opportunity for a hearing for you. No guarantees of course, but we'll continue to press the committee as hard as we can.
