Alan, I think it might be a very good idea for you to transmit the letter set forth below to Hillary on your personal stationary.

Dear Madam Secretary,

My friend C. Leonard Gordon, whom you have met in East Hampton, is Chairman of the Board of an Israeli Company, Althera Medical Ltd. ("Althera") that has a patented product, based on an invention at Tel Aviv University that delivers alpha radiation into tumors on a tiny pin called a DaRT (*an acronym for Diffusing Alpha-emitters Radiation Therapy*).

Alpha radiation has been the "holy grail" of radiation for over 50 years. It is more powerful than Beta or Gamma but, until the invention of the DaRT, it couldn't be beamed into a tumor because it can't penetrate skin, or even rice paper.

Scientists at TAU have conducted thousands of tests inserting DaRTs into every kind of human tumors implanted in animals. The radiation bounces off of the DaRTs and diffuses throughout the tumor shrinking it and killing the cancer cells. The radiation, if it escapes through a break in the skin of the tumor, can't travel more than a millimeter or two in healthy tissue. The DaRTs are ready for human clinical testing as shown by the Press Release attached to this letter.

Len suggested you might send a copy of my letter and its attached press release to President Hugo Chavez to have his doctors review the safety, efficacy and possible applicability of DaRTs for treatment of President Chavez's cancer. It is a more powerful, safer radiation treatment of his cancer then he received in Cuba and it is easier to deliver. No lead lined rooms or big equipment is needed, nor is there any need to go to Cuba for the treatment. His doctors could insert the DaRTs in Venezuela.

We think that Steve Jobs might be alive today if DaRTs had been available to him. Alther is prepared to make DaRTs available to President Chavez's Doctors in Venezuela for examination testing and for treatment of President Chavez. They can be shipped by air, loaded with precise dosage of alpha radiation required to be effective for 4 days. The radiation loses power and is finished in approximately 20 days. The DaRT could be removed but need not be.

Professor Benjamin Corn, Chairman of Radiation Oncology at the Sourasky Medical Center and Althera's Chief Medical Officer who will lead the clinical testing in Israel would be available to review the feasibility of such treatment with President Chavez's doctors in Venezuela.
