Here is an update:

After the Rio+20 conference, Susan Rice suggested one more round of discussion on the U.S. participant on the panel. USUN/NY is working on a short paper laying out the issues and background, as well as factoring in conversations Elizabeth Cousens has had with the UK and Indonesia at Rio. This paper would be the basis for a decision.

At the July 2 9:15am senior staff meeting, the Secretary said that Ban had asked her when would the U.S. provide a name for the high level panel. (They were both at the June 30 Geneva meeting on Syria.) I responded that we would move ahead with interagency conversations and recommend a name.
