It was wonderful to see you yesterday briefly with Jill at the NY Women's Foundation Event. Your remarks about your mother and the role of kindness in the world were incredibly inspiring. The more I hear you speak in different contexts the more I think our philosophies on life and women are so very aligned on many levels. I also enjoyed the privilege of being in China last week on the Women and Philanthropy portion of the US Delegation. So much interesting learning came from that trip and I thought your remarks with Madame Liu were so very appropriate and well delivered.

Since we last saw each other around Women in the World, I have been spending a lot of time thinking about "the way forward," as you aptly put it, drawing on what I have seen in law (at Latham), business (at Avon), philanthropy (at Goldman) and now in the media with Tina. I do think there is a moment here that can be seized for women if we look at the pieces of the puzzle - or the legs of the stool - a bit differently and seek to identify the best constellation that will provide the strongest leverage points for women today. Again, it was so wonderful seeing you yesterday and do hope we get a chance to explore some ideas about what is possible. I do truly feel the moment could be upon us.
