

<u>ELIGIBILITY</u>: Priority will be given to Department of State direct-hire (FS, CS) employees at the FO-04 to -01/ GS-12 to -15 and other inter-agency personnel who are currently serving in positions at embassies and regional bureaus occupied with issues of civilian security, and in bureaus and offices that report to the Under Secretary for Civilian Security, Democracy and Human Rights (J). Other agency employees (including comparable military ranks) who meet the stated requirements may attend on a reimbursable basis. Space is limited and final registration will be determined in consultation with the Office of the Under Secretary for Civilian Security, Democracy and Human Rights.
