We are continuing our discussions with DoD regarding the "rebalancing" efforts but the mood has shifted significantly in the past month and we are beginning to encounter resistance to moving forward in any meaningful way.

As you know, I strongly believe that our national security goals would best be served if U.S. civilians under State Department leadership led all USG engagement, strategic communication, and public diplomacy activities with foreign civilian populations, with the exception of active combat zones. This is a matter of both principle and practicality. Civilian processes should be used to determine our nation's engagement priorities, the type and range of programs to deploy, and the end results sought. From the perspective of global publics, civilians are more credible and thus more effective spokespersons for the U.S. in the long run. I am also convinced that experienced, language-fluent, and culturally aware State Department public diplomacy professionals can achieve strategic communications and engagement objectives more efficiently and effectively than their DoD counterparts. Officer for officer and dollar for dollar, we can produce better results.

DoD agrees in principle to civilian leadership on engagement activities, but has a different perspective of what this would mean.
