Below are quick highlights from the speech. He reiterated what he and others have said publicly before, namely that he will seek full membership in the UN, and confirmed that the letter will be submitted the day of his speech (September 23). This time, he added, "all other options (i.e., UNGA) will be studied and decided upon <u>later</u>." The decision was justified in terms of leveling the playing field for future negotiations, in which the (territorial) terms of reference would be set, and repeated his line that the Palestinians do not want to "isolate" Israel but rather the policies of occupation and settlement. Abbas also emphasized the importance of keeping demonstrations on the ground peaceful, lest this be used to discredit the statehood drive.

"We are going to the UN Security Council. This is our decision which we have communicated to everyone. Once I deliver my speech, I will deliver the accession the letter to the UNSG who in turn will hand It over to the Presidency of the Security Council. All other options will be studied and decided upon later."

Heading to the UN tomorrow to get our people's concern to this forum. Our people have suffered years after years.

Our rights are being violated every day.. While the world hears and listens.

The tragedy of our people has been born along with the UN. Dozens of resolutions have passed.

We are going to get our right which is full membership in this organization.

Going to the UN came as a result of the failure of negotiations caused by the Israeli inflexibility.

Going to the PLO won't have any bearing on the status of the PLO, the sole legitimate representative of all Palestinians.

As you know the PLO is the high reference and authority for the Palestinian people. The PLO is the creator of the PA. Those who speak about undermining the PLO status and role, are not accurate. (i.e., a refutation of Goodwin-Gill...) The PLO will stay until a solution is found to all outstanding issues mainly the refugees.

Three reasons for September:

Obama said in September he hopes to see a Palestinian state, member in the UN. Quartet said in September is a deadline to negotiations and thirdly we had set september as deadline to end government institutions building plan and so was attested by the World Bank last month.

We put our prisoners on top of our priority.

We don't want to raise expectations. We won't be able to get independence out of this move. We should not downplay the significance f the move either.

We go to the UN to get full membership from the UNSC.

We are going to the UN armed with an Olive branch which was held earlier by late Arafat. (Hope they won't strip us of it).

We are going to the UN not to de-legitimize Israel but to isolate Israeli occupation and practices against our people. They have trained dogs, unleashed pigs, and unleash other means to fight our people at the time we head to the UN. These aggressions remind us of Shatila and Sabra massacres and other massacres in the past. Today is the anniversary of Sabra and Shatila massacre. For the past 63 years we have experienced such massacres. Its about time to end this and relax...

The occupation is the main reason for instability.

Let me be honest... We are going to face difficult times. If we succeed, the following day the occupation will not end. But we would have achieved recognition that its not a disputed territories but a state under occupation. Today, Israel denies that this land is ours. They claim that its their lands/ borders. We stand to stay that settlement is illegal and this is out land. This would lead us to a state to state negotiations and not a disputed territories.

I promise that any outcome will be put on the table for the leadership to study it. Going to the UN is not our strategy but a part of this strategy. Creation of a state on 1967 is the goal etc.

I call on our people every where not to give anyone the excuse to undermine our status while we are seeking this achievement in the UN. Our people will be able to prevail. We affirmed the peaceful nature of our actions. Some Israeli intelligence say 'we have never heard Abu Mazen utter the word peaceful.' I don't utter anything but the word peaceful.

I read some views about those who say you should embrace other means (he was speaking in front of a Palestinian audience that included all of the PLO factions). I urge you not to deviate from peaceful marches. Any other action will give others an excuse to discredit our struggle.

We will continue to seek reconciliation, unity of the people and the land is our main weapon. We will keep this unity and we need to strengthen our internal standing.
