Subject: Iran Hikers Released, Airplane en route to Tehran (SBU)

(SBU) Embassy Muscat says Shane Bauer and Josh Fattal, the two U.S. citizens detained in Iran since mid-2009, have been released into the custody of the Omani Envoy in Tehran and notes an Omani airplane is en route to Tehran to retrieve the hikers.

(SBU)? Embassy Dubai notes the Irani Judiciary?s Office of Public Relations and Protocol said in a statement that Branch 36 of Tehran?s Appellate Court agreed to their release. The text of the short statement follows: According to the Judiciary?s Office of Public Relations and Protocol, following the two American citizens? lawyer?s request to Branch 36 of the Tehran Appellate Court to implement their bail order, after they had been sentenced to mutable sentences of 8 years in prison by Branch 15 of the Tehran Revolutionary Court, Branch 36 of the Appellate Court, as the jurisdiction for this appeal, agreed to this request, and by transforming the temporary custody order to a bail order, and by issuing the approval of bail at 5 billion rials (500 million tournans, about US\$500,000) for each defendant, freed the abovementioned until the definite verdict is issued.
