Subject: Update on Honduras and the OAS

The following is an update on our efforts to promote the prompt reintegration of Honduras into the OAS. Attached, please find the <u>current vote count</u> (also listed below). Outreach continued today, including calls between DAS Reynoso and ministers of Grenada, Dominica and Saint Vincent and the Grenadines, and contacts at the OAS by Ambassador Lomellin. As A/S Valenzuela discussed in a conference call earlier today, we are still hoping the Colombian-Venezuelan effort will bring near consensus on this issue. If it does not, however, the Colombians are supportive of the U.S. government desire for a prompt OAS vote.

- Pres. Colom phoned Pres. Ortega. Ortega did not/not push back on reintegration.
- DAS Reynoso called PM Skerrit (Dominica). He said the Honduras issue would come up next week at the Organization of Eastern Caribbean States meeting. He said Dominica would support reintegration once "Zelaya is free to go home."
- DAS Reynoso called the Saint Vincent and the Grenadines PM.
- Amb. Aponte asked Pres. Funes to call Pres. Rousseff.
- Amb. McKinley asked Pres. Santos to call Rousseff.
- Amb. Piehel called the Suriname FM. Suriname thinks it's "time to move forward."
- Amb. Lomellin spoke with Colombian OAS Perm. Rep. Hoyos. He said Colombia is going to try to lobby Argentina.
- Amb. Lomellin spoke with the Belizeans, Guatemalans and Peruvians at the OAS. Pres.
  Colom had planned to call FM Patriota (Brazil) to ask him not to hinder Honduras's
  reentrance. Patriota said Argentina is concerned about human rights issues. Peruvian
  Perm. Rep. DeZela said he has spoken to Venezuelan Perm. Rep. Chaderton.
  Chaderton said Venezuela would not obstruct the reintegration process.

## **Opportunities**

- Pres. Colom will call Pres. Rousseff to emphasize the implications of Honduras's isolation to its region in light of the deteriorating security situation. Colom is also willing to travel to Brazil to convey that message.
  - DAS Reynoso is calling FM Rodas (Guatemala) this weekend to urge continued Guatemalan outreach to Brazil.
- Pres. Fernandez is also reaching out to Pres. Rousseff.
- A/S Valenzuela is in Paraguay meeting w/ President Lugo; FM Moreno (Chile); FM Choquehuanca (Bolivia). A/S Valenzuela will also meet with Pres. Mujica at the Paraguayan bicentennial events.
- FM Holguin (Colombia) was in Argentina on May 13, and will be in Uruguay on May 14 pushing Honduran reintegration.
- Embassy Brasilia is working to persuade the Brazilians that the Zelaya case will not/not be appealed.
- Possible WH call to Brazil.
- Possible S call to Santos.
- Pres. Martinelli is traveling to Ecuador on May 13, where he will discuss Honduras issues with Pres. Correa.
