I have created a new federal advisory committee at the State Department to provide me with informed advice on a broad range of U.S. foreign policy issues.

The membership will be bi-partisan and diverse. We have named this committee the Foreign Affairs Policy Board, which you will recognize, mirrors the comparable DOD Defense Policy Board that has been in operation for years.
