GOS Interest in Economic Statecraft

A good news story, the GOS wants to follow your example by elevating economic statecraft as an important component of their foreign policy. The Mission I lead in Spain has made this a top priority, and I was very pleased to have been invited to your Global Business Conference to share Embassy Madrid's best practices. I think you'd be interested in some of our activities, alone and in concert with the GOS, to create jobs and economic growth in the U.S.

Service Innovation Summit

In addition to these matters which I'd like to discuss with you, I want to bring to your attention a conference our Embassy will host in Madrid, at the end of this month, having to do with volunteering and community service. This Service Innovation Summit is the product of a public private partnership between Embassy Madrid and Meridian House, and it is intended to encourage the growth of volunteering and community service in Spain. Although the Spanish lack a strong tradition of civil society, as exists in the United States, they understand that challenging times require the participation of every citizen in addressing the problems of their communities and their nation. There is a growing appetite in Spain for engaging citizens in community service, and the Embassy has undertaken a number of initiatives to support this. The Service Innovation Summit will bring experts and service leaders from the United States to Madrid to share best practices and to learn from one another.

We have received enormous and enthusiastic support for this Summit. His Royal Highness, the Prince of Asturias will give the opening address. Ann Stock, Kris Balderston, and Jonathan Greenblatt, from The White House Office of Social Innovation and Civic Participation, along with Arianna Huffington, José Andrés, Alan Khazei and many more American leaders have agreed to join us in Madrid. We believe the Mayor of Madrid will announce at the Summit that her city will become the second international city to participate in the Cities of Service Program begun by New York's Mayor Bloomberg.

In light of our shared passion for service, I thought you'd like to know what the Embassy in Madrid is doing to promote this in Spain.

Lastly, as I noted to Cheryl, during a recent meeting with His Majesty King Juan Carlos, he asked me to convey his warmest personal wishes to you.

I look forward to seeing you at the Chiefs of Mission Conference, and if it is possible, spending a few minutes discussing these bilateral issues.
