The U.S. National Commission for UNESCO is a State Department federal advisory committee that supports worldwide humanitarian development and values by coordinating efforts and delivering expert advice from federal, state and local governments and from the NGO community on issues of education, science, communications and culture.

Appointments to the Committee are made by the Secretary. This year, the Secretary can appoint up to 16 members from the NGO community, 12 state and local representatives, 3 federal representatives, and up to 8 members at large.
