Just spoke to FM Amr on behalf of S, and urged that he and President Morsi weigh in with Sudanese tonight re protective personnel to Khartoum. I mentioned that Anne had already been in touch with Essam Haddad.

Amr said he understood urgency, and would talk to Morsi and then raise with Bashir and co. I told him I did not have precise numbers, but point was that addl personnel would be discreet and temporary, much as had been case in Cairo during revolution. Key is to ensure safety of our diplomats.

He promised to try.
