To Ambassadors and DCMs:

As you will have heard, the parties reached a deal in Honduras late Thursday night. In advance of more formal talking points, please draw on following points Tom did for the Secretary. Please underscore that the Honduran negotoiating teams did a superb job, supported by their leaders. We were pleased to work closely with them over the last two days.

Throughout the crisis we we worked closely with the OAS and friends in the region. Please encourage host govts to support the Honduran elections now that there is a Guaymuras agreement.

Also, please underscore that S played an active role from the very beginning, by her key role in helping launch the San Jose process, to meeting with and calling key leaders (including Zelaya and Micheletti more than once). She also took the risk of sending a team to Honduras against long odds this week.

Many thanks to all for your support throughout. Particular kudos and thanks for Amb. Llorens, DCM Henshaw and their excellent team for four months of skilled and tireless work. USOAS under Lew Amselem did an outstanding job as well. WHA/CEN under Chris Webster -- and DAS Bisa Williams -- worked round the clock producing huge amounts of excellent work. WHA Press devoted long and productive hours as well.

Of course, the work is not done. Implementation and preparation for elections will keep everyone busy. But all who contibuted to this success should take a moment to enjoy it.

This is an a big step forward for the inter-American system and its commitment to democracy as embodied in the Inter-american Democratic Charter.

-- we were proud to be part of this process, and commit ourselves to working with Honduras as it prepares for elections.
