A short while ago President Lobo agreed to the final draft of the text of an Agreement for National Reconciliation and Democratic Consolidation in the Republic of Honduras brokered by Colombia and Venezuela. It will be signed in Cartagena tomorrow. I just spoke to President Lobo who was upbeat about the outcome. He expressed his deep appreciation for the steadfast support from the United States throughout. He will travel Monday to a meeting in Managua with Colom, Funes and Ortega. The Central American countries will ask for a special session of the Permanent Council this week and present a resolution to re-admit Honduras to the OAS.

It has been a long day ______ I have been in continuous touch with Foreign Minister Holguin since late last night-- she has shared drafts of texts and concerns -- and both Mike McKinley and Hugo Llorens have been available around the clock to follow this and speak to both presidents, VP Bogran FMs and others

Julissa had earlier spoken to FM Rodas of Guatemala-- and I followed up with an additional call as well to reiterate our support for the meeting the Central Americans are convening Monday in Managua.

We should expect the Centrals to call the PC meeting expeditiously--
