We've received word from the FCO that one AMCIT and one Briton have been detained or kidnapped in Syria. The AMCIT is named Jim Foley and the UK captive is John Cantelle. They were reportedly taken from an internet café in Binesh, Syria. There is no attribution regarding responsibility. Both are journalists, possibly freelance.

FBI London is coordinating in the UK. CA has been notified, and is attempting to verify identity and whereabouts now, and will coordinate directly with UK Embassy Washington, as will CT and our hostage recovery expert.
