Please forward to Cheryl this report on my 48 hour visit to Kiev.

One is never completely sure that the Government of Ukraine will do what they say, but I believe I convinced Yuri Ivanyuschenko, the President's best friend, that JT must be freed from jail. Yuri convinced the President and I believe she will be free by early next week—if they do what they say. Doesn't mean the charges will be dropped, but they appear to have a plan to get the Roda to change the law to decriminalize what she did—maybe. Also, look for a new Minister of Foreign Affairs to be named in the next few days. Hold this close, as the incumbent MFA doesn't know it.
