#### NASA Agency Program Management Council September 2017 Capability Days APMC Decision Memorandum

**Summary:** The Agency Program Management Council (APMC) met on September 13-14, 2017, focusing on continued progress implementing the Capability Leadership Model (CLM) across the Agency, and deliberating previous Mission Directorate actions for closure. Additional background related to this APMC, including prior actions, is referenced in the March 2017 APMC Capability Days summary posted to "Inside NASA". For all topics discussed at this APMC, supporting files can be found on NX in the September 2017 APMC Capability Days meeting folder.

#### **Decisions:**

This APMC was established as informational, with the topics intended to feed forward into subsequent senior leadership meetings. However, the following specific decisions were made during the meeting upon review of the recommendations. Additional actions related to these decisions are noted in the actions section of this memo.

#### Small/Medium Size Mission Competition Diversity and Approach - GSFC/JPL

**Decision 1:** The APMC accepted the GSFC/JPL proposed process that allows Principal Investigators (PIs) from different Centers to be part of the mission proposal process, prior to considering external partners. Based on this decision, the GSFC and JPL leadership will jointly release a memo to the remaining NASA Center Directors, laying out the process under which civil servant PIs from all Centers can have their proposed mission concepts considered by GSFC and JPL for potential mission collaborating/partnering. In addition to the memo, GSFC/JPL will conduct documented, multi-step, multi-factor decision gate processes to select the portfolio of mission concepts for each Announcements of Opportunity (AO). Two joint notices will be released per relevant AO. (Action closed: 03/15/17 APMC action #3).

#### **Center Roles Update – Mission Directorates**

**Decision 2:** In general, the Center Roles updates by the Mission Directorates were accepted by the APMC. Specifically, SMD added two new roles: 1) research for high-end computing to GSFC; and 2) planetary science research, technology, and data archiving to GRC. In addition, SMD research capability leaders have asked Centers to hire new scientists in understaffed research capability areas, as needed. SMD work packages through the Internal Scientist Funding Model (ISFM) are directed to research capabilities of the Centers.

The SMD study on program office roles and responsibilities was presented and accepted by the APMC (Action closed: 10/31/16 EC action #EC-2016-10-001).

#### CLM Baseline Reviews and Systems Capability Leadership Team (SCLT) Updates Accepted by the APMC

*Decision 3:* The baseline assessments for the Sensors & Instruments discipline capability and the Heliophysics Research capability were accepted by the APMC.

In addition, STMD provided an SCLT update on the Entry, Descent & Landing (EDL) capability and the Rendezvous & Docking capability (Action closed: 11/30/16 APMC Follow-up #R8). HEOMD provided an SCLT update on the In Situ Resource Utilization (ISRU) capability (Action closed: 11/30/16 APMC Follow-up #R8).


- 1. <u>09-13-2017#1, informal APMC Action</u>: (STMD SCLT) confirm the statement "...ESA can provide passive international berthing & docking mechanism..."; email the AA with reply. Assigned to: HEOMD/G. Williams, due September 22, 2017. Action is **CLOSED**.
- 2. <u>09-13-2017#2, formal APMC Action</u>: (HEOMD SCLT) review authority, technology approach, and resources for communications and navigation to determine if SCLT is warranted. Assigned to: HEOMD/Deputy AA, due March 2018 APMC.
- 3. <u>09-13-2017#3, formal APMC Action</u>: (ECLSS SCLT) develop the executive summary for the ECLSS capability, including challenges and areas under consideration (Note: outside of the nominal cadence for this system). Assigned to: HEOMD/R. Gatens, due March 2018 APMC.
- 4. <u>09-13-2017#4, formal APMC Action</u>: perform a scoping assessment of the topic, Digital Transformation, to determine if a new capability should be established. Assigned to: OCT/D. Terrier, due March 2018 APMC.
- <u>09-13-2017#5, formal APMC Action</u>: charter a review of how insight/oversight is applied and develop a more consistent and efficient approach. Assigned to: AA/R. Lightfoot, due December 31, 2017.
- 6. <u>09-13-2017#6, formal APMC Action</u>: charter a Human Systems Integration tiger team which includes representation from the three technical authorities, Mission Directorates and relevant disciplines to scope and provide options to address the human systems integration technical gap. The scoping effort will identify HSI requirements, policy gaps, technical gaps, and will propose the best long term integrated approach to address HSI within NASA. Assigned to: OCHMO/J.D. Polk, due March 2018 (status); September 2018 (completion).
- 7. <u>09-13-2017#7, formal APMC Action</u>: charter an Active Optical (Laser/Lidar) tiger team, which includes representation from SMD, STMD and HEOMD to address an increased emphasis in Active Optical technology which is critical for future NASA Earth, Planetary Science and Mars Exploration. Team to provide agency-level strategy and solutions for advancing high-risk Laser/Lidar technologies that are not currently being sufficiently planned or developed or risk reduced to meet NASA missions requirements. Assigned to: Sensors/Instruments Capability Lead/U. Singh, due March 2018 (status); September 2018 (completion).
- 8. <u>09-14-2017#8, formal APMC Action</u>: provide Executive Summaries for Earth Science, Astrophysics, and Planetary research capabilities, utilizing the executive summary template. Assigned to: SMD/D. Andrucyk/M. New, due March 2018 APMC.
- <u>09-14-2017#9, formal APMC Action</u>: present to the NASA AA a concept of Program Office capabilities, with the intent of avoiding duplication between program/project and institutional functions (ensures actual core program work). Assigned to: SMD/D. Andrucyk; discussion on concept due October 31, 2017 (include HEOMD/Deputy AA); presentation on concept due March 2018 APMC.
- 10. <u>09-14-2017#10, formal APMC Action</u>: establish cube-sat/small satellite coordination working group across the Agency led by SMD. Assigned to: SMD/D. Andrucyk, due March 2018 APMC.
- <u>09-14-2017#11, formal APMC Action</u>: update Center Roles for document NPD1000.3 *The NASA Organization* (V2), based on APMC accepted content and additional Mission Directorate refinements. Assigned to: Office of the Administrator/L. Guerra, OACS/D. Boccippio; due December 31, 2017.
- 12. <u>09-14-2017#12, informal APMC Action</u>: join the membership of the Enterprise Protection Program panel, with the intent of safeguarding mission systems. Assigned to: Mission Operations Capability Leader/Troy Leblanc; due December 31, 2017.

### Forward Work:

- 1. Office of the Chief Engineer will pursue the following and report status to the March 2018 APMC:
  - Partner with the Office of Procurement to review the current engineering support contracts to identify opportunities to leverage or consolidate (in conjunction with Procurement Business Services Assessment activities).
  - Working with the Associate Administrator, ensure there is a consistent Agency-wide adoption of the Capability Leadership Model. Reinforce with the Mission Directorates, Programs and Projects the utilization of the CLT structure in place. Tailor communication with specific expectations. This forward work requires the Mission Directorates, as well as Program/Project management, to initiate engagement and enable communication forums with CLTs.
  - Assess Pathways implementation at each Center and leverage best practices in consultation with Engineering Directors' for engineering leadership's needs.
  - Establish a team with the Capability Portfolio Managers to evaluate other CLT facilities and bring forward a prioritized recommendation on facilities significantly benefitting from a rate-based approach.
- 2. The Aerospace Corporation will conduct an external pilot assessment, starting with a study of the following capability areas: guidance, navigation and control (GN&C); sensors and instruments; electrical power; materials; and mechanical systems. The results of this study will be presented at the March 2018 APMC.
- SMD will further evaluate the proposed NExSS, a cross-discipline approach to research, to determine
  if a new research capability should be established. The results will be presented at the March 2018
  APMC.
- 4. Capability Leadership Model Cadence for 2018:
  - <u>Baseline</u>: cryogenics (OCE); autonomous systems (STMD); environmental control & life support systems (HEOMD).
  - <u>Re-baseline</u>: aerosciences, avionics, electric power, materials, non-destructive evaluation, propulsion (OCE); EDL (STMD); ISRU (HEOMD); Earth science research (SMD); life sciences research (HEOMD); aircraft operations (MSD); mission operations.
  - <u>Executive Summaries</u>: rendezvous & docking (STMD); flight mechanics, GN&C, human factors, life support/active thermal, loads & dynamics, mechanical systems, passive thermal, sensors & instruments (OCE); heliophysics research, astrophysics research, planetary research (SMD).
