### PPBE20 Budget: OMB Messaging and Approval to Submit

**Summary:** The Executive Council (EC) met on August 24, 2018 to review the PPBE20 budget submission language, align budget messaging, confirm budget action closure, and provide approval for budget submission to OMB.


- Strategic planning to implement Space Policy Directive 1 (SPD-1), and other external policy guidance, was completed with the new Administrator in June, through a series of SIP meetings.
- Budget briefs were conducted in the Senior Management Council (SMC) on June 26-27<sup>th</sup>, and budget Issues were distributed to SMC members for comment on options.
- Budget issues were decided by the EC on July 30<sup>th</sup>. Informed by SMC member comments, the EC provided direction on arrangement of budget content within out-year budget projections under strict and inflation-adjusted interpretations of OMB guidance, and consistent with external policy direction and Administration priorities.

The EC made its decision after consultation with budget Control Account Managers and the Office of Legislative and Interagency Affairs, during the meeting.

#### Decision:

The EC approves the overall messaging approach for the PPBE20 budget submit, and approves submission to OMB, contingent on: (1) incorporation of changes requested at the meeting, and (2) the outcomes of a meeting to be scheduled for next week on content of the lunar surface wedge.

Additional EC or Administrator approval is not required prior to submission.


