SUBJECT: FOIA CASE DON-NAVY-2020-007231

This letter is in response to your request under the Freedom of Information Act (FOIA), assigned tracking number DON-NAVY-2020-007231, dated April 8, 2020, for information pertaining to: *"a copy of records, electronic or otherwise, of all records pertaining to the addition of three Unidentified Aerial Phenomena/UAP videos titled FLIR1, Gimbal and GoFast posted on the NAVAIR FOIA website. I am seeking a copy of all records pertaining to the decision, and action, of adding these videos. This includes but would not be limited to: 1. All letters/emails/memos etc. to/from all parties involved in the review of the videos. 2. All reports/investigative material involved in the review of the videos for potential public release. 3. All letters/emails/memos etc. pertaining to the videos being added to the NAVAIR website and the decision to do so (and why)."*

The following responsive documents are provided: Four emails totaling 34 pages titled "Email 1, 2, 3, and 18". My review included consideration of the "foreseeable harm standard", therefore portions of the documents have been withheld under the following FOIA Exemptions:

Exemption (b)(5) (5 U.S.C. § 552 (b)(5)) ***Deliberative Process Privilege*** - protects information to prevent injury to the quality of agency decisions. Includes internal advice, recommendations, or subjective evaluations pertaining to the decision-making process of the Agency and ***Attorney Client Privilege*** - confidential communication between an attorney and his client relating to a legal matter for which the client has sought professional advice. Moreover, although it fundamentally applies to facts divulged by a client to his attorney, this privilege also encompasses any *opinions* given by an attorney to his client based upon, and thus reflecting, those facts, as well as communications between attorneys that reflect client-supplied information.

Exemption (b)(6) (5 U.S.C. § 552 (b)(6)) protects personal information which if disclosed would result in an unwarranted invasion of personal privacy.

I have also withheld *fifty-nine emails and three legal memos, totaling 498 pages* in their entirety under the following FOIA Exemptions:

Exemption (b)(5) (5 U.S.C. § 552 (b)(5)) **Deliberative Process Privilege** - protects information to prevent injury to the quality of agency decisions. Includes internal advice, recommendations, or subjective evaluations pertaining to the decision-making process of the Agency and **Attorney Client Privilege** - confidential communications between an attorney and his client relating to a legal matter for which the client has sought professional advice. Moreover, although it fundamentally applies to facts divulged by a client to his attorney, this privilege also encompasses any *opinions* given by an attorney to his client based upon, and thus reflecting, those facts, as well as communications between attorneys that reflect client-supplied information.

Exemption (b)(6) (5 U.S.C. § 552 (b)(6)) protects personal information which if disclosed would result in an unwarranted invasion of personal privacy.

Please make note that *seven documents totaling 151 pages* responsive to your request required review with Office of the Secretary of Defense (OSD). These documents have been sent to their FOIA coordinator for review and direct response to you. There are no fees associated with the processing of your request in this instance.

Under 32 *CFR* §286.11, you have the right to an appeal. It must be received (i.e., post-marked if by mail or submitted online) within 90 calendar days from the date of this letter. Please provide the appellate authority (see below) the following in an envelope marked “FOIA Appeal”:

- a letter requesting an appeal that explains what you are appealing with any supporting arguments or reasons you think may be worthy of consideration;
- a copy of your initial request;
- a copy of this letter.
