## SUBJECT: FREEDOM OF INFORMATION ACT CASE DON-NAVY-2020-006828

This responds to your Freedom of Information Act (FOIA) request of April 17, 2020 in which you seek: "I respectfully request a copy of records, electronic or otherwise, of the following: 1) All communications, e-mails, letters, memos, internal communications, notes etc. regarding AFOSI investigation case #3290517356125. Although this is an AFOSI investigation, in it, it states that the Division Head, Naval Air Warfare Center - Aircraft Division, Naval Air Station Patuxent River, MD was contacted. There was analysis on three videos which they determined there was "no sensitive symbology or other items of concern." I am seeking all records pertaining to this, which would include, but not be limited to, memos, emails, letters, reports, notes, etc."

Enclosed is a copy of "All communications, e-mails, letters, memos, internal communications, notes etc. regarding AFOSI investigation case #3290517356125". We have considered the foreseeable harm standard when reviewing records and applying FOIA exemptions. Portions of the documents have been withheld under the following FOIA Exemptions:

**Exemption (b)(5)** (5 U.S.C. § 552 (b)(5)) protects information which includes internal advice, recommendations, or subjective evaluations pertaining to the decision-making process of the Agency.

**Exemption (b)(6)** (5 U.S.C. § 552 (b)(6)) protects personal information which if disclosed would result in an unwarranted invasion of personal privacy.

We have withheld one internal communication document in its entirety under the following FOIA Exemption:

**Exemption (b)(5)** (5 U.S.C. § 552 (b)(5)) protects information which includes internal advice, recommendations, or subjective evaluations pertaining to the decision-making process of the Agency.

There are no fees associated with the processing of your request in this instance.

There are two ways to file an appeal: through FOIAonline or by mail.

- <u>Through FOIAonline</u>. This will work only if you set up an account on FOIAonline before you make the request that you would like to appeal. To set up an account, go to FOIAonline (this is a website that will appear as the top hit if you search the internet for "FOIAonline"), click "Create Account" (a link located within the blue banner at the top in the upper right corner), enter your data into the field that subsequently appears, and click "Save" (at the bottom left of the screen). With your account thereby created, you will have the power to file an appeal on FOIAonline to any request you file on FOIAonline thereafter. To do so, locate your request (enter a keyword or the request tracking number in the "Search for" field on the "Search" tab), click on it, then the "Create Appeal" tab in the left-hand column. Complete the subsequent field, click "Save," and FOIAonline will submit your appeal.






