SUBJECT: FREEDOM OF INFORMATION ACT REQUEST CASE NUMBER DON-NAVY-2021-005381

This letter is in response to your Freedom of Information Act (FOIA) request submitted to this office on April 9, 2021, in which you requested: "all deck logs from USS RUSSELL (DDG 59) for the month of July 2019 and all reports, memos, letters, emails, videos pertaining to the USS RUSSELL (DDG 59) encountering unknown drones while operating of the coast of San Diego in July 2019." Your request was received on April 14, 2021, with assigned case number DON-NAVY-2021-005381 and assigned internal tracking number 2021-55.

Your request was processed in accordance with the Freedom of Information Act (5 U.S.C. § 552), Part 701 of Title 32 of the Code of Federal Regulations, and the Department of the Navy Freedom of Information Act Program (SECNAVINST 5720.42G).

For the purpose of assessing FOIA processing fees, you have been categorized as a "media" requester, and as such, only duplication fees are applicable to your request. In this instance, there are no fee charges for the processing of your request by this office.

Commander, Carrier Strike Group NINE, USS RUSSELL (DDG 59) and Naval History and Heritage Command (NNHC) conducted a thorough search of their spaces and provided responsive records for processing. Our review of the responsive records reveal that they contain personal identifiers of third parties (such as names and/or social security numbers), release of which would constitute an unwarranted invasion of personal privacy. Further, portion of the responsive material contains technical data with military or space application in the possession of, or under the control of, the Department of Defense. Pursuant to the provisions of FOIA, 5 U.S.C. § 552 (b)(6) and (b)(3) 10 U.S.C. § 130, your request must be partially denied in order to withhold this information.

You have the right to appeal if you are not satisfied with this response. It must be received within **90 calendar days** from the date of this letter. Please provide a letter requesting an appeal, with a copy of your initial request and a copy of the letter of denial, in an envelope marked "Freedom of Information Act Appeal" or "Appeal of Records."

You are encouraged (though not required) to provide an explanation why you believe the redactions were inappropriate or our search was inadequate. You may file your appeal by one of the two methods below:

1. <u>FOIA Online</u>: This will work only if you set up an account on FOIA Online before you make the request that you would like to appeal. To set up an account, go to FOIA Online (www.foiaonline.gov), and click "Create Account" (a link located within the blue banner at the top in the upper right corner). Enter your data into the field that subsequently appears and click "Save" (at the bottom left of the screen). With your account, you will have the ability to file an appeal on FOIA Online to any request you submit on FOIA Online. To submit your appeal, navigate to the "Search" tab and click on the "Search For" field. Enter your request tracking number or a keyword. When the request is populated, locate the "Create Appeal" tab on the left side of the screen. Complete the fields and "Save" and the system will automatically submit your appeal.




