This is in response to your 19 March 2023 Freedom of Information Act (FOIA) request, originally submitted by you to the National Archives and Records Administration, for "A copy of ALL Records Management Self-Assessment (RMSA) reports submitted to NARA for the past 5 years." Four documents found to be responsive to your request were received in the National Reconnaissance Office (NRO) by way of referral on 21 April 2023.

We have processed the referred documents in accordance with the FOIA, 5 U.S.C. § 552, as amended and these four documents are being released to you in part.

Material withheld from release is denied pursuant to FOIA exemption:

(b) (3), which is the basis for withholding information exempt from disclosure by statute. The relevant withholding statute is 10 U.S.C. § 424, which provides (except as required by the President or for information provided to Congress), that no provision of law shall be construed to require the disclosure of the organization or any function of the NRO; the number of persons employed by or assigned or detailed to the NRO; or the name or official title, occupational series, grade, or salary of any such person.

You have the right to appeal this determination to the NRO Appellate Authority, 14675 Lee Road, Chantilly, VA 20151-1715, within 90 days of the above date.
