Dear John Greenewald:

This responds to your Freedom of Information Act (FOIA) request of 5 August 2014 for "a copy of all complaints submitted to the NSA about the NSA cafeteria. Please include all correspondence relating to this complaint (which would include internal agency communications, emails, memos, etc.) for the calendar year of 2013." A copy of your request is enclosed. Your request has been processed under the FOIA and the documents are enclosed. Certain information, however, has been deleted from the enclosures.

In our previous letter, dated 10 July 2015, we informed you that material responsive to your request was located in a prior request, FOIA Case Number 78604, and was awaiting review. We have completed our review of the material in that case and it is enclosed.

This Agency is authorized by various statutes to protect certain information concerning its activities. We have determined that such information exists in these documents. Accordingly, those portions are exempt from disclosure pursuant to the third exemption of the FOIA, which provides for the withholding of information specifically protected from disclosure by statute. The specific statutes applicable in this case are Section 6, Public Law 86-36 (50 U.S. Code 3605).

Since these deletions may be construed as a partial denial of your request, you are hereby advised of this Agency's appeal procedures.

You may appeal this decision. If you decide to appeal, you should do so in the manner outlined below. NSA will endeavor to respond within 20 working days of receiving any appeal, absent any unusual circumstances.

chart which is used to calculate the 6% sales tax. Since the chart provides for a range 16 cents on a taxable
sale, the % of tax applied will not always equate to a 6% charge. (E.G. a sale between \$2.01 and \$2.16 will
result in small fractions to variance from the 6% rate. The complainant note their tax charged on their
cafeteria bill equalled 6.15 %, which would be typical difference for charge a customer incurs when using a tax
charge that allows for a 16 cent difference that charges 6% for all charges within that 16 cent range




