Dear Mr. Greenewald:

This responds to your request of 5 February 2019 to have "NSA COMINT REPORT: Capital Projects Planned for India, 31 Aug 1972" reviewed for declassification. The material has been reviewed under the Mandatory Declassification Review (MDR) requirements of Executive Order (E.O.) 13526 and is enclosed.

We have determined that some of the information in the material continues to require protection. The portions deleted from the document were found to be currently and properly classified in accordance with E.O. 13526. The information denied meets the criteria for classification as set forth in Section 1.4 subparagraph (c) and remains classified TOP SECRET and SECRET as provided in Section 1.2 of E.O. 13526. The withheld information is exempt from automatic declassification in accordance with Section 3.3(b)(3) of the Executive Order.

In addition, Section 3.5 (c) of E.O. 13526, allows for the protection afforded to information under the provisions of law. Therefore, information that would reveal NSA functions and activities has been protected in accordance with Section 6, Public Law 86-36 (50 U.S. Code 3605, formerly 50 U.S. Code 402 note).

Since your request for declassification has been denied you are hereby advised of this Agency's appeal procedures. Any person denied access to information may file an appeal to the NSA MDR Appeal Authority. The appeal must be postmarked no later than 60 calendar days after the date of the denial letter. The appeal shall be in writing addressed to the NSA MDR Appeal Authority (P133), National Security Agency, 9800 Savage Road, STE 6881, Fort George G. Meade, MD 20755-6881. The appeal shall reference the initial denial of access and shall contain, in sufficient detail and particularity, the grounds upon which the requester believes the release of information is required. The NSA MDR Appeal Authority will endeavor to respond to the appeal within 60 working days after receipt of the appeal.

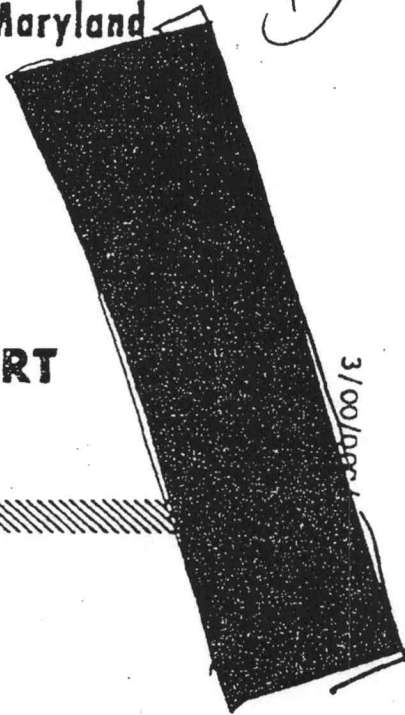

CAPITAL PROJECTS PLANNED IN INDIA

Portions of this report, as indicated, are classified ~~TOP SECRET UMBRA~~; the remainder is classified ~~SECRET NOBAY~~ (OO/10536-72).

In June and July 1972, Indian capital projects and major equipment imports included plans for two atomic energy projects, telecommunications, electronics, two argon plants and an air plant, a bearing rings plant, copper refining, detonators, fishing vessels, an oil refinery, and other projects.

Atomic Energy Project

France is to supply financing for an Indian atomic energy project. The Banque National de Paris, on 22 June reported that it had been asked to set up a credit agreement, on the terms of the French-Indian Protocol of 20 March 1972, to finance an Indian atomic energy project. The credit was to amount to 35 million frs (ca. \$6,839,000). Furthermore, the bank's client, Les Pompes Guinard, was being asked by the Department of Atomic Energy, Bombay, to supply nuclear pumps worth about 7 million frs. (ca. \$1,367,800) for the Madras Atomic power project. The Paris bank asked its New Delhi office to find out whether the pump order was to be charged to some portion of the credit and/or whether the Indian authorities planned a special atomic energy program valued at 35 million frs.

Atomic Power Project

Sweden is supplying material for the Madras Atomic Power Project. On 12 July, QUALITEST, Orsay, France, told Rajasthan Atomic Power Project (RAPOWER), Bombay, that material manufactured in Sweden for the Madras Atomic Power Project [redacted]

[redacted] had been packed and would be shipped within a short time.

UHF Link For Pipeline

The Indian Oil Corporation plans the construction of a UHF radio relay running from Haldia to Barauni to Kanpur in connection with one of its pipelines. [redacted]

Offers were due on 31 July.

As a result, Bharat Forge must speed up an already planned ring-rolling project and, because the Indian Government denied it a machinery import license due to lack of foreign exchange, the firm is also forced to build its own ring rolling machine.
