Dear Mr. Greenewald:

This is a final response to your May 3, 2021 Freedom of Information Act (FOIA) request, a copy of which is enclosed for your convenience. We received your request on May 3, 2021, and assigned it FOIA case number 21-F-0946. We ask that you use this number when referring to your request.

The Public Affairs, a component of the Office of the Secretary of Defense, conducted a search of their records systems and located 76 pages determined to be responsive to your request. Ms. Tanya R. Rose, Information Management Director, in her capacity as an Initial Denial Authority for Public Affairs, has determined that portions of the 76 responsive pages are exempt from release pursuant to 5 U.S.C. § 552 (b)(6), as disclosure of the information would constitute a clearly unwarranted invasion of the personal privacy of individuals.

In this instance, fees for processing your request were below the threshold for requiring payment. Please note that fees may be assessed on future requests.

SUBJECT: Letter of Resignation & Differed Retirement

Mr. Secretary;

It has been my sincere honor and pleasure to have served with some of America's finest men and women in both peace time and in war. For over 22 years, I have been blessed to learn from, and work with world-class leadership, you certainly being among the very best.

With that in mind, bureaucratic challenges and inflexible mindsets continue to plague the Department at all levels. This is particularly true regarding the controversial topic of anomalous aerospace threats. Despite overwhelming evidence at both the unclassified and classified levels, certain individuals in the Department remain staunchly opposed to further research on what could be a tactical threat to our pilots, sailors, and soldiers, and perhaps even an existential threat to our national security. In many instances, there seems to be a direct correlation the phenomena exhibits with respect to our nuclear and military capabilities. The Department must take serious the many accounts by the Navy and other Services of unusual aerial systems interfering with military weapon platforms and displaying beyond next generation capabilities. Underestimating or ignoring these potential threats is not in the best interest of the Department no matter the level of political contention. There remains a vital need to ascertain capability and intent of these phenomena for the benefit of the armed forces and the nation.

For this reason, effective 4 October 2017, I humbly submit my resignation in hopes it will encourage you to ask the hard questions: "who else knows?", what are their capabilities?", and "why aren't we spending more time and effort on the issue?". As I transition to a new chapter of my life, please know it has been an honor and privilege of a lifetime to serve with you. Rest assure, no matter where the path of life may lead me, I will always have the best interest of the Department and the American people as my guiding principle.

I sent this follow-up question on May 6th:

I need you to clarify this statement:

Mr. Elizondo had no responsibilities with regard to the AATIP program while he worked in OUSDI, up until the time he resigned effective 10/4/2017

Does this mean Mr. Elizondo never had ANYTHING to do with AATIP at ANY time?

Elizondo's PR firm released this statement to me:

"There is ample, formal documentation on AATIP and the fact that it specifically involved Mr. Luis Elizondo while he was assigned to the Office of the Under Secretary of Defense for Intelligence. This fact was substantiated by numerous reputable media outlets including the New York Times, Washington Post, and Politico, through independent sources."

And this is NOT part of the statement, just an FYI for you. This ran in Politico in Dec 2017: "Pentagon spokeswoman Dana White confirmed to POLITICO that the program existed and was run by Elizondo. But she could not say how long he was in charge of it and declined to answer detailed questions about the office or its work, citing concerns about the closely held nature of the program."

Is there anyway to get a response to my follow-up question above and a statement on claims made by Mr. Elizondo's representatives?

I need you to clarify this statement:

Mr. Elizondo had no responsibilities with regard to the AATIP program while he worked in OUSDI, up until the time he resigned effective 10/4/2017

Does this mean Mr. Elizondo never had ANYTHING to do with AATIP at ANY time?

Elizondo's PR firm released this statement to me:

"There is ample, formal documentation on AATIP and the fact that it specifically involved Mr. Luis Elizondo while he was assigned to the Office of the Under Secretary of Defense for Intelligence. This fact was substantiated by numerous reputable media outlets including the New York Times, Washington Post, and Politico, through independent sources."

And this is NOT part of the statement, just an FYI for you. This ran in Politico in Dec 2017: "Pentagon spokeswoman Dana White confirmed to POLITICO that the program existed and was run by Elizondo. But she could not say how long he was in charge of it and declined to answer detailed questions about the office or its work, citing concerns about the closely held nature of the program."



Hello, Steven,

I got your voicemail, too, so I know your request has to do with what I provided to John Greenewald.

Regarding Luis Elizondo and AATIP:

While in OUSD(I), Luis Elizondo did not have any assigned responsibilities for AATIP. The Defense Intelligence Agency ran AATIP. Elizondo was neither assigned nor detailed to DIA.

[The below was provided in response to a question about the difference between AATIP and AAWSAP and whether either were UAP related.]

Neither AATIP nor AAWSAP were UAP related. The purpose of AATIP was to investigate foreign advanced aerospace weapons system applications with future technology projections over the next 40 years, and to create a center of expertise on advanced aerospace technologies. The goal was to help understand the threat posed by unconventional or leap ahead aerospace vehicles/technologies that could have national security implications for the United States. The AAWSAP contract goal was to study 12 technical areas: lift, propulsion, control, armament, signatures reduction, materials, configuration, power generation, temporal translation, human effects, human interface, and technology integration.

[The below was provided in response to a follow-up question to the above response, asking for clarification due to comment that Christopher Sherwood had told the NY Post in May]

At the time, Mr. Sherwood was repeating the information that had been provided by a previous spokesperson some two years earlier. That previous spokesperson is no longer with my organization, and I cannot comment on why that person's explanation of AATIP included that it had looked at anomalous events. According to all the official information I have now, when implemented, AATIP did not pursue research and investigation into unidentified aerial phenomena; that was not part of the technical studies nor the reports produced by the program.



I got your voicemail, too, so I know your request has to do with what I provided to John Greenewald.

Regarding Luis Elizondo and AATIP:

While in OUSD(I), Luis Elizondo did not have any assigned responsibilities for AATIP. The Defense Intelligence Agency ran AATIP. Elizondo was neither assigned nor detailed to DIA.

[The below was provided in response to a question about the difference between AATIP and AAWSAP and whether either were UAP related.]

Neither AATIP nor AAWSAP were UAP related. The purpose of AATIP was to investigate foreign advanced aerospace weapons system applications with future technology projections over the next 40 years, and to create a center of expertise on advanced aerospace technologies. The goal was to help understand the threat posed by unconventional or leap ahead aerospace vehicles/technologies that could have national security implications for the United States. The AAWSAP contract goal was to study 12 technical areas: lift, propulsion, control, armament, signatures reduction, materials, configuration, power generation, temporal translation, human effects, human interface, and technology integration.

[The below was provided in response to a follow-up question to the above response, asking for clarification due to comment that Christopher Sherwood had told the NY Post in May]

At the time, Mr. Sherwood was repeating the information that had been provided by a previous spokesperson some two years earlier. That previous spokesperson is no longer with my organization, and I cannot comment on why that person's explanation of AATIP included that it had looked at anomalous events. According to all the official information I have now, when implemented, AATIP did not pursue research and investigation into unidentified aerial phenomena; that was not part of the technical studies nor the reports produced by the program.

"The AATIP program did pursue research and investigation into unidentified aerial phenomena."

Susan Gough gave this statement (in part) to John Greenewald at The Black Vault:

"According to all the official information I have now, when implemented, AATIP did not pursue research and investigation into unidentified aerial phenomena"

She gave this reason for why your original statement back in May was wrong:

"At the time, Mr. Sherwood was repeating the information that had been provided by a previous spokesperson some two years earlier," said Gough. "That previous spokesperson is no longer with my organization, and I cannot comment on why that person's explanation of AATIP included that it had looked at anomalous events."

Did you give me inaccurate/wrong information? If so, why? And, if so, how would you explain you getting the wrong information?
