Dear Mr. Greenewald:

This is a final response to your February 11, 2023 Freedom of Information Act (FOIA) request to the Office of the Inspector General (OIG), a copy of which is enclosed for your convenience. The Office of the Secretary of Defense/Joint Staff (OSD/JS) FOIA Requester Service Center received your request on March 18, 2025, and assigned it FOIA case number 25-F-2554. We ask that you use this number when referring to your request.

The All-domain Anomaly Resolution Office (AARO), Office of General Counsel (OGC), and the Office of the Assistant to the Secretary of Defense for Public Affairs (OATSD(PA)), components of OSD, and the United States Navy (Navy), conducted a review of 78 responsive pages referred by OIG. Mr. Paul Plescow, Senior Intelligence Officer, AARO; Mr. David Bennett, Director, OIC, OGC; Ms. April Holt, FOIA Program Manager, OATSD(PA); and Mr. Richard Strong, Director, Navy FOIA/PA Program Office; in their capacity as Initial Denial Authorities, have determined that portions of these records are exempt from mandatory disclosure pursuant to 5 U.S.C. § 552:

(b)(5), inter- and intra- agency memoranda which are deliberative in nature; this exemption is appropriate for internal documents which are part of the decision making process, and contain subjective evaluations, opinions and recommendations;

(b)(6), information which, if disclosed, would constitute a clearly unwarranted invasion of the personal privacy of individuals; and

(b)(7)(C), law enforcement records or information that could reasonably be expected to constitute an unwarranted invasion of personal privacy.

Please note that we have considered the foreseeable harm standard when reviewing records and applying exemptions under the FOIA in the processing of this request.

During our review of the records, we were advised that the U.S. Army (USA) would have cognizance over 61 pages, as described above. We have referred your FOIA request and the 61 pages to USA for direct response to you. For your convenience, contact information for the USA FOIA office is provided below:

Hi (b)(6)

I am reaching out in a final effort to avoid seeing this unfortunate situation escalate. As a soldier and public servant with decades of unblemished service, these false accusations are personally painful as you can well imagine. Moreover, the clearly inaccurate information released by your office has the potential to profoundly damage my career and with it my ability to provide for my wife and family.

In that regard, attached you will find a sample of unclassified correspondence that clearly demonstrates how active I remained on the UAP issue right up until my departure, to include interagency coordination with the IC on this important issue and operational collaboration with the US Navy. The transition plans referenced herein were briefed to and approved by a senior political appointee who reported directly to General Mattis. Some of the F-18 pilots and Navy officials can confirm multiple briefings and discussions with this individual and others, to include Congress. Some of these discussions and briefings actually occurred inside the SecDef's personal office suite. That is why my emails reference "the front office."

Officials from other agencies and departments (ie DIA and CIA) attended meetings I held to coordinate activities on this topic in support of the men and women in the US Navy, who as you know were and still are deeply perplexed and concerned by this phenomenon. AATIP was an official program that was never shut down, when the funding dried-up I continued to lead and interact with officials in DoD and other agencies to the best of my ability in the interest of national security. When I departed, as is clear from my resignation letter, it was purely out of frustration with my ability to gain additional traction and support. But I put my shoulder to the wheel all those years and worked diligently to maintain a focus on the AATIP issue and continued to coordinate and promote collection and analysis. Call it an "activity" vs a "program" if you will, but if this escalates it will be easy to prove how active I remained in support of our men and women in uniform, especially in the US Navy. If some who were not privy to my actions want to portray me as a rogue, well bad on them for sitting on their hands and doing nothing about recurring intrusions into US airspace and military operating areas and good on me for continuing to risk my reputation and career in support of the US Navy and the nation. Personally, it is outrageous so many others did so little in the face of what the Navy now publicly acknowledges is serious national security issue. The plain truth is that I did everything I could to maintain focus and attention on this vital issue when so many others continued to sweep it under the rug purely for fear of the stigma and possible impact on their reputations. And for that the department wants to make me out to be the bad guy? An imposter? For showing initiative and support to the Navy and others? For keeping this effort going as best I could -- an effort now fully vindicated by the Navy itself?

As you can well imagine, I am not only hurt and disappointed but angry. I should if anything be getting accolades for persistence and initiative, especially since the Navy has now publicly acknowledged the seriousness of the issue, something that only occurred because of my efforts. Instead, a knife in the back? Wow, thanks guys! If the department wants to have this out in public we can certainly do so. I can easily establish that Neil took the meetings referenced in these emails and that this plan was blessed by an individual who has departed but was at the time a senior Administration appointee and directly reported to General Mattis. Do you honestly think I

made up the stuff in these emails? Really? Check Neil's calendars and you will see these meetings occurred (as well as innumerable other meetings on my calendars).

I am providing these documents to you to afford you and the Department a final opportunity to correct the record. Meanwhile, I am being pushed into a corner as you can well imagine and will soon be forced to engage an attorney and respond. The oversight committees are also well aware of my role and I believe appreciative of my efforts.

In conclusion, it seems clear to me and others that there exists an extreme miscommunication among OUSDI staff. I truly hope we can resolve this amicably.

What a sad statement it is that instead of being rewarded for my initiative and persistence, for diligently pursuing an issue so many others were willing to duck, some in the department are instead trying to destroy my career and reputation by sowing disinformation. To reiterate, I was an OUSDI staff member while working with the AATIP portfolio up until the point of my departure. This was previously verified by the DoD Press Secretary in 2017. Check Neil's calendar and you will be able to confirm these meetings occurred -- a small sample of the total number of meetings I was having on a weekly and near daily basis at the time.

I know that you are trying to be a fair and honest broker. I hope you will therefore take this letter in the spirit of a former colleague merely seeking to set the record straight.

Please advise receipt of this communication if you would at your earliest convenience. I am holding off media requests and will continue to do so until I hear from you. As you can imagine, the pressure is growing.

Good afternoon, all. Your questions below pertain to the issues I raised in earlier emails regarding the distinctions we must make between past programs and the normal, day-to-day coordination/facilitation work of the DoD and, in particular, the OUSDI. Mr. Elizondo did play a role in facilitating connections and introductions to other DoD elements that were working CI/safety issues similar to those encountered by Navy. There were no funding lines associated with this work or significant resources expended, and nothing out of the ordinary regarding business practice. The "work" was similar to the daily travails of all of us in the Pentagon-- office and small group meetings, advice, and correspondences largely related to the same. In this regard, Mr. Elizondo was very useful. Though a colorful personality to be sure, I think Neill would agree that Mr. Elizondo maintained a solid reputation up until he made a sudden, shocking departure in October 2017.

As always, I am happy to discuss details in person or on another network.

As for your particular questions below--

- 1) I am aware of office discussions that occurred at the request of OSD leadership. I escorted the pilots myself.
- 2) (b)(6) covered this below, and Jay is copied on this message. Jay is an Office of Naval Intelligence Defense Intelligence Senior Leader (DISL).
- 3) I think you characterize the confusion accurately. The differences of perspective/opinion may arise from semantics/terminology regarding "programs" or "projects". The statement from earlier is germane--

"The DoD is always concerned about maintaining positive identification of all aircraft in our operating environments as well as identifying any foreign capability that may be a threat to the homeland. DoD will continue to investigate, through normal procedures, reports of unidentified aircraft encountered by US military aviators in order to ensure defense of the homeland and protection against strategic surprise by our nation's adversaries."

Gentlemen,

Both Luis Elizondo himself and former DASD Chris Mellon have contacted our office because they believe the statements that we've put out regarding AATIP and particularly Elizondo's role in it, are false (and Elizondo is threatening to sue). Per the information we've received from DIA and OUSD(1), Elizondo was briefly supporting the DIA office that managed the AATIP program, but after early 2010, while in OUSD(1), he had no responsibilities for AATIP. Elizondo claims he continued working on AATIP/UAPs until he resigned in 2017. He claims that J. Stratton in Navy knew of the program/his involvement, and that then-SECDEF Mattis and/or his front office was briefed on the program, and that two Navy pilots briefed the SECDEF/his front office on "what they saw."

First, are you aware of any briefings on UAPs/AATIP to then-SECDEF Mattis' front office in general, and in particular, do have any knowledge/reports/documentation that two Navy pilots briefed the SECDEF front office on any UAP incidents in the 2016-2017 time frame?

Second, do you know who J. Stratton is? Does he still work for Navy (perhaps somewhere in the SECNAV/secretariat side, rather than the military side of Navy)? Did he previously/does he still have anything to do with UAPs?

Third. There is confusion -- probably as a result of semantics/terminology -- over whether the program "ended" or was "transitioned." By the best information we've received, the formal AATIP program last received funding in the FY2010 NDAA, and those funds ran out, with the completion of the final 12 of 38 technical studies, in 2012. From the overall DoD perspective, that was the end of AATIP as a program. However, I'm beginning to think what happened is that some office in either OSD and/or Navy (e.g., N2N6) continued to track/monitor UAP incidents -- but not as an official program, just as a mission/function/duty of an office, with no funding line, and certainly not as "AATIP." I think that is what Elizondo is referring to when he claims that he continued to work with/in AATIP until 2017. Can you shed any light on that?

Attached are a two examples of the documentation Lue may feel compelled to release if there is not a clarification of his continuing active role in coordinating activities with Navy and other agencies related to UAP issues right up until his departure and resignation from OSD.

Frankly, it might well be to Lue's benefit and that of TTSA and the History Channel to have a pissing match about this with DoD/OSD but personally I'd hate to see that. I'm glad that does not seem to have occurred to Lue yet but it may become unavoidable if there is not some clarification since his integrity is publicly being called into question.

I also want to point out that Lue insists that he was NOT detailed to DIA, another falsehood according to Lue.

I know your office and its credo very well and fully understand that you and your colleagues are absolutely committed to being as transparent as possible. There is not the least question in my mind regarding your integrity or that of your colleagues in OSD Public Affairs based on serving in OSD during 2 Administrations. However, you have clearly have not been given a full or complete picture on this issue.

I hope this information proves useful. There is much more than this sample. Lue has a lot of friends on the inside who I believe will continue to push out more unclassified information on his behalf if this becomes a pissing match. Indeed one of them will soon be appearing on the History Channel show talking about their work with Lue on these matters AFTER the time period you seem to believe he was no longer involved with AATIP (although that individuals identify is protected).

I hope this information proves useful. Please do not hesitate to contact me if I can be of further assistance.

Lue cherishes his relationship with DoD and does not want to escalate this but as you can imagine after the intercept story by Kloor pressure is building on him to respond.

In my view it is probably best for you to continue this discussion directly with Lue going forward; it is not really my affair, but I did want to give you a head's up as I can see where this may be heading and it seems to me to be preferable to avert a public clash over this if possible.
