The pentagon shaped light areas on the upper right quarter of the space photograph pictured on the cover of the August 5, 1966 issue of Life Magazine are images of the diaphragm of the lens used in making the picture. Your photograph of an unidentified flying object (Chicago Daily News; August 3, 1966; page 50) shows striking similarity.

Did Flying Pentagon Check On Gemini 10 Astronauts?

Did the Gemini 10 astronauts see flying saucers out in space and neglect to report them?

Astronauts John W. Young and Michael Collins brought back photographic evidence that seems to show the same kind of unidentified flying objects in space that earthbound people spotted last week near Erie, Pa.

THE ODD THING is that the objects don't seem to be round, the usual shape of flying saucers.

They look more like the home plate on a baseball diamond—or perhaps like the five-sided Pentagon building in Washington, D. C. (Some military significance?)

The mystery shapes showed up in the space pictures. But no one got excited. Life magazine attempted to explain them away by calling the geometric patches light distortions from the spacecraft window and camera lens.

BUT THEN last week a flying saucer was reported near Erie, Pa. With the story The Daily News ran a photo captioned: "It Looked Like This."

One sharp-eyed reader, G. F. Riegler of 848 Riverview Terrace, spotted the similarity. He compared the astronauts' photo on the Life magazine cover and the News' picture, and asked: "Coincidence?"

EITHER THOSE flying saucers are everywhere—or else perhaps they really are light distortions caused by the camera lens.

To test the latter theory, staff photographer Bill Koehler set up a camera with a spotlight aimed directly at the lens.

SURE ENOUGH, he got a picture of some mysterious, five-sided objects. He figures the shape is caused by the iris diaphragm—the little gadget that closes down when you take pictures in bright light—which lets the light through a tiny, five-sided hole.

Koehler figures the same thing could happen if the sun shines into the lens.

Well, there goes that Mardán theory.

How to get rid of those pesky little spaceships?

Flying Saucer No Hoax, Erie Police Chief Says

Girl Hysterical After Seeing 'It' On Presque Isle

ERIE, Pa., Aug. 3—"She could not have put this on as an act. That would be absolutely impossible. She was hysterical."

With these words Police Chief Dan Dasconio of Presque Isle State Park discounted any possibility that a dramatic flying saucer report near Erie was a hoax.

Dasconio said today he was sure "something" had been sighted by 16-year-old Betty Jean Klem of Jamestown, N. Y., and an 18-year-old male companion, Douglas Tibbets of Greenhurst, N. Y.

Others See It

They were among a carful of people who reportedly saw a "metallic, sort of silvery" object land between two trees on Presque Isle Peninsula Sunday.

A rash of other reports of unidentified flying objects (UFO's) followed the incident.

Two police officers in suburbs east of Erie reported seeing a bright light moving back and forth across the sky today from 4:45 to 6:55 p. m. One of the officers said the object

1:15 to 6:55 a. m. One of the officers said the object turned red, disappeared, reappeared and turned bluish.

Another unexplained bright object was reported moving across the sky at 2:30 a. m. by eight persons on a beach near Erie. One of the witnesses—Dennis Buckel of an Erie radio station—said they watched it for about 10 minutes during which period it changed direction several times.

Saw Another Day Before

Buckel said they also saw an orange-red object at about the same time and place the day before.

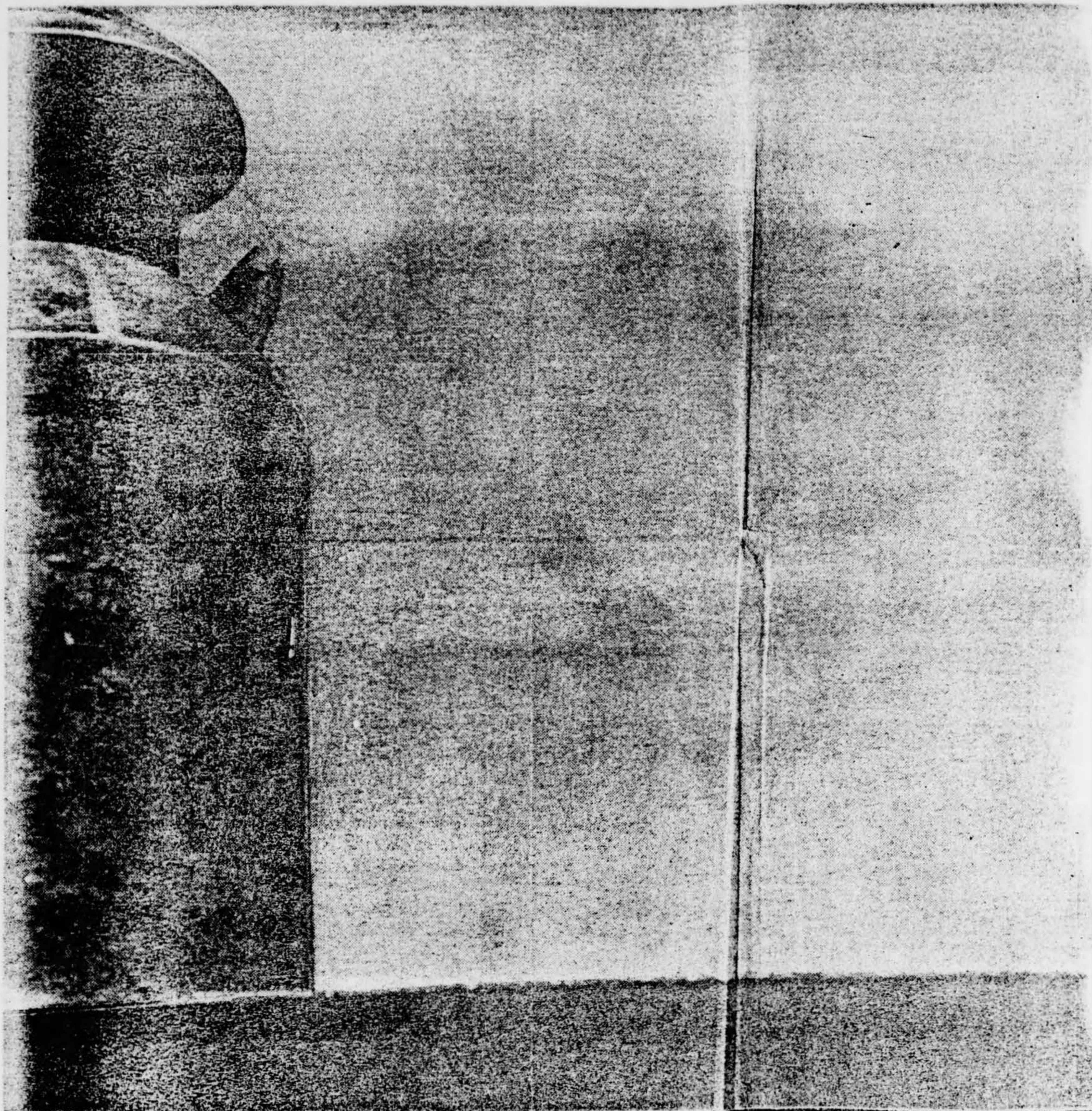
Spokesmen at Buhl Planetarium in Pittsburgh were unable to account for the sightings. Arthur Draper, Buhl's program director, ruled out the possibility of meteorites—a meteorite sighting never lasts as long as 10 minutes—or artificial satellites—satellites don't change direction. Weather balloons were also ruled out.

Meanwhile, there were these developments in the investigation of the original sighting by Miss Klem:

►Maj. William S. Hall, an Air Force investigator, ordered plaster molds made of imprints in the sand, allegedly produced by the legs of the UFO. The molds were sent to Wright-Patterson Air Force Base in Dayton.

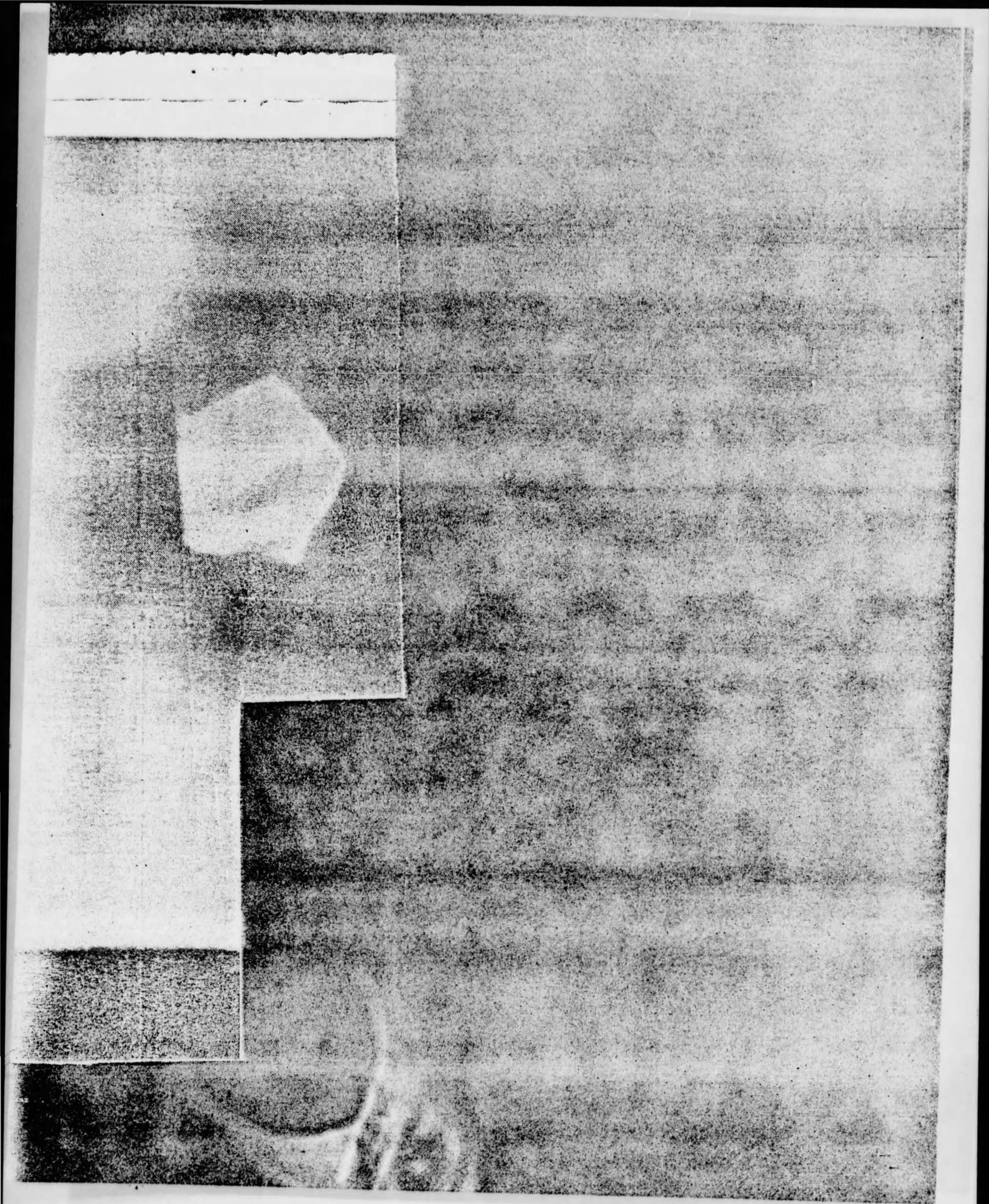
►An astronomy professor at Jamestown Community College, Dr. Marshall Martz, said he will interview Miss Klem. He is a member of the National Investigations Committee for Aerial Phenomena (NIICAP).

►Five other NIICAP members were investigating the report.

ERIE, Pa., Aug. 3—(AP)—Two Erie newsmen said they saw and photographed early today a bright object in the sky near where a young couple reported the landing of a mysterious object.

Dennis Buckel of Radio Station WJET said at about 2 a.m. he saw what looked like a bright

... he saw what looked like a bright star, but faster moving.

Another WJET news man, Jerry Trembley, said he saw the same object about two hours later and another strange cluster of flashing lights.

ON SUNDAY, Betty Jean Klem, 16, of Jamestown, N.Y., and Douglas Tibbets, 18, of Greenhurst, N.Y., said they saw a metallic, silvery object land near their car on beach No. 6 on Presque Isle State park, a curving peninsula jutting into Lake Erie.

Police said they found two triangular impressions in the sand, about six inches deep.

The teenagers' report attracted five members of the National Investigations committee on Aerial Phenomena and an official from the headquarters of Project Bluebook at Wright-Patterson Air Force Base.

POLICE CLOSED off the beach area.

The WJET newsmen came up with motion pictures of objects in the sky.

Said Trembley of the objects he saw:

"As we walked toward the spot where the original sighting took place we again noticed the movement of the same object or the same type of object in the sky, but this time it was more south than the original sighting."

He said a second object "had only red and green and white lights, but did not act like an ordinary plane. It came first towards us and then seemed to head away and climb higher in the sky."

GENERAL INFORMATION

HOURS OF OPERATION: The Park is open to the public the year around, weather and road conditions permitting. The park opens at 5 A.M. each day and closes at 9 P.M. from Labor Day to Memorial Day and at 12 midnight from Memorial Day to Labor Day. The Park Entrance Gate closes one hour before the above closing hours and all visitors must be out of the Park by closing time.

CONDUCT OF VISITORS: The atmosphere in the park is expected to be one of "wholesome recreation for the family". Visitors are expected to observe park rules and regulations and behave in accepted fashion. Intoxicating beverages are not permitted in the park.

FIRES: The prevention of forest fires is of utmost importance. Open fires are not permitted in the Park. Visitors are urged to bring own charcoal stoves. Please extinguish all charcoal before leaving. DO NOT DUMP HOT COALS ON THE GROUND.

TRAFFIC REGULATIONS: Traffic regulations are designed to insure the utmost of safety to park visitors. A 25 m.p.h. speed limit is enforced throughout the Park. Violations are prosecuted through the minor judiciary as required by law.

OVERNIGHT LODGING: There is no overnight lodging or camping on the Park premises. These accommodations may be obtained off the park at commercial establishments.

ACTIVITIES: The general rule is that ALL ACTIVITIES CEASE ONE HOUR AFTER SUNSET. The exceptions to this rule are that bathing ceases AT SUNSET and motoring through the Park is permitted until closing. Parking or stopping of motor vehicles during this period is not permitted.

PARKING: Please park cars in parking areas according to posted signs. Please do not park cars on firetrails or in prohibited zones. Illegally parked cars will be tagged by park police, and if public safety requires, they will be towed away at the expense of the owner. Parking of cars or stopping of cars is not permitted beyond one hour after sunset.

PICNICKING: Picnic tables are available in the

picnic areas. Please do not move tables from one area to another or use tables for wind shelters. Share tables on busy days. Good park manners call for a cleanup of the area after use and it is requested that picnickers either take rubbish home or deposit it in roadside refuse containers. A limited number of charcoal stoves are available in the picnic areas. DOUSE ALL HOT CHARCOAL FIRES WITH WATER BEFORE DUMPING! This prevents burns to bathers' feet. Picnicking on the bathing beaches is not permitted.

PETS AND ANIMALS: Dogs are permitted only when on a leash and at all times must be under the control of the owners. No dogs or pets are permitted on the bathing beaches.

BATHING: Bathing is permitted only in guarded areas when guards are on duty. All bathing is confined to the lakeside waters of the park. Please keep out of the water when guards indicate that water is too rough for safe bathing. New beach houses contain dressing rooms, refreshment stand and coin checking facilities. Floating devices inflated by air are not permitted as a safety measure, but life jackets approved by U. S. Coast Guard are permitted. In order to keep the beaches as clean and sanitary as possible to meet public health regulations, picnicking on the beaches is not permitted nor are pets permitted on bathing beaches or bathing areas.

PICNIC RESERVATIONS: Cabins and Cookhouse facilities are available for DAY USE ONLY by groups and by reservation. These facilities may be reserved in advance at the Park Office. Each group shall assume full responsibility for its members and shall leave the premises in clean condition.

BOATING: Each boater using Park waters is required to register his boat at the police headquarters at the Park Office. Trailer boats may be launched at several boat ramps in the park at no charge. Boat speed is limited to 4 miles per hour in all park waters. Police boat is on duty to enforce State boating rules. Please get boating bulletin at Park Office when registering boat.

MARINA: Slips up to 45 feet are available by lease. Inquire at office for rates.

BOAT LIVERIES: Two boat livery concessions

operate in the park at which boats, canoes, bait and fishing gear may be rented.

CANOEING: Canoeing is permitted on inland waters under park jurisdiction. Due to rough waters which may arise, canoeing is not permitted in Misery Bay, Erie Bay or Lake Erie waters.

SKIN DIVING: Skin diving in waters under park jurisdiction is prohibited. Divers may launch a boat and proceed to a point 500 feet off shore where they may engage in this sport.

WATER SKIING: A water skiing area has been designated on Thompson Bay for water skiers. Skiing is prohibited in all other park waters. Please stop in office for further information concerning this sport.

FISHING: A Pennsylvania fishing license is required of all fishermen except that children under 16 years are not required to have a license.

LOST AND FOUND: Please report lost and found articles to Police Headquarters. Finders of articles have first claim to unclaimed lost articles.

FIRST AID: During the summer, a nurse is on duty at the Red Cross Hut in the Park, to render first aid. This service is provided through the Erie Chapter of the American Red Cross in cooperation with the Park as a United Fund Service. First Aid attention is also available at the Park Office the year around.

REFRESHMENTS: Several refreshment stands are located in the Park to serve the public. These are operated by a concessionaire who is required to give a high quality service.

PARK RULE VIOLATIONS: Violators of park rules, traffic rules and highway littering laws are subject to arrest and fine under existing laws. Park rules and regulations are posted in the Park Office and at various convenient points throughout the Park. It is expected that visitors will observe the rules and abide by them.

PARK POLICE: Park police are on duty 24 hrs. a day and are instructed to courteously enforce the laws and rules of the Park and to aid and assist the public.

The first interview was conducted on 2 August 1966, in the home of Anita Haifley. She was very calm and had more interest in her children than the interview. Information given on her written statement varied from the information received from the interview. She was very easily lead, agreeing with my statements, not veing able to think of what to say.


The interview of Betty Klem, Gerold and Douglas was conducted in the home of Betty on the 3rd of August. Both Gerold and Douglas stated they were both very interested in UFO's. Gerold stated he had seen one (UFO) last year. Douglas stated he had seen them before and so had his father, stating, someone has to find out what "they" want, either they are good, or bad - "The longer Douglas talked, the more distant or "wayout" his stories were. Douglas stated that he thought the object was going to pick up the monster the girls saw. Also, the monster was sighted in Jamestown, the night of the 1st and 2nd and that the monster was looking for Betty because she saw it. There was no mention of a full moon, only a dark, clear sky - yet no one could identify anything. Why would they go to a beach a hundred miles away when there are many beach areas on the lake in Jamestown...arriving at the picnic area at 8:00 PM and were ready to leave at 8:20 as stated in Betty's statement. All statements varied and no one would say or write just what it was they saw.

Douglas and Betty were the only ones interviewed by the press yet Anita also was present at the sighting. She had no idea that Douglas and Betty went back to Erie for the interview or that I had set up an interview on the 3rd of August. Also, newsmen arrived and wanted to take pictures of Betty and Douglas; Sister-in-law to Betty requested no pictures since Mon and Dad were on vacation. However, Douglas was all for the pictures when I departed.

My personal opinion is that Betty, Douglas and Gerold set up a hoax, getting Anita involved as a backup. Every time the police arrived the object disappeared. Douglas seems unreliable, likes to tell stories. Anita is very gullible. Betty seemed reliable. Gerold's statement varied from Douglas's statement. Gerold was not accounted for until everything was over. Douglas said the object the girls saw was on the right side of the car, Betty said it was in front. Betty said a stem came from the center of the object before landing. It looked like the stem of a big mushroom. Douglas drew the object having no center.

I hope you can make sense out of my own thoughts, but the more I think about the type of people that are involved the more disbelief there is.

After carefully analyzing the facts as told to us by the people involved in this sighting and from my personal observation of the people concerned and the environment they live in, I have come to the conclusion that this incident could very well be a hoax concocted by three of the principals involved [REDACTED], [REDACTED], and [REDACTED] in my opinion, was led to believe she saw the things stated in her statement by [REDACTED] and [REDACTED]. I am of the opinion that [REDACTED] has no knowledge or part of this if it is found to be a hoax.

Being a native of this area and having spent a good share of my life hunting and fishing this area, I believe that the so called "monster" (if there was such) could very well have been a large black bear; as black bears are not too uncommon in this area.

Some of the facts that bring me to this conclusion are as follows:

1. All four principals involved stated it was a clear dark night - no clouds in the sky. There was no mention of the moon which on 31 July was full and rose at 19:30 hours in this area.
2. During the week of 26 July the local TV stations showed a program called "Lost in Space". In this program there were two monsters fitting their description controlled by a human being.
3. [REDACTED] was conveniently absent during the incident and the only things that [REDACTED] saw were suggested by Betty Klem or Douglas Tibbetts.
4. When [REDACTED] first observed, as she states "monster", she exclaimed "close your eyes, it's coming".
5. [REDACTED] stated that he knew the beach and beach area and that is why they went there for a picnic. However, the picnic lasted only twenty minutes and the distance between Jamestown and the beach is approximately 80 miles.
6. The only persons whose statements agree on exact times of the sighting and disappearance of the vehicle is [REDACTED] and [REDACTED]. These two are boy and girl-friend.



Statements from the police lead to the following chain of events; At 8:15 PM EDST, group arrived. At 9:30PM, probably as beach became deserted, Gerald Labelle left to get help. Additional witness reports seeing the car at 9:40pm with light on inside and people around picnic table. 10PM, police noted car, stopped to offer help. Informed that help had been sent for, they said they would return in about 45 minutes and see if all was well. At that time all persons were sitting in car, with food still on table about 20' away, around some bushes. 10:25 to 10:30 sighting took place. 10:35 police returned, were told by Tibbetts "Something wierd is going on up there". Tibbetts and police departed car and walked nearly 300 yards up beach when Miss Klem heard rustling in bushes, looked up to see "dull black shape, bigger than a man, big head and shoulders, arm like appendages, no hands, no face visible, as though it had it's back turned." It was in front of the car, and when Miss Klem blew the horn it "lumbered into the bushes". The lights were not turned on. Tibbetts and police ran back to cars. All persons got into police car and returned to Admin Bldg to calm down women and alert police chief. Policemen and Tibbetts returned to stalled car, searched area around picnic table with no results. More food missing from table and cake gouged, circular hole about 5" in diameter. All returned to Admin Bldg. Labelle returned with friends from Erie with car to aid, and reported at Admin Bldg. Time of return is not clear. Patrolmen searched beach with no results.

At 0630AM, just after full daylight, 2 other patrolmen searched the beach and found marks they considered unusual. They had no exact knowledge of the area designated by Tibbetts as landing place. These marks did coincide with that area, according to patrolmen who accompanied him. (See exhibits for diagram and pictures). I believe the witnesses were at least nervous at being stuck in the sand in an unlighted area. This is supported by the fact they had abandoned their picnic on the table and were in the car. Police report comments of scratching sound heard prior to sighting. Whatever was seen or purported to be seen of the UFO must have heightened this feeling. Tibbetts warned women to keep windows up and doors locked while he and the patrolmen walked up the beach. He further directed Miss Klem to flash the lights if she needed them while they were gone. When she saw the "shape" she blew the horn ^{STEADILY} instead, and told Mrs (?) Haifly "not to look."

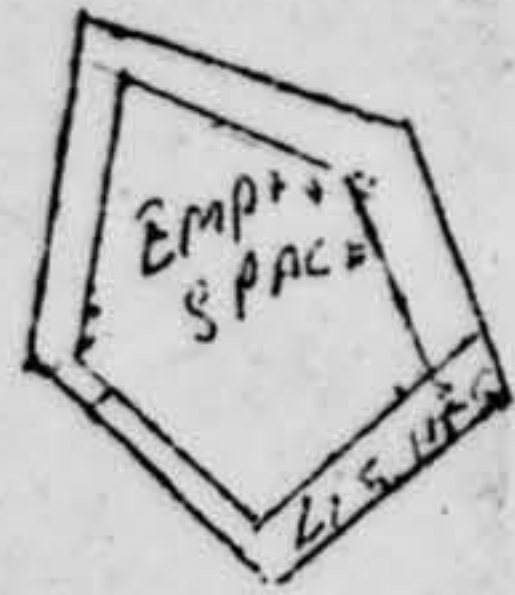

Recommendations:

1. Instructions be issued to investigating Air Force personnel to remain completely objective in the reporting and recording of observed data. The distortion of the true orientation of the two larger footprints would have been very misleading had the photographs not been available to show them to be located in other than symmetrical manner.

2. It is suggested that an appointed member of the civil engineering personnel of each Air Force Base be given a very brief course in obtaining soil samples and taking soil strength data readings. Capt. Skillen, AFIT/CEC, has suggested that this course could be given to such personnel during their regularly scheduled periods of instruction at the Air Force Institute of Technology at WPAFB. In this manner, a more accurate estimated weight acting on the depressions can be made in the investigation of future reported sightings.

For instance, it is highly desirable that cone penetrometer (or other similar tests) be performed at a number of stations in the immediate vicinity of the depressions as well as within the depression itself. In this manner, the strength of the undisturbed soil would be established as well as the degree of compression of the soil under the footprint area.

3. It is mandatory that a more accurate layout of the footprint locations and orientation be made. Pieces of string tied between pegs can serve as valuable reference lines. At the minimum, a base line should be drawn by scribing a straight line in a convenient location on the soil. All points would then be referenced from this line so that an accurate diagram can be reconstructed of the site by participating investigators. Photographs of the site should include this base line (or Lines) as a reference. In this particular case, no record whatever was made of the angular relationship of the two larger triangular footprints, which is a decided handicap in the analysis of the evidence.

TO: Major H. Quintanilla, Jr., FTDTR

The Landing Gear Group of the Air Force Flight Dynamics Laboratory was asked to evaluate the subject depressions found in the vicinity of a UFO sighting that occurred on July 30, 1966. According to the investigators, the location of the depressions did not correspond to the area where the witness reported that the UFO alighted. However, the unusual shape and orientation of the depressions prompted further investigation following their discovery. The following are the conclusions and recommendations of FDFM:

Conclusions:

1. According to the investigating USAF Officer, the sand was definitely compressed under load and not excavated as might have been done by a child playing on the beach.
2. Assuming that the depressions were made by an applied load and based on inspection of the soil sample and the plaster-of-paris casting provided, the estimated weight that caused the two larger depressions was 750-1000 lbs. Since no information was given regarding the size and depth of the smaller (third) depression, no estimate regarding the weight that may have rested on it can be given.
3. According to Mr. Max Groff, EWFRG, of Base Civil Engineering, the outrigger stabilizing pads of certain large construction equipment could leave an inverted three-sided pyramid footprint shape similar to the ones found on Presque Isle. However, no vehicle tracks were observed in the vicinity of the footprint, which effectively eliminates this potential explanation.
4. The layout of the three footprints showed no semblance of symmetry. If the third, smaller footprint is discounted, lines extended through the apex and bisecting each of the two larger triangular footprints do not converge in a symmetrical manner. This information, obtained from study of the photograph which shows both larger footprints, is contrary to the orientation shown on the sketch made by the USAF investigating officer.
5. Based on the number of depressions and their orientation, it is not likely that they served as ground-stabilizing contact elements for any kind of platform or vehicle. A minimum of three points is necessary to provide stable support of any object and some form of symmetry in their location is basically logical.

Of the three adult witnesses, I was able to talk to only the male, and to obtain statements from the two police officers who arrived on the scene. Statements from news editor who was called in by the chief of police and additional patrolmen were taken. The general impression is that the witnesses were fairly level-headed, but obviously frightened. Miss Klem was described as being very nearly in a state of shock but rapidly regained control of herself when taken to the Park Admin Office. Listening to conversation of those present at the initial interview, there appear to be discrepancies in description between Mr Tibbetts and Miss Klem.

FACTUAL DATA Five samples of sand in plastic vials and about 10 pounds of sand were submitted for analysis. Three of the vials were labeled "W" and two vials were labeled "E". The ten pounds of sand was submitted in a large pasteboard box. The vials were opened and all of them had a strong unmistakable odor of urine. A test for the urea in urine was performed by heating a portion of the wet sand from each vial in a small amount of distilled water and sodium hydroxide. A red litmus paper was held over the top of the container in which the sand, water, and sodium hydroxide were heated and in every case the litmus turned blue indicating that ammonia had been formed. This was a positive test that urea was present in the sand. Other portions of the wet sand in the vials were dried under a heat lamp and extracted with chloroform. The chloroform was evaporated but no residue was found. The sand in the box contained several pieces of sand bonded together in the form of thin flat sheets. One of the pieces of bonded sand was placed in a beaker of water but no observable change took place. Another piece of bonded sand was placed in a beaker of chloroform and the bonding substance dissolved. The soluble portion of the bonded sand the bonded sand was decanted and the chloroform was evaporated. An infrared spectrum of the soluble substance was recorded and identified as an acrylic resin. The day after this identification was made and reported verbally to Lt. Marley of TDETR, he informed me that he had just received information that the sand had been sprayed with an acrylic resin prior to making plaster of paris casts of the indentations. (Next page.)

Obviously, the acrylic resin that was identified came from the investigator who made plaster of Paris casts of the indentations.

This is a good opportunity to emphasize the importance of taking a representative and an uncontaminated sample if the sample is to be subjected to a chemical analysis.

A portion of the sand in the box which appeared to be uncontaminated by the acrylic resin was extracted with chloroform. The chloroform was evaporated and a small residue remained which was identified by infrared spectroscopy as an ester. It is not unusual to find esters in the soil.

CONCLUSIONS

The five samples submitted in the plastic vials contained urine.

The sand submitted in the box contained a very small amount of ester material, however, this was not considered to be unusual. The acrylic resin originated from one of the investigators when he sprayed the indentations with the resin prior to making plaster of Paris casts.

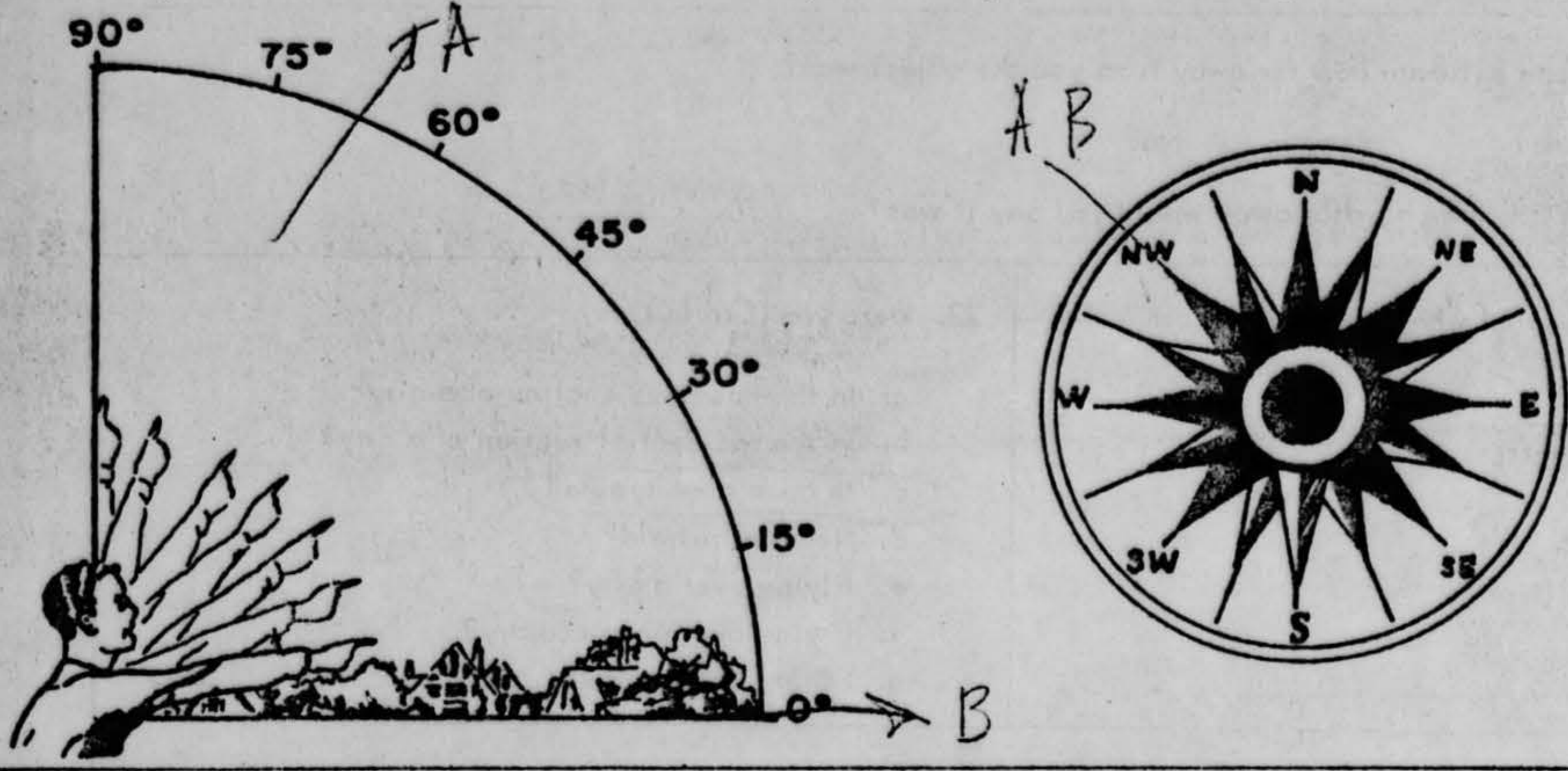

The witness appeared creditable. He did state affirmative answer to one questioner who asked if he was a policeman. He was wearing a borrowed police jacket at the time - early morning. This could have been caused by lack of desire to be questioned by curiosity seekers.

Park police placed a vehicle at the observers spot and cruised the area roads with another vehicle with various light combinations to try to duplicate light conditions, but could not.


Newsreel photographers stationed all night on the beach the following night saw a light and photographed it. Film is being forwarded in accordance with AFR 200-2

L. Physical Evidence

1. Physical evidence is questionable. Two triangular marks found in the sand (see attach #1) were photographed and a plaster of paris cast made by Penna State Police. There is no evidence to actually relate these marks to the sighting. These marks were obviously made by an angular flat, slightly concave object pointed slightly down, and pushed into the sand, as evidenced by firmly packed bottom surface, sand pushed up in crater-like ridge around the edges, and penetration of this angular surface about 4 - 5" below surface of sand, maximum. Cast was made with top even with average surface of sand, not as deep as pushed up ridge. A smaller mark, similar but not identical with two larger marks also existed. As seen in photo, it has no obvious relation with other two holes. The most striking feature of these ^{two} marks is their similarity, being very nearly identical, except for direction.

Some damp spots in the sand nearby, which did not become noticeably drier during the day were sampled from various locations within the damp area, and samples are included, along with sketch of area.

Full cast of Easterly hole is included, and partial cast of West hole, along with sand from general area.

ADDITIONAL COMMENTS

Both investigators (Major Hall - Captain Meier) reported discrepancies in the information available to them. The following is a listing of puzzling factors:

1. Who actually saw "black shape"?
2. Description of object quite varied.
3. Who actually walked down beach?
4. The sounds heard varied.
5. Vibrations of car as alleged UFO settled to ground.
6. How did object disappear.
7. Why were [redacted] and [redacted] getting ready to go swimming when Miss [redacted] reports they were ready to leave for home at about 8:30.
8. Why were persons parking on that part of beach at this time of night. Observers were watching the sky from inside the stranded automobile when they noticed a bright star. Arcturus was on an azimuth of 275° at a 30° elevation at 1030 EDT, possibly accounting for this observance. Looking back several seconds later an object was observed "free falling" toward the ground.

The girls saw nothing but a light in the sky and a glow of light in the woods prior to observing the "black shape". One observer; however, provided a vivid description of the alleged UFO. Only male observer allegedly saw object land. There was food missing from the picnic table which leads to the belief that some animal was responsible for the black shape portion of the total sighting. There are numerous bears and raccoons in the area.

CONCLUSIONS

1. No evidence exists to relate the damp areas and the indentations found on the beach to the sighting. Considering the indentations, the following comments are presented:

a. No object could have made a stable landing without at least a third appendage.

b. Sand should have been a lot more compressed for alleged landing.

c. No ground maneuver capability apparent.

d. Portions of ground indentations appear to have been uncovered - not totally compressed, as should have been.

e. No definite sign of vehicle departing area in the sand. No evidence of heat blast or sand being disturbed by aerodynamic vehicle.

f. Rough weight calculations place weight of alleged object at approximately 1500 lbs. total weight. This being a static load estimate calculated anticipating a two-legged object.

g. Acrylic resin was present in the large sample taken around the indentation. This was attributed to the acrylic lacquer which was sprayed on the indentations prior to casting the mold.

h. Urine was distinctly present in the soil samples.

2. Both Major Hall and Mr. Parmenter (Erie County Civil Defense) checked for existence of radioactivity. In both cases negative results were obtained.

1. No correlation can be found to exist between the three facets of the case under consideration: light - indentations, indentations - monster, monster - light.
2. No evidence exists to relate the damp sandy areas and the indentations found on the beach to the visual sighting. Considering the three indentations, no evidence is present to indicate a landing of any type occurred (Flights Dynamics Lab, W-PAFB). A chemical analysis of the soil samples was completed. There was nothing unusual in the samples except urine (AF Materials Lab W-P AFB).
3. There is no evidence to substantiate the presence of a black monster. No unusual markings were found to indicate such a "thing" was observed. The missing food and scratching sounds are indicative of some type of animal in the area.
4. As yet, there is no explanation of the lights that were observed. An object was observed "free-falling" for approximately 3 - 5 seconds. Concluding a possible meteor as the explanation, the Smithsonian Institute was contacted; however, they had no information of any meteors being observed at this time and place. Contact was made with the Park Police and nearby U.S. Coast Guard Base for any unusual lights over the area. Negative results were received in both cases.
5. With the existing data no conclusive explanation can be made concerning the lights. It is assumed that no correlation existed between the lights, the indentations, and the "alleged black monster".

Worthy of note is the fact that as object settled to the ground the car vibrated. An object slowly descending onto a sandy area isn't likely to cause the vibration of a car approximately 300 - 400 yards in the distance, especially since the depth of the indentations were only about 4 - 5 inches in the loose sand.

Various discrepancies are noted throughout the available information. These discrepancies are prevalent in the description of the alleged UFO and in the actual sequence of events as they occurred. Considering these discrepancies, it is difficult to give any ^{much} credence to the sighting. ~~The validity of the sighting is definitely questionable.~~

MEMOS FOR THE RECORD

At 0130, 1 August 1966 Lt Marley was notified by SSgt Jones, of TDETR, that the Duty Officer had information on an important sighting in Pennsylvania that took place in a public park. The police wanted to know if they should rope off the area. Lt Marley called the Duty Officer and after finding out that the object appeared as a light and stayed there for 45 minutes that there would be no need for roping off the area. Duty Officer was Captain O'Brian.

At 0745, 1 August, Lt Marley received a telephone call from Major Hall, Youngstown Airport, 231-3600, ext. 258 autovan. Youngstown had been called by Captain O'Brian. Major Hall didn't know anything about the sightings over in Pennsylvania. They are manned by civilian guards over the weekends and evidently it was these guards that gave the number of Wright-Patterson to the Police in Pennsylvania. Lt Marley said he would contact Youngstown if they are to go out and investigate.

Talked to Sgt Heckencheck with the State Police, Pennsylvania 814 899-3117 - State Police said that the sighting had been brought to their attention. These people were stuck in the sand and they saw this bright shiny object that sparked. Later they saw it land and then later they saw a black monster in the bushes. Sgt Heckencheck at this point mentioned that it was possible imagination which took over at this time.

Lt Marley spoke with Chief of Park Police Dan Dascanio, 814 833-6124. We got statements from the people. Dascanio had talked with Captain O'Brian and he said not to rope the area off. A search of the area commenced at daylight and

New Castle News of New Castle, Pennsylvania called at approximately 0845, 1 Aug 66.
A picture which their photographer had taken was a possible UFO. Spoke with [REDACTED]
[REDACTED]. Looked something like a pentagon but didn't seem to have a body. Major
said he had no idea what it could be. Would have to turn it over to the
photo analysts. Mr. [REDACTED] is going to send us the background information with
camera data along with the negative.

all had returned with the exception of two officers. The people said there were marks out there, but they hadn't seen anything yet. Basically the same report is in the newspaper. He will send us his report along with the newspaper clippings. Yes these people had also observed a black monster. He would send us his reports.

Conversation 0930, 1 August 1966 with Major Hall, Youngstown Airport.

He will leave at noon today to check out the sighting, will take a camera, camper, geiger counter etc, will try to go as near as possible to AFR 200-2. Since the witnesses have returned to New York, Major Hall will have Niagra AFS contact the witnesses and give Major Hall information received from witnesses. Explained to Major Hall that there had been widespread publicity already on this. Major Hall said he would get background readings from the geiger counter and then readings in the immediate area. Will call us collect to inform us how things are going.

Conversation at 1500 hours, 1 August 1966 with Major Hall, on the scene this afternoon, presently at the Police Department at Erie, Pa. Object left three "V" shaped marks in the ground, 45° angle, indentations 4 inches deep, two identical, indentations 16 feet apart, 10 - 12 inches long.

Getting statement from Tibbetts - other two observers back in Jamestown, New York. Cast being made and Major Hall had taken pictures. Had gotten five soil samples. There is a plane coming over to Wright-Patterson AFB 2 August 1966 and he will get this stuff on the plane. The Civil Defense had a negative reading as far as radioactivity goes. Major Hall had negative reading

on radioactivity. He will get the Civil Defense to give a statement to this effect. [REDACTED] is apparently level headed. Measurements were made by tape measure.

At 1930, 1 August 1966 Lt Marley was called by Major Hall from scene of sighting. After conversation with Mr [REDACTED], Major Hall said that said observer saw something free falling downward to the sand. There were at first white lights noted; however, after the object supposedly hit the ground the white lights disappeared and red lights became visible. M [REDACTED] watched this for about 10 minutes. When the park police came up the lights disappeared and were never seen again. The police did not see anything. [REDACTED] and Miss [REDACTED] were walking down the beach and Miss [REDACTED] stayed in the car. Miss [REDACTED] noted a type of black monster around the car and she began to blow the horn causing the other two witnesses to return to the car. Major Hall felt he had done all that could be done at the scene. He thought that a personal interview should be performed with the witnesses.

At 0745, 2 August 1966, Lt Marley spoke with Captain Meier, Niagra AFS autovan 231-3860, ext. 351. Two witnesses returned to Jamestown, New York, need statements and a personal investigation with them. Requested Captain Meier do this. He has Duty Officer today and tomorrow, but said he probably could get relieved of this duty or someone else would go today. He will call in his findings followed by a written report. He will look into the fact that the 16 year old gets hysterical.

Conversations at the home of SSgt Harold T. Jones on 2 August 1966, approximately 1915.

Spoke with Major Hall, 3 August 1966, 0745 hours. Airplane is going to take off in approximately $\frac{1}{2}$ hour from Youngstown, arriving in Dayton, approximately $1\frac{1}{2}$ hours later. 23354 is the plane number. Wanted us to call Base Ops and have them notified that they were just dropping off some information and packages and will be right off again. Recommended bringing a station wagon to pick up the cast and soil samples.

Two guys from WJET decided to park over on the beach Monday night. They saw some light, with a movie camera they took a picture, about five seconds. WJET is sending this film into us. With all the background information on the film, camera, etc.

Sand samples in tubes are marked one, W and other E. This stands for the areas where the sighting took place. One is from West section other from East section.

Conversation with Capt Meier, 3 August 1966, 1145 hours. He has received written statements from all witnesses. There is no description on any of these. The length, size etc. There doesn't seem to be any concrete. When you talk to them you see that they definitely have seen something. He has a diagram of so called space craft which they described as real wierd.

described it as a five sided figure, with lights around it, empty in the middle. Observed from 300-400 yards away. He had talked to the photographer who took the pictures of the landing site. Everything is sort of word of mouth. will build onto everyting. 22 year old girl very calm. She didn't see it land, only saw something in the sky like a satellite. Thought it was a satellite. Noise was similar to a jet motor. Felt the car vibrate. Girls saw nothing except a glow through the woods. Glow of light.

FTD Duty Officer called three different times to inform me that Captain Meier called and wanted a breakdown of the UFO sighting in Erie, Pa. I asked the OD to call Captain Meier back and to tell him our office would call him at 0730 or 0800 hours in the morning on 3 August 1966.

Again: O.D. called back and said Capt Meier called him and wanted to know if he should go to Erie, Pa. that he could only get a statement from one of the observers and she didn't make too much sense. The other girl went back to Erie for a press interview and I told the OD to call him back and tell him to go to the girls house tomorrow, 3 August 1966.

Again: O.D. called and said Capt Meier called him again and said if we called him at the time stated we were going to call that it would be too late that he would be enroute to the other observers home for the statement requested by us. O.D requested that either Lt Marley or myself give Capt Meier a call and brief him on the sighting tonight.

2115(L) I called Capt Meier and gave him a brief summary of the sighting and he stated that the girl he spoke to did not make much sense, all she kept saying that it sounded like a jet engine going on and off right overhead.

Told Capt Meier as soon as he got the other observers statement to give us a call collect and he said he would give us a rundown of what the girl said.

2145(L) Received another call from the O.D. at home and he stated that "UPI" just called and wanted to know about the Maj Hall from Project Blue Book that was investigating the sighting in Erie. I informed the O.D. if they called back to tell them to call our office from 0715 - 1600. The O.D. wanted to know if it would be okay if he said Project Blue Book, and I said that was Okay.

in the large sand sample which was taken around the indentation. This binder was sprayed into the indentations prior to casting the mold. A smell test of the five samples around the area definitely had the presence of urine. An additional chemical test will be performed of these five samples.

3 August 1966, contacted Mr. Wagner about the analysis of indentations in the sand off Lake Erie, Pa. Left casting of indentation at his office. Told him I (Lt Marley) would furnish him with measurements and additional information when Major Hall's report came in.

4 August 1966, contacted Mr. Smithson and reported that acrylic lacquer was sprayed on indentations accounting for the presence of the acrylic resin. Urine was definitely present in several of the samples. Additional testing were in the process of being conducted.

4 August 1966, conversation with Capt Meier concerning alleged UFO sighting. Capt Meier is sending radar information, basically whether anything unusual was reported in the area on radar.

Conversation on 4 August 1966, with the U. S. Coast Guard Base, Presque Isle State Park, Erie, Pennsylvania, 833-7697. They had checked into the fact that there were lights over Lake Erie on the night of 1 August 1966. All it was, was a fishing boat. Observed somewhere between 2130 - 2200 hours. Somebody from General Electric Plant had observed it. One plane going North and one was going South, passenger planes, they too had observed the objects. The Coast Guard went up in the tower and they saw these weird looking lights on the lake. They took the Coast Guard boat out and found it was a fishing boat.

[REDACTED] drew a picture of it. Did not observe any legs under it. [REDACTED] seems reliable and said that it looked like a mushroom from underneath object. [REDACTED] comes from a clean type of home. There is nothing you can put your finger on. The news reporter described the indentations to be 6 - 8 inches deep in parts, fluffy sand around it, as if nothing solid was there. [REDACTED] said something about there being web foot with 9 toes. Both of the girls and [REDACTED] saw 7 - 8 foot monster come out of woods, blew the horn and it just went back. A tree nearby had claw marks on it, with bark tore off. Capt Meier had a Sgt with him who was a hunter and said that it could easily be bear marks, as there are bear in the area. Conflicting information during the whole case. [REDACTED] was in the car. Personally he cannot believe [REDACTED]. [REDACTED] has seen these things before. [REDACTED] had gone to get help, hitched a ride into Erie and then stayed there all night, not sending help until the next morning. [REDACTED] saw one of these things last year. No shape, no nothing, has gone back to the area and hopes to see them. [REDACTED] thinks the spacecraft is looking for the beast who has been seen over the area. Nobody saw the object take off. It just vanished when a police car came. [REDACTED] touched the brakes when he saw the police car coming in the rear view mirror. The object just vanished then. When everybody was gone they saw the monster. Asked Capt Meier what the possibility of the [REDACTED] doing the scaring. He felt that this was quite possible, since they could not account for his presence, other than he supposedly went after aid for the car.

3 August 1966, contacted Mr. Lee Smithson of AF Materials Labs. 55119 (MAYA). Mr. Smithson made initial investigation and determined an acrylic resin present

5 August 1966, conversation with Mr. Smithson of Materials Labs. Confirmed preliminary analysis of soil specimen as having the presence of urine. Mr. Smithson found nothing unusual in the five samples. Some traces of organic material was found but this was expected.

8 August 66, conversation with Dan Dascanio (Police Chief) took place concerning operation of the lighthouse in the state park. Chief Dascanio said that it would not have been possible for the witnesses to have seen the lighthouse because the lighthouse only throws light out over the lake. The light isn't seen from the land.

Nothing else on the case had turned up. There had been several other cases reported in the area.

8 August 1966, conversation with Coast Guard Base, Presque Isle State Park, Pennsylvania. There was nothing in the log book to indicate the observance of an alleged UFO on the night of 31 July 1966. The tower at the base is not manned all the time. The only night that a boat was scrambled to identify an apparent UFO was the night of 1 August 1966.

Relayed above information to SAFOI at 1525, 8 August 1966.

They said that these lights were about 2-3 miles out, and would give the appearance of being weird.

4 August 1966, contacted Mr. Aivars V. Petersons of Flight Dynamics Lab (FDFM) for information on alleged indentations in ground. Following are his comments:

1. No way object could have made stable landing without at least third appendage.
2. Sand should have been a lot more compressed for alleged landing.
3. No ground maneuver capability apparent.
4. Portions of ground around indentations appear to have been uncovered - not totally compressed as should have been.
5. No definite sign of vehicle departing area in the sand. No evidence of heat or sand being disturbed by aerodynamic vehicle.
6. How could object have caused car to shake when it supposedly hovered over the ground approximately 10-15 feet and then settled to the ground.

Mr. Petersons said that various persons had discussed the alleged landing. It was mentioned that indentations were very similar to bow of a boat that could have been pulled up on the beach. Smaller mark looked like where anchor was placed. Also looked like the type of indentations that would have been made when a rifle was fired at the ground.

Rough weight calculations made place weight of alleged object at approximately 1500 lbs total weight. This being a static load estimate - (Mr. A.V. Petersons)

4 August 1966, contacted Mr. Alex Geddes of the Smithsonian Institute on above date. He didn't have any reports of any meteors coming down over Lake Erie on 31 July 1966. Said he would call if he heard of any such reports.

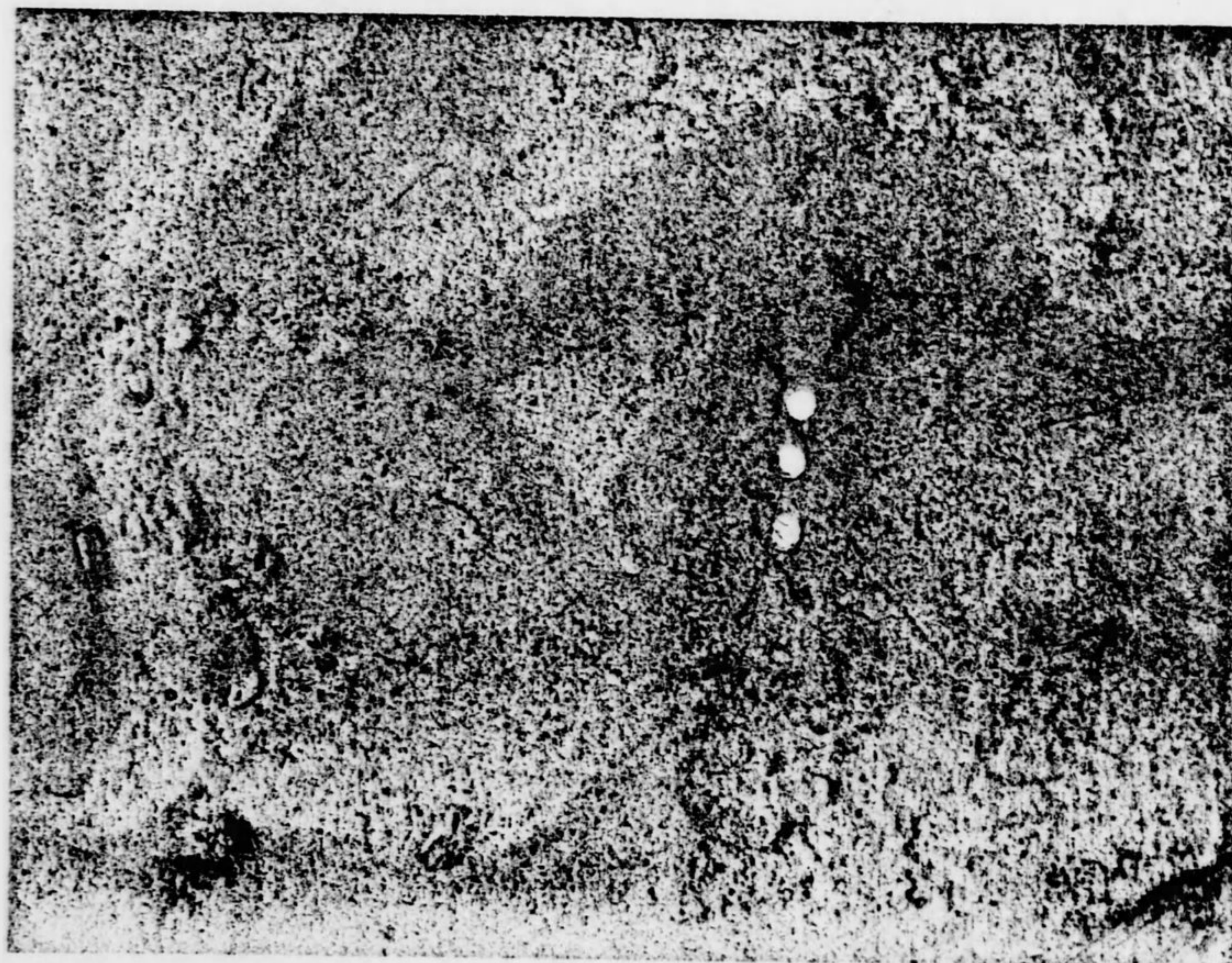

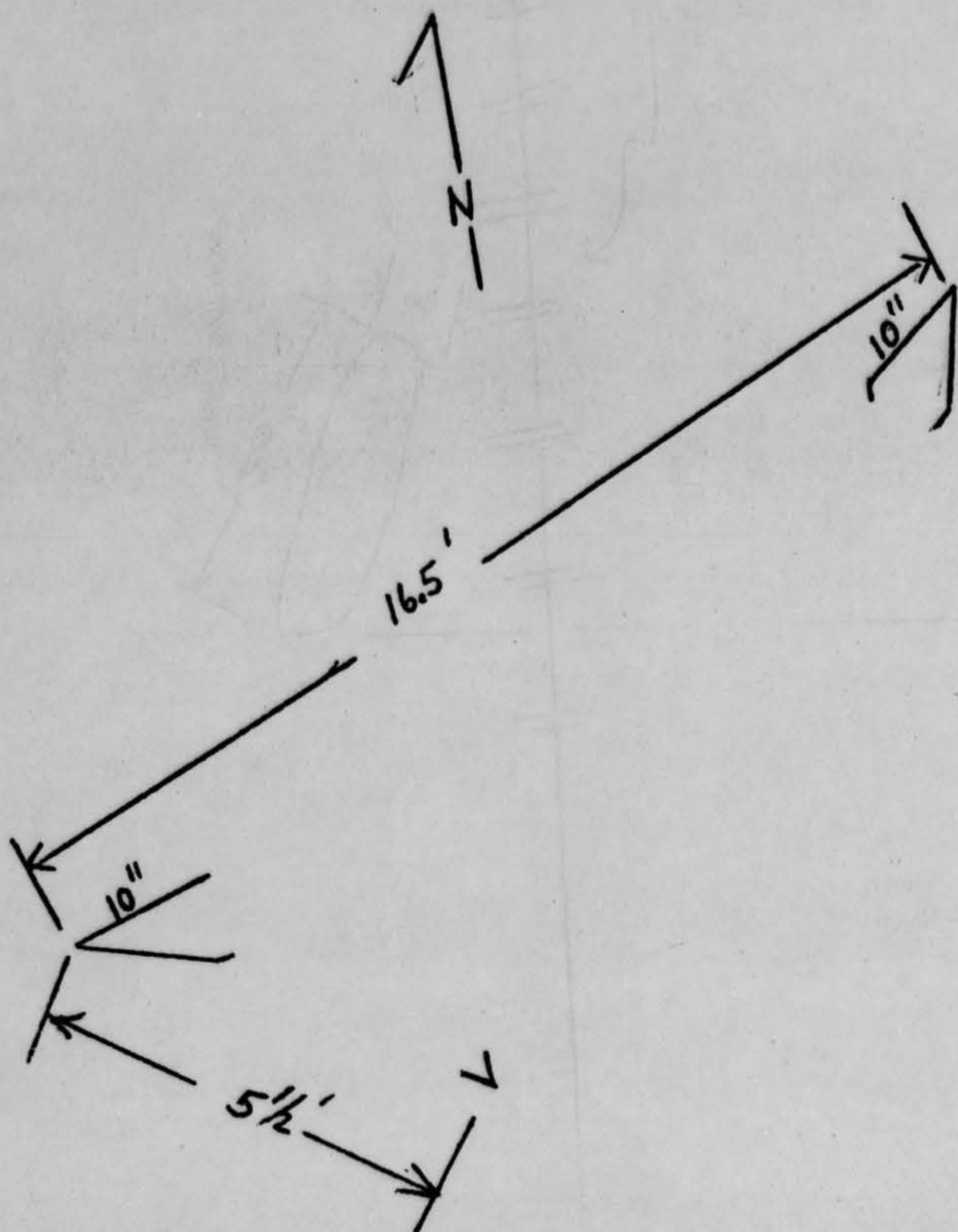


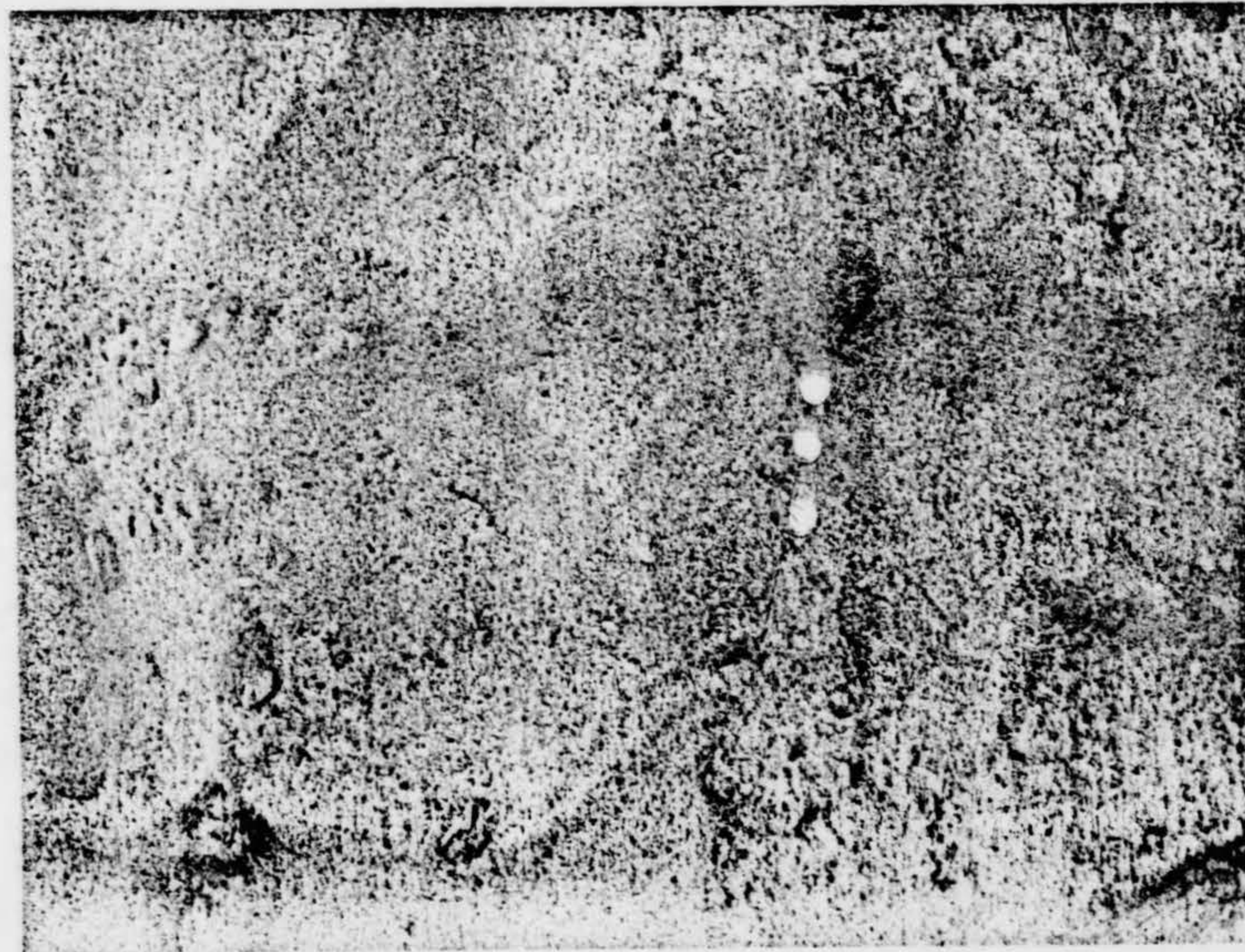
DIAGRAM of SAND MARKS
