

Subject: House passed The Caesar Syria Civilian Protection Act

Just in case you missed it, on November 15, 2016, the House unanimously passed the Caesar Syria Civilian Protection Act (HR 5732). It's now with the Senate. Here's the HFAC release: https://foreignaffairs.house.gov/pressrelease/engel-royce-syria-sanctions-bill-passes-house/

Text from the link within the article below:

The Syria legislation targets key backers of Assad such as Russia and Iran, according to Royce, by requiring the president to sanction countries or companies that do business with or provide financing to the Syrian government or the Central Bank of Syria.

Anyone that provides aircraft to Syria's commercial airlines, does business with the transportation and telecom sectors controlled by the Syrian government, or supports the country's energy industry also would be subject to sanctions, according to the legislation.

"If you're acting as a lifeline to the Assad regime, you risk getting caught up in the net of our sanctions," Engel said.

Sanctions could be suspended if internationally recognized negotiations to resolve the war in Syria are making progress and the violence against civilians has ended, according the legislation.

The White House and State Department had previously argued to Congress that new sanctions legislation could undermine efforts with Russia to forge a cease-fire between Assad and rebel groups. While the Russia talks have collapsed, the administration maintained concerns that the sanctions might hurt Iran, another Assad supporter, giving Tehran an excuse to renege on the US-brokered nuclear deal.

I hope you are well. I don't know if you remember me, but we communicated back in September (copy of our emails attached), about my firm's request to OFAC for a specific license to represent Concern Kalashnikov in legal matters before the US Patent and Trademark Office.

As you explained, we did not need a specific license to conduct (and be paid for) such legal work, as these types of services are allowed under the general license provisions of 31 CFR Secs. 589.506-507.

Unfortunately, our US bank, JP Morgan Chase, is refusing to allow the wire payment for Concern Kalashnikov (see what we are being told in the below email). Chase is saying that the payment must be by check and must be in US currency. Attached is a copy of the wire authorization from Concern Kalashnikov's bank to our bank.

If you are still able to assist me, I'm wondering two things: (1) Is Chase correct that payments from sanctioned entities/persons must be by check and in US currency; and (2) If Chase is not correct, I'm hoping there is someone (maybe you) from OFAC who can assist us in getting Chase to clear these funds so that we may be paid for our already rendered services.

As a final matter, and so you see we have completed our requirements under 31 CFR 589, also attached are a copy of our retention letter with Concern Kalashnikov, as well as our letter sending a copy of the same to the OFAC.

I look forward to hearing from you at your earliest convenience.






