Russia's Kalashnikov Unveils New Brand and Plan for World Domination

Kalashnikov unveiled its new branding with the help of girls in tight dresses holding AK-47 ammunition magazines

Hoping to offset a disappointing year, Russia's iconic weapons maker Kalashnikov launched a new brand and marketing strategy at a blowout press conference in central Moscow on Tuesday.

Inconsistent Russian military orders and greater domestic competition have in recent years forced Kalashnikov Concern to look abroad for customers to keep its production lines running and staff employed

Eighty percent of Kalashnikov's civilian weapons are exported, and under a distribution deal signed last year 200,000 rifles were supposed to go to the U.S. — the world's biggest market. Kalashnikov currently produces around 150,000 civilian weapons annually, showing the scale of its U.S.

But these plans were cut short his summer, when the U.S. slapped sanctions on Kalashnikov to punish the Kremlin for its actions in Ukraine. The move killed the company's U.S. expansion plans, and an EU arms embargo installed in July then froze Kalashnikov out of the European

"The U.S. market was very important for us," Kalashnikov CEO Alexei Krivoruchko said at the press conference, where the struggling arms manufacturer presented a new branding and development strategy through 2020.

The company unveiled new logos across its these three product lines - Kalashnikov for he Russian and foreign militaries; Baikal for civilian hunters; and Izhmash for sportsmen and promised to target new markets, including South America, Asia-Pacific and Africa, to offset the damaging loss of the U.S. civilian arms market.

The rebranding will play a critical role in Kalashnikov's plan, said Sergei Chemezov, head of Rostec, Kalashnikov's state-owned parent company. The strategy aims to increase revenue by a factor of four and expand production volumes to 300,000 units per year.

Kalashnikov hopes the new strategy will allow it to become the most popular weapons maker in he world by 2020.

This year, the company broke even, delivering over 140,000 weapons to customers across the globe. Last year Kalashnikov lost 1.7 billion rubles (\$31 million), according to Moscow Defense Brief, a publication produced by the Center for the Analysis of Strategies and Technologies, a Moscow-based defense think tank.

New Face, New Strategy

As part of its 20 million ruble (\$375,000) rebranding effort, Kalashnikov treated reporters and industry officials to a presentation that was part dramatic reading, part live-action film, and part flashy powerpoint.

Thin girls in ight dresses strutted around holding AK-47 ammunition magazine — which the company has embraced as a symbol of the brand — while a small orchestra played patriotic Russian wartime classics to set the mood.

As if the point wasn't made already, Kalashnikov's CEO was introduced by a sharp-looking young man wearing a Soviet officer's uniform from World War II. As he waxed nostalgic about the glorious triumphs of he Russian people, a lone spotlight illuminated his theatrical expressions.

When Krivoruchko finally took the stage to present the company's plan, he said the first priority was to raise production potential by modernizing aging production equipment. According to him, about 90 percent of the company's production infrastructure is outdated.

"Our total investment program stands at around 4 5 billion rubles [\$85 million]. By 2020, we will increase maximum production capacity twofold," he said. This would bring annual production levels to 300,000 a year.

But branding continued to be the primary focus of Kalashnikov's new look, demonstrated by video presentations showing off the new logos in action.

After an animated historical short about the history of Russian weapons manufacturing, which seemed to prominently show he menacing geographic reaches of the hated NATO alliance, attendees witnessed the new Kalashnikov brand in action as an ultra-elite team of special forces operators mercilessly tracked down and disposed of a band of Dagestani terrorists.

Kalashnikov's other brands were shown in a more tranquil light, as everyday hunters and sportsmen toted their rifles around the great outdoors.

The great tragedy of this new marketing campaign is that it is perfectly suited to U.S. consumers that Kalashnikov can no longer reach. The military heritage and sporty utility of its products would resonate with the fiercely independent U.S. gun-owner community.

"Kalashnikov was invented for the people, in the name of the people," Krivoruchko said in conclusion, making the case that the weapons help people protect heir sovereign rights.

Losing the West

But it was not all sunshine and roses at the conference. Journalists and company men were keenly aware of he blow dealt to Kalashnikov earlier this year by U.S. and EU sanc ions on the Russian defense industry.

Al hough Kalashnikov dominates 95 percent of Russia's domes ic small arms market, that market is tiny. Russian citizens are not allowed to own weapons wi hout a license.

Al hough Kalashnikov officials would not specify how much money was lost due to U.S. sanctions, Krivoruchko told reporters that because of the blacklis ing, "we were only able to export 40,000 weapons to the U.S."

A source close to Kalashnikov's export deal with the U.S.-based Russian Weapons Company told The Moscow Times on a condi ion of anonymity that "the losses are not calculable, but they are in he millions [of dollars]."

"Yes, we are having a hard time," said Rostec's Chemezov. "We have lost the American market, and most of our hunting products were sold to the U.S."

However, Kalashnikov and Rostec believe that he damage has been done and that he outlook for the company's future in he international market is already looking brighter. Sales lost to sanctions are being replaced by new markets — such as Malaysia and Thailand, where deals for civilian arms exports were signed last week.

All hough the terms of those agreements were not announced, Chemezov said "we have almost closed he gap."

Military Orders

But under the theatric surface of civilian oriented marketing and sales, the company is struggling to win Russian military contracts, which remain the mainstay of he company's business, according to Ruslan Pukhov, director of he Center for he Analysis of Strategies and Technologies, a Moscow-based think tank specializing in the Russian defense industry.

"The main challenge for Kalashnikov is not the small arms market, but missiles. This is their main source of revenue. They mass-produce missiles at their plant in Tula, and their des iny depends on future orders of these missiles," Pukhov said.

"Everything depends on whether or not these high-precision munitions will be successful in the global market and if the Russian army will buy into them," he said.

Kalashnikov also has important military contracts at stake in the field of rifles. It is bidding for contracts as part of the Russian Defense Ministry's Ratnik program — an analogue to the U.S. future warrior program, which seeks to develop a next generation "battlefield kit," or standard issue set of gear and weapons as part of the government's massive 20 trillion ruble (\$370 billion) rearmament campaign.

Weapons designer Mikhail Kalashnikov gave his name to the new joint company formed on the basis of "Izhmash" and "Izhmeh." Despite the fact that manufacturers were willing to offer Kalashnikov from one and a half to three million rubles for the use of his name as a brand name, Kalashnikov gave it for free.

"Mikhail Kalashnikov is a patriot, a true patriot. There was not a single word about some kind of payment," *Interfax* quoted Director General of JSC NPO Izhmash Konstantin Busygin, who made a

statement last Friday at a press conference. Busygin also added that the documents were signed back in February.

It is assumed that the new concern, known as "Kalashnikov", will bring together largest enterprises of the Russian defense industry to manufacture a wide range of ammunition under a single brand. The merger should be completed within the next three months. Upon its completion, the company will receive the name "Concern "Kalashnikov."

Negotiations with the Kalashnikov family started last year. At the time the entity was entitled to use the name of the designer only for certain types of military products. Meanwhile, it seemed appropriate to substantially expand the range as it would be beneficial both for the plant

HISTORY OVERVIEW

The holding company carries on the glorious history of an armoury founded in 1807 by the order of Emperor Alexander I. It manufactured most types of small arms in 19th and 20th centuries. During World War II, the total number of rifles and carbines manufactured by Izhevsk Weapons Plant exceeded total production of all German plants. During the two centuries, the company produced vast volumes of antitank rifles, aircraft machineguns, aircraft cannons, guns, handguns and other weapons.

After the WWII the plant launched mass production of Kalashnikov rifles that are still used by armies and special forces worldwide. Izhmash was established in 1975.

By 2008, Izhmash comprised over one hundred companies, some of which were on the verge of bankruptcy. In 2010, Russian Technologies carried out an audit which revealed a poor state of the holding company. Only 32 companies were actually operating with a multi-level management system, high overheads and doubled up functions. The combined liability of Izhmash in early 2011 was RUR 19 billion. The use of the existing modern equipment hardly exceeded 20%.

Russian Technologies took on the restructuring process through bankruptcy and merger. One of the objectives was to retain its research, industrial and human resources and to turn Izhmash into a leading global small arms manufacturer.

Izhmash was established in 2011 through assets consolidation, the process that finished in April 2012. As a result, there was a threefold increase in profits and a 10% cut in costs.

In a short time Izhmash managed to establish control over financial flows, improv production financing, payment systems and service of current payments.

In 2011, Izhmash increased the utilisation rate of modern multipurpose equipment from 20% to 70%. The effect from the efforts to enhance production performance amounts to RUR 100 million.

Izhmash revenues increased due to expanded distribution markets. In 2011, the company reached a 50% growth in supply to the US market which accounts for 65% of the global sports and hunting weapons market. Izhmash products are supplied to 27 countries, including the USA, Canada, Australia, Germany, Great Britain, Norway, Kazakhstan, Thailand, and South Africa.

Within 9 months from 2011, export to Germany increased 77%, export to the USA – 62% and export to Italy – 84%. The company cooperates with new partners in New Zealand and Ukraine.

IZHMASH today is producing fourth-generation Kalashnikov assault rifles – the 100-series AKs: AK -101, AK-102, AK-103, AK-104, AK-105. The company is also working on upgrades for the most ubiquitous assault rifle of the Russian Army: the Kalashnikov AK-74.

Senior Designer Vladimir Zlobin. While developing the Kalashnikov AK-12, designers have been able to achieve a significant improvement in the rifle's ergonomics and operating features, adapting it for the modern battlefield conditions while keeping its time-tested unique characteristics. Preliminary testing of AK-12 is now in progress, and the new rifle couldbe accepted for active service with the Russian military and law enforcers in 2014, at which point series (mass) production will begin. AK-12 will be platform for developing as many as 20 different versions of civilian and military rifles.

In April 2012, at the request of the Russian Practical Shooting Federation and working in close contact with competitive shooters, the IZHMASH R&D Technology Center designed the Saiga-12 Ver. 340 sporting shotgun. The Rostec team used the new shotgun to win the Russian practical shooting championship, also winning the silver medal at the most prestigious sporting shooting event in the world – the World Shotgun Championship.

Latest civilian sporting and hunting firearms include new versions of Los-10 and Los-11 ("Moose") hunting shotguns, Saiga-9 carbine (the civilian version of the Vityaz-SN submachine gun), Saiga-12 Ver. 340 for practical shooting, airsoft-modified Kalashnikov AK-74M for practice shooting and airsoft competition, and many other models.



'The famous weapons manufacturer had a slick rebranding' The Guardian said



Equipped with a shiny new logo and claiming its guns are "protecting peace", the Russian weapons manufacturer Kalashnikov launched a major rebranding drive in Moscow on Tuesday. Kalashnikov Concern, a new overarching brand that includes the famed assault rifles as well as hunting and sports weaponry, paid a leading Russian agency to design a new brand and renew its worldwide image.

"The Kalashnikov is a Russian symbol that is known across the world," said Alexei Krivoruchko, Kalashnikov's chief executive "The rebranding is a symbol of changes in the way our business works and our product lines that have been long in the making The new brand will reflect our main principles: reliability, responsibility and technological efficiency"

Sergei Chemezov, head of Rostec Corporation with a controlling stake in Kalashnikov, said he hoped the new brand would become as well known as Apple across the world

The company's most famous gun was developed by the Soviet engineer Mikhail Kalashnikov in 1947 and quickly became a mainstay of wars and civil conflicts across the world, known for its ease of use and reliability. The weapons are manufactured at a plant in Izhevsk, a city in Russia's Urals region

A slickly produced marketing video produced for the launch of the new brand describes the Kalashnikov as a "weapon of peace"



"The gun was made for the defence of a country that was living through the cold war and had to be prepared for a major intervention," says the video voiceover "The simple and reliable AK was also in demand well beyond the borders of the Soviet Union

"It precipitated not just a technological but a social revolution Freedom movements in Africa, Asia and Latin America could at last fight back against professional colonial armies The AK-47 gave them the chance to demand rights and achieve justice This is a weapon which helped people defend their families and futures, and demand the right to a peaceful future"

A second video features a reconstruction of a Russian special forces operation against terrorist suspects in the northern Caucasus, with dramatic music in the background and statistics flashing up about how many terrorists have been "liquidated" by Russian troops in recent years. It ends with the phrase: "Kalashnikov: promoting peace and calm"



Krivoruchko said on Tuesday that a huge contract to supply up to 200,000 weapons a year to the US and Canada is still on hold after Washington slapped sanctions on Russian defence companies including Kalashnikov over the summer, in response to Russia's actions in Ukraine The US accuses Russia of backing the insurgency in east Ukraine, where Kalashnikov rifles are used both by the insurgents and the Ukrainian forces

Kalashnikov was meant to supply between 80,000 and 200,000 sporting rifles and shotguns annually to a US importer for the next five years, under an agreement signed in January, but Krivoruchko said not a single gun had been delivered Instead, the firm is exploring new markets in Asia



Kalashnikov Concern was created by a merger of the Kalashnikov brand, Baikal hunting rifles and Izhmash sports rifles Kalashnikov Concern plans to release a range of sportswear and knives as well as its traditional lines of weaponry

Rostec to transfer the control over IMZ to private investors

The Corporation will retain a blocking stake



Andrey Bokarev will acquire 74.9% of IMZ (Izhevsky Mekhanichesky Zavod) shares owned by Rostec Corporation. The purchase price will be allocated for production modernization and reequipment of manufacturing funds. Rostec will retain controlling interest.

The purchase will be made after corporate approval procedures are fulfilled through additional IMZ shares emission and will have two stages. 51% of shares will pass to private investors the first quarter of 2015, and the rest of the stock will be purchased later. The shares will be acquired by one of the companies controlled by Bokarev.

Recently Rostec has revised the strategy of several holdings. Sporting gun and pistol manufacturer IMZ is a Corporation's non-core asset. The reequipment requires substantial investments, engineering processes need to be arranged. Market competences and private investor experience will contribute to the plant's sustainable development. However, Rostec will retain controlling interest.

The total price is to be defined after independent appraisal of IMZ value, 100% of which are owned by Rostec for now.

Andrey Bokarev has vast experience in the industrial production. Transmashholding co-owned by Andrey Bokarev manufactures diesel engines for submarines, mainline and industrial electric locomotives, main line and diesel-locomotive shunters, freight and passenger cars, electric trains and subway cars, car casting, diesel locomotive and marine engines, diesel-electric engines, components for railroad rolling stocks and city railroad transport.

The company's share in the Russian small arm market is about 50%. The plant produces a whole range of civilian weapons such as smoothbore and rifled hunting weapons, air rifles and pistols, sporting and service weapons, limit-target firearms. The most popular weapons are classical smoothbore hunting weapons, self-loading and air weapons.

The share of exports in the plant's revenues is over 25%. Key IMZ importers are Germany, Cyprus, the USA.

Today, IMZ is on the verge of unprofitableness. Revenues for 2013 were RUR 3 bln, loss – RUR 182 mln. The company needs to realize a large-scale investment program to drastically change the situation. New investors will help revive the plant.





The new CK: Kalashnikov unveils new brands, fashion range

Kalashnikov, Russia's legendary firearms producer, has revamped its corporate image, unveiling a new "CK" red-and-black logo – not to be

confused with Calvin Klein – a new slogan, three streamlined weapons brands and its own survival gear.

The Siberian weapons maker paid more than \$380,000 for the rebranding campaign, launched in a public presentation Tuesday.

The new Kalashnikov logo is a "CK" written in black and red and melded into a single block. The abbreviation stands for Kalashnikov Concern, as the producer now calls itself. The colors were borrowed from the flag of Udmurtia in western Siberia, the region hosting Kalashnikov's main facilities, the company said in a statement. The logo is accompanied by the company's name written in Russian.

The firearms producer also has a new slogan, or rather two different slogans. In English, it's "Protecting Peace," but in Russian it translates as "Weapons of Peace" or "Weapons of the World," depending on which meaning of the Russian word "mir" is used.



The ambiguity missed in the English version is meant to stress both the prevalence of Kalashnikov firearms in the world and its producer's mission to provide nations and individuals with the means to protect themselves.

Kalashnikov revamped the three brands of firearms it produces for military, civilian and sports weapons. The most famous military brand remains eponymous to the producer, but gets a new logo as well. Now Kalashnikov rifles sold to armies and police will be marked with a K, containing the distinctive image of a curved Kalashnikov rifle magazine.

"Kalashnikov is a legendary weapon known throughout the world," said Tina Kandelaki, the TV presenter who heads the PR firm that developed Kalashnikov's new brand. "For our country Kalashnikov is one of the national symbols. That's why we worked on rebranding the company with pride and realization of the responsibility we took upon us."

The concern wants to use its new brand to expand its presence on both domestic and international markets through better product recognition. In addition to firearms, it plans to sell Kalashnikov-branded survival gear, including hunting knives and outfits.

MOSCOW, September 23 (RIA Novosti) – State-owned Russian Technologies, or Rostec, confirmed on Monday the sale of a 49 percent stake in arms maker Kalashnikov Corporation to private investors for 2.5 billion rubles (\$75 million).

The stake has gone to a joint venture set up by Andrei Bochkarev, co-owner of Transmashinkholding and Kuzbassrazrezugol, and Alexei Krivoruchko, head of Aeroexpress, Rostec said in a statement.

Rostec will retain a 51 percent stake in the corporation. The 2.5 billion rubles will be invested within the next two years and spent on development projects, Rostec said.


The deal has received President Vladimir Putin's blessing, according to a defense industry source cited by the Kommersant newspaper.

The investment should pay back within five years, Krivoruchko was quoted by Kommersant as saying.

"Our plans include a significant increase in manufacturing capacity. In particular, we are interested in establishing joint ventures with foreign partners for the production of gunpowder and ammunition," he said.

Russia's Izhmash arms factory, manufacturer of the legendary Kalashnikov assault rifle, was renamed Kalashnikov Corporation in mid-August and will soon integrate several other defense plants into the new holding. It will include Izhmash, Izhmekh and some other small-arms manufacturers under the famed Kalashnikov brand.

Izhmash produces over 70 types of weapons, including firearms, aircraft guns, and artillery shells, as well as a variety of sporting and hunting weapons. The company won a \$400

million Russian government contract in July to produce Vikhr anti-armor missiles. Izhmekh is best known for its Makarov and Yarygin pistols.

However, both companies have been recently experiencing financial difficulties and a sharp drop in production output. The government is now hoping to revive them by merging them under the new brand

Mikhail Kalashnikov, 93, the designer of the Kalashnikov assault rifle, personally authorized the use of his name for the new corporation in February.



HISTORY OVERVIEW

The holding company carries on the glorious history of an armoury founded in 1807 by the order of Emperor Alexander I. It manufactured most types of small arms in 19th and 20th centuries. During World War II, the total number of rifles and carbines manufactured by Izhevsk Weapons Plant exceeded total production of all German plants. During the two centuries, the company produced vast volumes of antitank rifles, aircraft machineguns, aircraft cannons, guns, handguns and other weapons.

After the WWII the plant launched mass production of Kalashnikov rifles that are still used by armies and special forces worldwide. Izhmash was established in 1975.

By 2008, Izhmash comprised over one hundred companies, some of which were on the verge of bankruptcy. In 2010, Russian Technologies carried out an audit which revealed a poor state of the holding company. Only 32 companies were actually operating with a multi-level management system, high overheads and doubled up functions. The combined liability of Izhmash in early 2011 was RUR 19 billion. Russian Technologies took on the restructuring process through bankruptcy and merger. One of the objectives was to retain its research, industrial and human resources and to turn Izhmash into a leading global small arms manufacturer.

Izhmash was established in 2011 through assets consolidation, the process that finished in April 2012. As a result, there was a threefold increase in profits and a 10% cut in costs.

In a short time Izhmash managed to establish control over financial flows, improv production financing, payment systems and service of current payments.

While developing the Kalashnikov AK-12, designers have been able to achieve a significant improvement in the rifle's ergonomics and operating features, adapting it for the modern battlefield conditions while keeping its time-tested unique characteristics. Preliminary testing of AK-12 is now in progress, and the new rifle couldbe accepted for active service with the Russian military and law enforcers in 2014, at which point series (mass) production will begin. AK-12 will be platform for developing as many as 20 different versions of civilian and military rifles.

In April 2012, at the request of the Russian Practical Shooting Federation and working in close contact with competitive shooters, the IZHMASH R&D Technology Center designed the Saiga-12 Ver. 340 sporting shotgun. Kalashnikov for free

Weapons designer Mikhail Kalashnikov gave his name to the new joint company formed on the basis of "Izhmash" and "Izhmeh." Despite the fact that manufacturers were willing to offer Kalashnikov from one and a half to three million rubles for the use of his name as a brand name, Kalashnikov gave it for free.

"Mikhail Kalashnikov is a patriot, a true patriot. There was not a single word about some kind of payment," *Interfax* quoted Director General of JSC NPO Izhmash Konstantin Busygin, who made a

statement last Friday at a press conference. Busygin also added that the documents were signed back in February.

It is assumed that the new concern, known as "Kalashnikov", will bring together largest enterprises of the Russian defense industry to manufacture a wide range of ammunition under a single brand. The merger should be completed within the next three months. Upon its completion, the company will receive the name "Concern "Kalashnikov."

Negotiations with the Kalashnikov family started last year. At the time the entity was entitled to use the name of the designer only for certain types of military products. Meanwhile, it seemed appropriate to substantially expand the range as it would be beneficial both for the plant

and Mikhail Kalashnikov, because the company would provide him with a steady income through the sale of products manufactured under his name. At the very least, this was the goal declared by "Izhmash". Now, however, the concern seems to be pleased with Kalashnikov's patriotism

that allowed the company to avoid paying him. It was noted earlier that the brand value of "Kalashnikov" was estimated at \$10 billion.

Mikhail Kalashnikov is a unique individual. Seventeenth child from a peasant family, Kalashnikov is now 93, and is famous around the globe. Since 1999, he has had the rank of lieutenant-general. Upon arrival somewhere with a visit, he is greeted like a movie star. Meanwhile, Kalashnikov lives in an ordinary house with no elevator, very modestly, without frills. He is nearly deaf because of trauma developed in shooting galleries and ranges during countless tests of his inventions. Despite the incredible demand for Kalashnikov's inventions, his design activities did not make him wealthy. This is not because Mikhail Kalashnikov failed to take advantage of the opportunities available to him, but because he did not want to do it. In the same way he did not use the opportunity to capitalize on his name, instead giving it as a gift.

Izhevsk Machine-Building Plant (NPO "Izhmash") produces various types of military firearms, sporting and hunting guns, air guns, precision-guided artillery shells, control systems, as well as machines and high-quality tools. There are Kalashnikovs among its products, in particular, modernized Kalashnikov, AK-74M, AK-9, and "one-hundredth-series" Kalashnikovs.

Izhevsk Mechanical Plant (JSC "Izhmeh") is also engaged in production of weapons, both civilian and service ones. In addition, the plant produces power tools, packaging equipment, gas equipment, medical equipment and precise steel castings. However, the basis of its production is still military and hunting weapons. In particular, "Izhmeh" produces the most common hunting rifle in Russia - IZH-27.

In addition to these two major companies, it is assumed that Kalashnikov company will also include other large entities. In particular, Vyatsko-Polyansky plant "Molot", located in the Kirov region. This company also manufactures military and civilian arms, including Kalashnikov RPK light machine gun and Kalashnikov RPK-74machine gun.

Rostec to transfer the control over IMZ to private investors

The Corporation will retain a blocking stake



Andrey Bokarev will acquire 74.9% of IMZ (Izhevsky Mekhanichesky Zavod) shares owned by Rostec Corporation. The purchase price will be allocated for production modernization and reequipment of manufacturing funds. Rostec will retain controlling interest.

The purchase will be made after corporate approval procedures are fulfilled through additional IMZ shares emission and will have two stages, 51% of shares will pass to private investors the first quarter of 2015, and the rest of the stock will be purchased later. The shares will be acquired by one of the companies controlled by Bokarev.

Recently Rostec has revised the strategy of several holdings. Sporting gun and pistol manufacturer IMZ is a Corporation's non-core asset. The reequipment requires substantial investments, engineering processes need to be arranged. Market competences and private investor experience will contribute to the plant's sustainable development. However, Rostec will retain controlling interest.

The total price is to be defined after independent appraisal of IMZ value, 100% of which are owned by Rostec for now.

Andrey Bokarev has vast experience in the industrial production. Transmashholding co-owned by Andrey Bokarey manufactures diesel engines for submarines, mainline and industrial electric locomotives, main line and diesel-locomotive shunters, freight and passenger cars, electric trains and subway cars, car casting, diesel locomotive and marine engines, diesel-electric engines, components for railroad rolling stocks and city railroad transport.

The company's share in the Russian small arm market is about 50%. The plant produces a whole range of civilian weapons such as smoothbore and rifled hunting weapons, air rifles and pistols, sporting and service weapons, limit-target firearms. The most popular weapons are classical smoothbore hunting weapons, self-loading and air weapons.

The share of exports in the plant's revenues is over 25%. Key IMZ importers are Germany, Cyprus, the USA.

Today, IMZ is on the verge of unprofitableness. Revenues for 2013 were RUR 3 bln, loss – RUR 182 mln. The company needs to realize a large-scale investment program to drastically change the situation. New investors will help revive the plant.





'The famous weapons manufacturer had a slick rebranding' The Guardian said



Equipped with a shiny new logo and claiming its guns are "protecting peace", the Russian weapons manufacturer Kalashnikov launched a major rebranding drive in Moscow on Tuesday. Kalashnikov Concern, a new overarching brand that includes the famed assault rifles as well as hunting and sports weaponry, paid a leading Russian agency to design a new brand and renew its worldwide image.

"The Kalashnikov is a Russian symbol that is known across the world," said Alexei Krivoruchko, Kalashnikov's chief executive "The rebranding is a symbol of changes in the way our business works and our product lines that have been long in the making. The new brand will reflect our main principles: reliability,

Sergei Chemezov, head of Rostec Corporation with a controlling stake in Kalashnikov, said he hoped the new brand would become as well known as Apple across the world

The company's most famous gun was developed by the Soviet engineer Mikhail Kalashnikov in 1947 and quickly became a mainstay of wars and civil conflicts across the world, known for its ease of use and reliability. The weapons are manufactured at a plant in Izhevsk, a city in Russia's Urals region

A slickly produced marketing video produced for the launch of the new brand describes the Kalashnikov as a "weapon of peace"



"The gun was made for the defence of a country that was living through the cold war and had to be prepared for a major intervention," says the video voiceover "The simple and reliable AK was also in demand well beyond the borders of the Soviet Union

"It precipitated not just a technological but a social revolution Freedom movements in Africa, Asia and Latin America could at last fight back against professional colonial armies The AK-47 gave them the chance to demand rights and achieve justice This is a weapon which helped people defend their families and futures, and demand the right to a peaceful future"

A second video features a reconstruction of a Russian special forces operation against terrorist suspects in the northern Caucasus, with dramatic music in the background and statistics flashing up about how many terrorists have been "liquidated" by Russian troops in recent years. It ends with the phrase: "Kalashnikov: promoting peace and calm"



Krivoruchko said on Tuesday that a huge contract to supply up to 200,000 weapons a year to the US and Canada is still on hold after Washington slapped sanctions on Russian defence companies including Kalashnikov over the summer, in response to Russia's actions in Ukraine The US accuses Russia of backing the insurgency in east Ukraine, where Kalashnikov rifles are used both by the insurgents and the Ukrainian forces

Kalashnikov was meant to supply between 80,000 and 200,000 sporting rifles and shotguns annually to a US importer for the next five years, under an agreement signed in January, but Krivoruchko said not a single gun had been delivered Instead, the firm is exploring new markets in Asia



Kalashnikov Concern was created by a merger of the Kalashnikov brand, Baikal hunting rifles and Izhmash sports rifles Kalashnikov Concern plans to release a range of sportswear and knives as well as its traditional lines of weaponry



Kalashnikov Corp. Sells 49% Stake for \$75M – Rostec

State-owned Russian Technologies, or Rostec, confirmed on Monday the sale of a 49 percent stake in arms maker Kalashnikov Corporation to private investors for 2.5 billion rubles (\$75 million).

MOSCOW, September 23 (RIA Novosti) – State-owned Russian Technologies, or Rostec, confirmed on Monday the sale of a 49 percent stake in arms maker Kalashnikov Corporation to private investors for 2.5 billion rubles (\$75 million).

The stake has gone to a joint venture set up by Andrei Bochkarev, co-owner of Transmashinkholding and Kuzbassrazrezugol, and Alexei Krivoruchko, head of Aeroexpress, Rostec said in a statement.

Rostec will retain a 51 percent stake in the corporation. The 2.5 billion rubles will be invested within the next two years and spent on development projects, Rostec said.


The deal has received President Vladimir Putin's blessing, according to a defense industry source cited by the Kommersant newspaper.

The investment should pay back within five years, Krivoruchko was quoted by Kommersant as saying.

"Our plans include a significant increase in manufacturing capacity. In particular, we are interested in establishing joint ventures with foreign partners for the production of gunpowder and ammunition," he said.

Russia's Izhmash arms factory, manufacturer of the legendary Kalashnikov assault rifle, was renamed Kalashnikov Corporation in mid-August and will soon integrate several other defense plants into the new holding. It will include Izhmash, Izhmekh and some other small-arms manufacturers under the famed Kalashnikov brand.

Izhmash produces over 70 types of weapons, including firearms, aircraft guns, and artillery shells, as well as a variety of sporting and hunting weapons. The company won a \$400

million Russian government contract in July to produce Vikhr anti-armor missiles. Izhmekh is best known for its Makarov and Yarygin pistols.

However, both companies have been recently experiencing financial difficulties and a sharp drop in production output. The government is now hoping to revive them by merging them under the new brand

Mikhail Kalashnikov, 93, the designer of the Kalashnikov assault rifle, personally authorized the use of his name for the new corporation in February.
