Dear Mr. Greenewald:

This is the final response to your March 5, 2017 Freedom of Information Act (FOIA) request, a copy of which is enclosed for your convenience. We received your request on March 6, 2017 and assigned it case number 17-F-0648. We ask that you use this number when referring to your request.

The Office of Cost Assessment and Program Evaluation (CAPE), a component of the Office of the Secretary of Defense (OSD), conducted a search of their records systems based on the information provided in your request. After thorough searches of the electronic records and files of CAPE, no records of the kind you described could be identified. We believe that these search methods were appropriate and could reasonably be expected to produce the requested records if they existed.

In this instance, fees for processing your request were below the threshold for requiring payment. Please note that fees may be assessed on future requests.
