Dear Mr. Greenewald,

This is our final response to your 16 May 2020 Freedom of Information Act request for the following:

1) All emails sent to/from (bcc'd or cc'd) USAF Spokesperson Malinda Singleton, with the e-mail of malinda.singleton.mil@email.mil (include all other email address that may be different utilized by Malinda Singleton), which contain the following phrases:

"Unidentified Aerial Phenomena" and/or "Unidentified Aerial Phenomenon" and/or "UAP"

The Secretary of the Air Force Public Affairs (SAF/PA) office reviewed your request and determined the attached documents are being released to you in part with some information withheld under Title 5 U.S.C, Section 552 FOIA Exemption (b)(6). Exemption (b)(6) requires withholding of information in personnel, medical, and similar files where disclosure "would constitute a clearly unwarranted invasion of personal privacy."

Should you decide that an appeal to this response is necessary, you must write to the Secretary of the Air Force, Thru: SAF/AII (FOIA), 1000 Air Force Pentagon, Washington DC 20330-1000, within 90 calendar days from the date of this letter. Include in the appeal, your reasons for reconsideration, and attach a copy of this letter.

The Navy has confirmed that the three videos that are in wide circulation are indeed recordings made by naval aviators, recorded during their training evolutions. The Navy has always considered the phenomena observed in those videos as unidentified.

These three sightings/observations, however, are part of a larger issue of an increased number of training range incursions by unidentified aerial phenomena in recent years. DOD and all the services take these reports very seriously and investigate each and every report. Any incursion into military air space or training ranges by any aircraft, identified or not identified, is problematic from both a safety and security concern. Safety of our aircrews is paramount. Unauthorized and unidentified aircraft pose a risk to flight safety. Additionally, it is vital we maintain security on our operations. Our aviators train as they fight. Any intrusions that may compromise the security of our

operations, tactics or procedures is of great concern.

You may attribute the above to me. Please let me know if you have any further questions.

We received a query from The Drive regarding UAP/UFO sightings off the coast of VA. This is based off of the stories that came out last week when the Navy's FOIA office released video of these sightings. Here is the NBC story that ran last week - <https://www.nbcnews.com/news/us-news/navy-confirms-videos-did-capture-ufo-sightings-it-calls-them-n1056201>.

The Drive came and asked us if the F-22s and T-38s at JBLE saw something similar during the timeframe that the aircrews at Oceana said they had a higher rate of sightings (2014-2015). Could you please check into it?

- Navy Super Hornet pilots out of NAS Oceana had *constant* encounters with these objects in 2014-2015, especially on radar. It got so bad that by early 2015 Oceana filed NOTAMs warning aviators about the phenomenon in the warning areas off Virginia. We have talked to the crews directly about this and are in the process of obtaining those NOTAMs and the paper trail leading to their posting. Langley's F-22s, which have superior sensor capabilities in some respects to the Super Hornets, as well the base's T-38 aggressors, are based right next-door and use the exact same warning areas for training daily. Did Langley aircrews experience the same phenomenon? If so to what extent? What about other USAF assets that use the same airspace for training?

In addition, OSD has taken the lead on all these types of queries – so if you do get any, please send them up there. The caveat being that we'll probably need your help to get the information 😊.

Thanks for grabbing the call today. Here is what we are looking for on the ongoing UFO/UAP story with the Navy and the USAF's position and comment on the issue:

- Have Air Force pilots encountered any similar unexplained phenomenon on radar, electro-optically, or visually? If so, what is the general frequency and magnitude of these events?
- Navy Super Hornet pilots out of NAS Oceana had *constant* encounters with these objects in 2014-2015, especially on radar. It got so bad that by early 2015 Oceana filed NOTAMs warning aviators about the phenomenon in the warning areas off Virginia. We have talked to the crews directly about this and are in the process of obtaining those NOTAMs and the paper trail leading to their posting. Langley's F-22s, which have superior sensor capabilities in some respects to the Super Hornets, as well the base's T-38 aggressors, are based

right next-door and use the exact same warning areas for training daily. Did Langley aircrews experience the same phenomenon? If so to what extent? What about other USAF assets that use the same airspace for training?

- The Navy changed their reporting practices and procedures for encounters with unexplained flying objects significantly due to the massive increase in incidents in recent years. Has the Air Force done the same? If not, why? Does it even have set procedures for these events? If so, what are they?
