Dear Mr. Greenwald

This letter is in reference to your Freedom of Information Act (FOIA) request dated 26 January 2021 for records pertaining to the use of the Extrasensory Perception (ESP). We received your FOIA request and assigned case number 2021-01266-F to it.

A review of the record you requested was conducted under the FOIA to determine if the document that you requested is releasable. It was determined that the document was properly classified at the time of its creation and currently remains properly classified in accordance with Executive Order 13526. Unauthorized release could cause serious damage to national security. There are no reasonably segregable portions that we can release. Consequently the release of this information is denied pursuant to 5 U.S.C. Section 552(b)(1).

Should you decide that an appeal to this decision is necessary, you must write to the Secretary of the Air Force within 90 calendar days from the date of this letter. Include in your appeal any reasons for reconsideration you wish to present and attach a copy of this letter. The appeal should be forwarded to:
