This letter is in response to your Freedom of Information Act (FOIA) case 2023-01352-F, to obtain copies of all emails, with any level of classification which contain the following keywords: "Unidentified Aerial" and/or "unidentified anomalous" and/or "Area 51" and/or "Dreamland" with emails specifically from the spokesperson Nellis Air Force Base. The records you have requested are being provided to you, with all personal information withheld under FOIA Exemption 6 (b)(6). Release of personal information "would constitute a clearly unwarranted invasion of personal privacy."

If you disagree and interpret this response as an adverse action, you may write to the Secretary of the Air Force, Through: Nellis AFB FOIA, 5870 Devlin Drive, Nellis AFB NV 89191, within 90 calendar days from the date of this letter. Include in the appeal your reasons for reconsideration and attach a copy of this letter. You may also submit your appeal on-line at the Air Force Public Access Link, https://www.efoia.af.mil/palMain.aspx.

Perhaps she did not realize she confirmed the operation (raids at two houses owned by the Area 51 webmaster, etc), and got in hot water with her boss. She specifically told me to use (b)(6) as "Nellis spokesperson" to confirm on the record what I described to her. It's obvious what she was confirming.

I was frankly surprised that the Air Force did confirm it while the FBI not surprisingly rebuffed our inquiry. However, I stand by what I reported, as she acknowledged what I related to her and asked me to attribute it to the lieutenant.


Hello everyone!

I know this email is asking something that has always been an impossible request but I do think now is the right time to venture in this direction. Of course I'm aware that no journalist has ever been able to gain access to the Nevada Test and Training Range but I really wanted to start a dialogue with you about how to make this happen. Could I schedule a phone call to discuss?

The topic of UAPs is being so widely discussed right now and is only becoming an even bigger topic of tension and conspiracy. The fact of the matter is that there is SOMETHING people are seeing in our air space and this is dangerous to our air traffic. We maintain canned response-to-query statements for various questions about the NTTR, which we've compiled to answer this one and mitigate follow-ups:

---BEGIN---

The U.S. Air Force does not label or refer to any area on the Nevada Test and Training Range as Area 51. The term "Area 51" comes from declassified Central Intelligence Agency documents, which refer to the area around Groom Lake as "Area 51." Groom Lake is physically located within the borders of the Nevada Test and Training Range.

Several agencies have jurisdiction over various parts of the Nevada Test and Training Range. The U.S. Air Force controls the airspace over the range and roughly 2.9 million acres of land withdrawn for military use. Various organizations including the Department of Energy, Department of the Interior and private towns such as Rachel also manage portions of the land. ---END---
