Dear Requester:

This is the final response to your Freedom of Information Act (FOIA) request, originally received by the United States Secret Service (Secret Service) on July 14, 2023, for a copy of records (which includes videos/photos), electronic or otherwise, pertaining to the recent investigation into cocaine found at the White House on or around July 2, 2023.

After a detailed review of all potentially responsive records, 112 pages were released and 34 pages were withheld in their entirety. After considering the "Foreseeable Harm" standard, outlined in Title 5 U.S.C § 552(a)(8)(A)(i) and Department of Justice guidance, exemptions under FOIA Statute Title 5 U.S.C. § 552, and/or the PA Statute Title 5 U.S.C. § 552a, have been applied where deemed appropriate.

Enclosed are the documents responsive to your request, as well as a document that explains the exemptions in more detail. Withheld information is pursuant to the exemptions marked below.

**FREEDOM OF INFORMATION ACT

Media reports said the DCFD field test indicated the substance was cocaine.

A small amount of a white powdery substance was found in the White House on Sunday evening, according to a person familiar with the episode, and an initial test by emergency response workers determined that it was cocaine.

President Biden and his family were away at Camp David when a uniformed Secret Service agent found the substance during a patrol of the West Wing around 6 p.m. on Sunday, the person said, prompting a brief shutdown of some of the White House campus as response workers assessed whether the substance was hazardous.

Later that evening, a test of the substance by hazmat crew officials returned a result: “We have a yellow bar saying cocaine hydrochloride,” an official said on a dispatch sent at 8:49 p.m. and logged by a website that gathers the agency’s radio communications.

A person familiar with the investigation, who spoke on the condition of anonymity to discuss an open inquiry, said that the radio dispatch discussing the test of the substance was placed

between the District of Columbia Fire Department's hazmat team and other officials within the department.

Anthony Guglielmi, a spokesman for the Secret Service, said that the substance had been found in a "work area of the West Wing" and that another dispatch that said the substance had been found in a White House library was incorrect.

In a statement, Mr. Guglielmi said "the item was sent for further evaluation and an investigation into the cause and manner of how it entered the White House is pending."

He did not confirm or dispute the initial finding that the powder was cocaine.

Vito Maggiolo, a spokesman for the District of Columbia Fire Department, declined to confirm the contents of any of the dispatches, but said officials with the department "were requested to assist the Secret Service as they conducted an investigation."

On Tuesday morning, Mr. Biden returned to the White House with several of his family members.

WASHINGTON - On the evening of July 2, officers from the U.S. Secret Service Uniformed Division found an unknown substance inside a vestibule leading to the lobby area of the West Executive Avenue entrance to the White House.

The substance was located inside a receptacle used to temporarily store electronic and personal devices prior to entering the West Wing.

Following the discovery, safety closures were implemented around the White House. This response was designed to ensure that the found substance was not a biological or radiological material that threatened the security of the White House. As such, the substance was field tested and determined to not be a hazardous compound.

Testing conducted by the District of Columbia Fire and Emergency Medical Services Department indicated that the found powder tested preliminarily positive for the presence of cocaine. The substance and packaging was treated as evidence and sent to the U.S. Department of Homeland Security's National Biodefense Analysis and Countermeasures Center, which analyzed the item for any biothreats. Tests conducted at this facility came back negative and gave formal confirmation that the substance was not biological in nature.

The substance and packaging underwent further forensic testing. The substance was analyzed for its chemical composition. The packaging was subjected to advanced fingerprint and DNA analysis. Both of these analyses were conducted by the Federal Bureau of Investigation's crime laboratory given their expertise in this area and independence from the investigation.

While awaiting the FBI's results, the Secret Service investigation into how this item entered the White House continued. The investigation included a methodical review of security systems and protocols. This review included a backwards examination that spanned several days prior to the discovery of the substance and developed an index of several hundred individuals who may have accessed the area where the substance was found. The focal point of these actions developed a pool of known persons for comparison of forensic evidence gleaned from the FBI's analysis of the substance's packaging.

On July 12, the Secret Service received the FBI's laboratory results, which did not develop latent fingerprints and insufficient DNA was present for investigative comparisons. Therefore, the Secret Service is not able to compare evidence against the known pool of individuals. The FBI's evaluation of the substance also confirmed that it was cocaine.

There was no surveillance video footage found that provided investigative leads or any other means for investigators to identify who may have deposited the found substance in this area. Without physical evidence, the investigation will not be able to single out a person of interest from the hundreds of individuals who passed through the vestibule where the cocaine was discovered.

WASHINGTON (AP) — No fingerprints or DNA turned up on the baggie of cocaine found in a lobby at the White House last week despite a sophisticated FBI crime lab analysis and surveillance footage of the area didn't identify a suspect, according to a summary of the Secret Service investigation obtained by The Associated Press. There are no leads on who brought the drugs into the building.

U.S. Secret Service agents found the white powder during a routine White House sweep on July 2, in a heavily trafficked West Wing lobby where staff go in and out, and tour groups gather to drop their phones and other belongings.

“Without physical evidence, the investigation will not be able to single out a person of interest from the hundreds of individuals who passed through the vestibule where the cocaine was discovered,” Secret Service  is said in the summary.

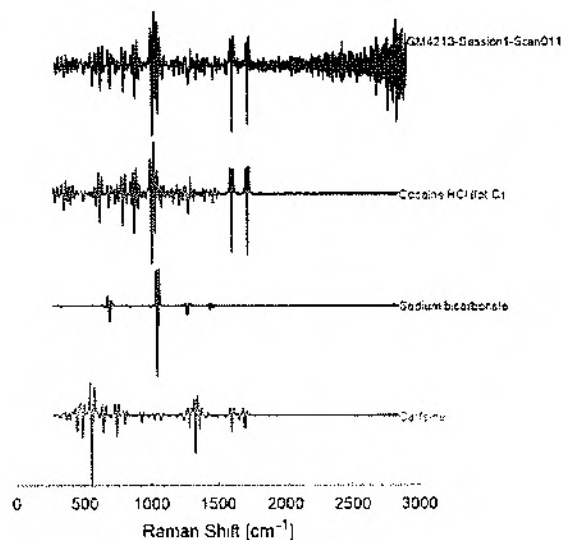

A small amount of a white powdery substance was found in the White House on Sunday evening, according to a person familiar with the episode, and an initial test by emergency response workers determined that it was cocaine.

President Biden and his family were away at Camp David when a uniformed Secret Service agent found the substance during a patrol of the West Wing around 6 p.m. on Sunday, the person said, prompting a brief shutdown of some of the White House campus as response workers assessed whether the substance was hazardous.

Later that evening, a test of the substance by hazmat crew officials returned a result: “We have a yellow bar saying cocaine hydrochloride,” an official said on a dispatch sent at 8:49 p.m. and logged by a website that gathers the agency’s radio communications.

A person familiar with the investigation, who spoke on the condition of anonymity to discuss an open inquiry, said that the radio dispatch discussing the test of the substance was placed between the District of Columbia Fire Department's hazmat team and other officials within the department.

Anthony Guglielmi, a spokesman for the Secret Service, said that the substance had been found in a "work area of the West Wing" and that another dispatch that said the substance had been found in a White House library was incorrect.

In a statement, Mr. Guglielmi said "the item was sent for further evaluation and an investigation into the cause and manner of how it entered the White House is pending."

He did not confirm or dispute the initial finding that the powder was cocaine.

Vito Maggiolo, a spokesman for the District of Columbia Fire Department, declined to confirm the contents of any of the dispatches, but said officials with the department "were requested to assist the Secret Service as they conducted an investigation."

On Tuesday morning, Mr. Biden returned to the White House with several of his family members.

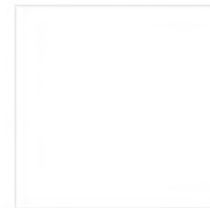
