Dear Requester:

This is the final response to your Freedom of Information Act (FOIA) request, originally received by the United States Secret Service (Secret Service) on July 10, 2024, for: 1) a copy of the 67 page report submitted to the U.S. Secret Service by the campaign of Robert F. Kennedy Jr. as referenced in this July 28, 2023, tweet by Mr. Kennedy:

https://twitter.com/RobertKennedyJr/status/1684909385376575488; and, 2) any correspondence with the Kennedy campaign staff, lawyers, or Kennedy himself regarding his secret service protection.

After a detailed review of all potentially responsive records, 45 pages were released and no pages were withheld in their entirety. After considering the "Foreseeable Harm" standard, outlined in Title 5 U.S.C § 552(a)(8)(A)(i) and Department of Justice guidance, exemptions under FOIA Statute Title 5 U.S.C. § 552, and/or the PA Statute Title 5 U.S.C. § 552a, have been applied where deemed appropriate.

Enclosed are the documents responsive to your request, as well as a document that explains the exemptions in more detail. Withheld information is pursuant to the exemptions marked below.

Please note that contacting the Secret Service's FOIA Program and/or OGIS **is not** an alternative to filing an administrative appeal and **does not** stop the 90-day appeal clock. # FREEDOM OF INFORMATION ACT SUBSECTIONS OF TITLE 5, UNITED STATES CODE, SECTION 552

#### Provisions of the Freedom of Information Act do not apply to matters that are:

- (b) (1) (A) specifically authorized under criteria established by an Executive Order to be kept Secret in the interest of national defense or foreign policy; and (B) are in fact properly classified pursuant to such Executive Order;

- (b) (7) records or information compiled for law enforcement purposes, but only to the extent that the information: (A) could reasonably be expected to interfere with enforcement proceedings; (B) would deprive a person of a right to a fair trial or an impartial adjudication; (C) could reasonably be expected to constitute an unwarranted invasion of personal privacy; (D) could reasonably be expected to disclose the identity of a confidential source, including a State, local, foreign agency or authority, or any private institution that furnished information on a confidential basis, and/or when records/information compiled by a criminal law enforcement authority in the course of a criminal investigation, or by an agency conducting a lawful national security intelligence investigation, information furnished by a confidential source; (E) would disclose techniques and procedures for law enforcement investigations or prosecutions, or would disclose guidelines for law enforcement investigations or prosecutions if such disclosure could reasonably be expected to risk circumvention of the law; (F) could reasonably be expected to endanger the life or physical safety of any individual;
- (b) (8) contained in or related to examination, operating, or condition reports prepared by, on behalf of, or for the use of an agency responsible for regulation or supervision of financial institutions; and
- (b) (9) geological and geophysical information and data, including maps, concerning wells.



submitted by Candidate Robert F. Kennedy Jr. This feedback from the full Committee is required to

resolve this request. In lieu of numerous responses, I would like to submit Monday, 4pm. This will be a virtual event. I will send an invitation shortly.



# **Candidate Protection Advisory Committee Guidelines**

"Pursuant to 18 U.S.C. 3056(a)(7), the Secretary of Homeland Security is responsible for determining," after consultation with the aforementioned Congressional advisory committee, "those persons who qualify as major Presidential or Vice Presidential candidates and should receive Secret Service protection. These guidelines are intended to assist the Secretary in determining, and the Committee in advising, who are the Major Candidates that receive Secret Service protection."

"Nothing in these Guidelines shall preclude the Secretary, after consultation with the Committee, from authorizing, declining to authorize, or withdrawing protection for a candidate on a case-by-case basis, depending upon circumstances, provided it is within the Secretary's statutory authority to act."

"Protection under these guidelines should only be granted within one year prior to the general election (*November 3, 2020*). Protection more than one year prior to the general election should only be granted in extraordinary, case-by-case circumstances in consultation with the Committee, based on threat assessment and other factors."

When determining whether a candidate for the Office of President or Vice President of the United States qualifies as a major candidate, the Secretary has broad discretion and may consider a variety of factors. These factors include, but are not limited to:

- 1. The candidate has publicly announced his or her candidacy and has filed the appropriate documentation with the Federal Election Commission (FEC);
- 2. The candidate is actively campaigning on a national basis for the office for which his or her candidacy has been announced, as demonstrated by operating a national campaign apparatus, regularly appearing at public events in multiple states, producing and publishing campaign advertisements, and other similar indicia of a campaign;
- 3. A threat assessment conducted by the USSS of general or specific threats directed towards the candidate (for these purposes, "threats" should be defined as explicit threats of bodily harm to the candidate or indications of inappropriate behavior towards the candidate suggesting potential bodily harm);
- 4. Whether, during and within an active and competitive major party primary, the most recent average of established national polls, as reflected by the Real Clear Politics National Average or similar mechanism, the candidate is polling at 15% or more for 30 consecutive days;
- 5. Whether the candidate is the formal or de facto nominee of a major party for President or Vice President;
- 6. Whether the candidate is an independent or third party candidate for President polling at 20% or more of the Real Clear Politics National Average for 30 consecutive days;
- 7. Whether the candidate is the Vice Presidential running mate of the above independent or third party candidate



# **RISK ENVIRONMENT**

Robert F. Kennedy Jr.'s public profile has increased since announcing his candidacy for the 2024 presidential election. All presidential candidates are inherently at risk for adverse attention due to the public, high-profile nature of the election (b)(7)(E)

Robert F. Kennedy Jr. is the son of former Attorney General Robert F. Kennedy—who was assassinated while a presidential candidate in 1968—and the nephew of former President John F. Kennedy and former Senator Ted Kennedy. Kennedy is an environmental lawyer and children's health advocate. He founded the world's largest clean water advocacy group, Waterkeeper Alliance, and the nonprofit Children's Health Defense. Kennedy is also an author, having published several books and articles for national newspapers about the science of vaccines and the environment.

On April 5, 2023, Kennedy announced his candidacy for the Democratic presidential nomination in 2024, making him the fourth member of his family to pursue the presidency. Kennedy

acknowledged his controversial opinions during his announcement speech, stating "I am not the ideal presidential candidate." Kennedy went on to explain the goal of his campaign and potential presidency would be to "end the corrupt merger of state and corporate power."

News media reporting and social media chatter have highlighted the assassination of Kennedy's father and uncle in relation to his decision to run for president. Many comments suggested that, for no other reason than that he is a Kennedy, he would be at risk of assassination. In May 2023, Kennedy received increased media attention after accusing the CIA of involvement in the assassination of his uncle. Kennedy has advocated for the release of the individual currently imprisoned for assassinating his father, Sirhan Sirhan, because he believes a CIA contractor was responsible for the death.

Kennedy has received both support and criticism for his stance on vaccines and has been described as an anti-vaccine activist. Kennedy has rejected this notion, insisting rather that he is a proponent for safe vaccines. For decades, Kennedy has lobbied against the use of a mercury-based preservative in vaccines because he alleges it is linked to autism. Kennedy remained in the public spotlight throughout the COVID-19 pandemic due to his vocal opposition to COVID-19 vaccines. In 2021 he published a book, *The Real Anthony Fauci: Bill Gates, Big Pharma, and the Global War on Democracy and Public Health*, in which he accused Dr. Fauci and Bill Gates of purposefully exaggerating the COVID-19 pandemic to promote expensive vaccines for profit. In January 2022, Kennedy received backlash for comparing COVID-19 policies in the US to Hitler's Nazi Germany. Several of Kennedy's social media accounts were suspended after he posted information critical of COVID-19 vaccines.

In 2013, a personal journal detailing Kennedy's extramarital affairs and his opinions of various celebrities and political leaders was leaked to a news outlet. In his autobiography, *American Values: Lessons I Learned from My Family*, Kennedy writes about his struggle as a "functional" drug and alcohol addict following the death of his father and subsequent path to sobriety. Media outlets, and Kennedy himself, have commented on how his past and political opinions may diminish his chances of securing the Democratic nomination.

Kennedy's family history, perceived controversial stance on vaccines, and his status as a challenger to President Biden for the Democratic presidential nomination elevates his risk for adverse attention.



# **PUBLIC INTEREST INDICATOR**

Google data for Kennedy serves as a measure of public interest. Public interest fluctuates in accordance with media coverage. The graph below depicts searches for "Robert Kennedy Jr" in Google.

Most recent polls show Kennedy has around 16-19% support among Democratic voters.



- Public interest volume spiked in **early April 2023** after Kennedy filed paperwork with the Federal Election Commission, declaring his candidacy for the 2024 presidential race as a Democrat.
- Public interest volume was highest in mid-April 2023 after Kennedy officially launched his presidential campaign.
- Public interest volume increased in early May 2023 after Kennedy participated in interviews where
  he claimed the CIA was involved in the assassination of his uncle, John F. Kennedy.

Robert Francis Kennedy Jr. was born on January 17, 1954, in Washington, DC, as the third of 11 children to US Senator and Attorney General Robert Francis Kennedy and Ethel Kennedy. Kennedy was nine years old when his uncle, President John F. Kennedy, was assassinated and 14 years old when his father was assassinated while running for the Democratic presidential nomination in 1968. Throughout his teen years into adulthood, Kennedy struggled with drug and alcohol addiction which resulted in several school expulsions and a felony drug arrest. Kennedy graduated from Harvard University in 1976 with a degree in American history and literature. He went on to receive his Juris Doctorate from the University of Virginia School of Law and a master's degree in environmental law from Pace University.

In 1982, Kennedy began his career as an assistant district attorney in New York City. He went on to join two nonprofits, Riverkeeper and the Natural Resources Defense Council, where he litigated and supervised environmental enforcement lawsuits. He became an adjunct professor of environmental law at Pace University in 1986, where he served for three decades. He later founded the school's Environmental Litigation Clinic, where he was a supervising attorney and co-director until 2017. Kennedy founded the non-profit environmental group Waterkeeper Alliance in 1999 and served as the president of its board. In 2000, Kennedy and environmental lawyer Kevin Madonna founded the environmental law firm Kennedy & Madonna, LLP, to represent private plaintiffs against polluters. In 2016, he joined the Morgan & Morgan, known for its personal injury and class actions suits.

Kennedy has been a vocal advocate for safe vaccines. In 2016, Kennedy founded the Children's Health

Defense advocacy group, formally known as the World Mercury Project. The group has advocated against the use of mercury in vaccines, pesticides, fluoridation of drinking water, and aluminum due to their alleged harmful effects on the health of children.

Kennedy was a staunch opponent to COVID-19 vaccines throughout the pandemic. In November 2021, Kennedy published a book titled *The Real Anthony Fauci: Bill Gates, Big Pharma, and the Global War on Democracy and Public Health,* in which he alleged Dr. Anthony Fauci and Bill Gates were purposefully exaggerating the pandemic and promoting expensive vaccinations for the benefit of "a powerful vaccine cartel."

Kennedy has seven children and three grandchildren. Kennedy married Emily Ruth Black in 1982. The couple had two children, Robert Francis "Bobby" Kennedy III and Kathleen Alexandria "Kick" Kennedy. Kennedy and Black separated in 1992 and divorced in 1994. In April 1992, Kennedy married Mary Kathleen Richardson and had four children: Conor Richard Kennedy, Kyra LeMoyne Kennedy, William Finbar "Finn" Kennedy, and Aidan Caohman Vieques Kennedy. Kennedy filed for divorce in 2010. Kennedy married his third wife, actress Cheryl Hines, in August 2014. Cheryl Hines has one daughter from a previous marriage, Catherine Young.

Kennedy has a neurological condition, spasmodic dysphonia, which affects his speech. Kennedy and his wife have residences in Los Angeles, CA, and Cape Cod, MA.



The Secretary of Homeland Security has the statutory responsibility to determine, after consultation with an Advisory Committee, which candidates in the upcoming 2024 Presidential campaign will receive Secret Service protection. In the event of an early start to the campaign season, the Advisory Committee should be formed and the guidelines for granting protection should be reviewed (updated, if desired) and adopted, as soon as possible.

As you are aware, the Secret Service has already begun to prepare for the 2024 Presidential Campaign. Legislation providing Secret Service protection for major Presidential and Vice-Presidential candidates was passed by Congress on June 6, 1968, immediately following the assassination of Senator Robert F. Kennedy. The legislation is codified in Title 18, United States Code, Section 3056 (a)(7). The statute authorizes the Secret Service, under the direction of the Secretary of Homeland Security, to protect "major Presidential and Vice Presidential candidates" who are defined as "those individuals identified as such by the Secretary of Homeland Security after consultation with an advisory committee consisting of the Speaker of the House of Representatives, the minority leader of the House of Representatives, the majority and minority leaders of the Senate, and one additional member selected by the other members of the committee."

The committee must select the additional member, establish its procedures, and adopt guidelines for approving requests for protection. I am enclosing a copy of the Advisory Committee Guidelines for Secret Service Protection to Presidential Candidates from 2017. Over the years these guidelines have been updated to ensure that they provide an appropriate benchmark for the Advisory Committee in evaluating requests for Secret Service protection. The guidelines were last adjusted in January 2017, following the 2016 campaign.

The guidelines also provide a basis for defending your decision to deny a request for Secret

Service protection as not being arbitrary or capricious.







Mr. Kennedy, a long-shot Democratic presidential candidate with surprisingly high polling numbers, said he wanted to close the Mexican border and attributed the rise of mass shootings to pharmaceutical drugs.

Robert F. Kennedy Jr., a scion of one of the country's most famous Democratic families, on Monday dived into the full embrace of a host of conservative figures who eagerly promoted his long-shot primary challenge to President Biden.

For more than two hours, Mr. Kennedy participated in an online audio chat on Twitter with the platform's increasingly rightward-leaning chief executive, Elon Musk. They engaged in a friendly back-and-forth with the likes of Tulsi Gabbard, the former Democratic congresswoman turned right-wing commentator; a top donor to Gov. Ron DeSantis of Florida; and a professional surfer who became a prominent voice casting doubt on coronavirus vaccines.

Mr. Kennedy, who announced his 2024 presidential campaign in April, is himself a leading vaccine skeptic, and has promoted other conspiracy theories. Yet he has consistently hovered around 20 percent in polling of the Democratic primary, which the party has otherwise ceded to Mr. Biden.

On Monday, he sounded like a candidate far more at ease in the mushrooming Republican presidential contest.

He said he planned to travel to the Mexican border this week to "try to formulate policies that will seal the border permanently," called for the federal government to consider the war in Ukraine from the perspective of Russians and said pharmaceutical drugs were responsible for the rise of mass shootings in America.

"Prior to the introduction of Prozac, we had almost none of these events in our country and we've never seen them in human history, where people walk into a schoolroom of children or strangers and start shooting people," said Mr. Kennedy, who noted that both his father and uncle were killed by guns.

Mr. Kennedy said he now had "about 50 people" working for his campaign. Unlike Marianne Williamson, the other announced Democratic challenger to Mr. Biden, he does not appear to be aiming to appeal to Democrats who are ideologically opposed to the moderate president or are otherwise uneasy with renominating him. Instead, he has used his campaign platform - and his famous name - to promote misinformation and ideas that have little traction in his party.

Asked during the discussion by David Sacks, a top DeSantis donor who is also close to Mr. Musk, "what happened to the Democratic Party," Mr. Kennedy spent nine uninterrupted minutes attacking Mr. Biden as a warmonger and claimed that their party was under the control of the pharmaceutical industry.

"I think the Democratic Party became the party of war," Mr. Kennedy said. "I attribute that directly to President Biden." He added, "He has always been in favor of very bellicose, pugnacious and aggressive foreign policy, and he believes that violence is a legitimate political tool for achieving America's objectives abroad."

The Democratic National Committee and Mr. Biden's campaign declined to comment about Mr. Kennedy.

The event, which at its peak had more than 60,000 listeners, according to Twitter, at times felt as if Mr. Kennedy were interviewing Mr. Musk about his stewardship of Twitter, a platform that has lost more than half of its advertising revenue since the billionaire acquired it in October. For more than 30 minutes at the event's start, the presidential candidate interrogated the tech mogul about releasing the socalled Twitter files, self-driving cars and artificial intelligence.

"These are really interesting topics for people, but I think a lot of the public would like to hear about your presidential run," Mr. Musk said to Mr. Kennedy.

Mr. Kennedy, 69, is a longtime amplifier and propagator of baseless theories, beginning nearly two decades ago with his skepticism about the result of the 2004 presidential election as well as common childhood vaccines. His audience for such misinformation ballooned during the coronavirus pandemic

On Monday, Mr. Kennedy repeated a host of false statements, among them:

- He said that after the Affordable Care Act of 2010, "Democrats were getting more money from pharma than Republicans." An analysis by STAT News found that political action committees with ties to pharmaceutical companies gave more money to Republicans than Democrats in 14 out of 16 election years since 1990.
- He claimed, without evidence, that "Covid was clearly a bioweapons problem." American intelligence agencies do not believe there is any
  evidence indicating that is the case.
- And as he blamed psychiatric drug use for the rise of gun violence in the United States, he contended that the gun ownership rate in the U.S. was similar to that of Switzerland. The United States had the highest civilian gun ownership rate in the world, at an estimated 120.5 firearms per 100 people, according the latest international Small Arms Survey. That was more than double the rate of the second-highest country, Yemen at 52.8, and much higher than Switzerland's 27.6.


