This responds to your Freedom of Information Act (FOIA) request dated December 20, 2020, and received in this Office on December 21, 2020, in which you requested a printout of the YouTube creator's page for the Office of Information Policy (OIP).

Please be advised, the Office for Information Policy (OIP) does not maintain an official YouTube account. Instead, OIP works with the Office of Public Affairs to post video content to the Department of Justice's flagship YouTube account, www.YouTube.com/TheJusticeDepartment. To be of assistance, a search has been conducted in the Office of Public Affairs, and eighteen pages were located that are responsive to your request. I have determined that this material is appropriate for release with certain information withheld pursuant to Exemption 5 of the FOIA, 5 U.S.C. § 552(b)(5) which pertains to certain inter- and intra-agency communications protected by the deliberative process privilege. Copies enclosed.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. See 5 U.S.C. § 552(c) (2018). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.

If you submit your appeal by mail, both the letter and the envelope should be clearly marked "Freedom of Information Act Appeal."
